The BC All Breed Pointer Club will conduct an approved CKC & AFTCA Sanctioned Walking Field Trial for all pointing breeds at Jura Stock Ranch, Princeton, BC on April 20 – 21, 2024. This trial is held under the rules of the Canadian Kennel Club, 5397 Eglinton Avenue, W, Suite 101, Etobicoke, ON M9C 5K6 and the rules of AFTCA.

**VOLUNTEER REQUIREMENT:** *Volunteers are essential to run a Field Trial! New volunteers will be shown the ropes and there will be a sign up sheet when entering. Please head to the saloon when you arrive to confirm your volunteer position.*

**RUNNING ORDER:** We will be posting and updating the Running Order on a white board, but it is the handler's responsibility to be aware of the timing of the Running Order and to be on time at the line. If your dog is not on the line within the specified 5-minute grace period, you will be disqualified from the stake. Please check in with the Trial Secretary before the trial starts each day.

**RUNNING & HANDLING:** All handlers to be on foot for all stakes. Judges will be on foot or ATV.

**STARTER PISTOL:** A starter pistol is available to borrow from the Secretary's desk – donation of \$5 Per Run. Must be returned promptly after your run! Please bring cash and driver's license.

**SITE RULES:** BCABPC is grateful to the JURA Family for the use of these grounds! Please respect and abide by all good neighbour rules and clean up all garbage before leaving. Drive with caution (dead SLOW!) as you approach the event site to ensure the safety of all participants (dogs and humans!). **No smoking or open flames permitted outside your vehicle.**

As this is private land, please clean your boots and brush mud off your vehicle before entering the grounds to avoid bringing invasive plant seeds onto the property and clean your boots before leaving to avoid carrying invasive plants seed back home.

**PRIZES:** Standard CKC rosettes will be awarded to placing dogs in all stakes.

\* **TC fee:** An additional fee of **\$10.50** as established by the CKC must accompany the entry of a dog for which a CKC Registration Number, Event Registration Number (ERN), Performance Event Number (PEN) or Miscellaneous Certification Number (MCN) is not shown on the entry form. **CANADIAN-RESIDENT ENTRANTS WHO ARE NOT CKC MEMBERS:** Effective January 1, 2011, the Canadian Kennel Club has implemented an annual non-CKC-member participation fee. Canadian-resident owners who are not members of the CKC must pay this annual participation fee or join the CKC. Failure to do so will result in cancellation of awards and titles. For co-owned dogs, one of the owners must supply a CKC membership number or pay the fee/join CKC. The above applies only to Canadian residents; American-owned dogs are exempt. The test secretary will have some of the forms available at the test; it is the entrants' responsibility to submit the form and fee to CKC.

**BORDER CROSSING:** A valid rabies certificate is required to bring a dog into Canada from the USA. Government regulations require a valid Rabies Certificate dated at least 30 days prior to entry into Canada.

## GENERAL INFORMATION:

- All participants must check in with the Trial Secretary before the start of each day's events.
- This event is a walking trial.
- The BCABPC wishes to remind all participants and spectators that there will be **no exercising or training of any dogs** on the grounds before, during or after the trial without the permission of the Field Trial Chair or Field Trial Secretary.
- The BCABPC reserves the right to **limit entries** to the available daylight hours and, if necessary, to rearrange the running order.
- "Post Entries" may be accepted on the day of the Trial, with an additional fee of \$20. Entries will be accepted only if we have birds available and daylight hours left to allow for the addition to a Stake.
- The duty of having a dog ready in place when required for judging rests solely with its handler or owner. If a dog is not present at the place where it is to start within 5 minutes after it is called for by the judges to run, it must be disqualified. The judges are responsible for keeping the time.
- Blank pistols only will be fired over all dogs with bird work in senior and derby stakes. Blank pistols may be fired over puppies if both handlers agree. No live ammunition will be allowed in any stake. Pistols must have solid barrels.
- No dog shall be picked up during a trial except with permission from the judge.
- All participants must be familiar with the CKC Rules and also the rules and provisions of this Premium List. CKC Field Trial Rulebooks are available from the CKC or online at the CKC website:

- The senior and derby stakes will be **30 minutes in length**. The puppy stake will be at least **20 minutes**. The Club reserves the right to rearrange the running order of the junior stakes should conditions warrant.
- With the permission of the judge, collaring a dog away after game contact will be allowed.
- Backing tests: If a dog has placed in one of the senior stakes of the trial and needs only a backing test to complete the requirements for a Championship, the owner may request a backing test. This test will be allowed at the discretion of the Field Trial Chairman and will depend on availability of birds. The test will cost \$20.00
- **Bitches in season may run at the end of the day.** Entrants with a bitch in season must notify the Trial Secretary prior to the start of the Trial they are entered in, that their bitch is in season.
- Tracking Collars: Approved electronic collars that are designed for *tracking only* may be used. Any questions regarding their use should be referred to the Field Trial Chair. Collars must be approved by the judges before a dog commences running a test.
- Gallery (audience) viewing is at the discretion of the judge. The gallery must remain quiet and 50 feet behind the Judges and Handlers. The gallery must not interfere with the Judges and Handlers.
- The BCABPC is committed to providing an environment free of discrimination and harassment, where all individuals are treated with respect. Members and event participants are expected to be respectful at all times. Harassment, discrimination, physical and verbal assault by anyone will not be tolerated, condoned, or ignored within our membership or at any event sponsored or hosted by the BCABPC. Any such claims will be reviewed by the Board. If a claim of harassment or discrimination is determined, disciplinary measures will be applied, up to and including termination of membership, or suspension from participation in future events for a length of time as determined by the Board.

**CKC, Chapter 16:** It shall be the duty and obligation of the trial-giving club to see that a judge is not subject to indignities. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

**LIABILITY:** All entries for this Field Trial are accepted on condition that the BCABPC, its officials and members, land and horse owners, are released from all liabilities for loss, damage or injury sustained by dog, horse or person in conjunction with, or during the running of, this Field Trial. All minors shall be under the direct care and supervision of the parent or guardian.

**CONCESSION:** There will be a small cash only concession available for items to purchase while at the event.

**ACCOMMODATIONS:** Self-contained units or tents are permitted on the site for **dry camping**. There are **no hook-ups** and **no potable water**. Bring your own generator if power required. Bring sufficient water for yourself and your dogs. Port-a-potties are on-site. Pack out all your garbage and leave no trace! There will be space for campers at the site.

**DIRECTIONS TO JURA STOCK RANCH, Princeton/Summerland Road, Princeton, BC**

Take Highway #3 into Princeton (from either east or west) and turn towards town onto Bridge Street (Petro-Canada station on the corner). Immediately turn right onto Highway #5A. Take Highway #5A over the steel bridge and just around the curve up the hill, turn right on Old Hedley Road.

If coming across the US border in western Washington, take the Sumas/Huntington crossing. This crossing will take you directly to Highway #1 eastbound. Once you get to Hope (about 1 to 1 ½ hours) you will see the sign for Highway #3 which goes off to the right.

If crossing in eastern Washington take the Oroville/Osoyoos crossing and proceed north on Highway #97 until you reach Highway #3 and turn west (left).

If you are coming into Princeton from Highway #5A north (Merritt, etc.) stay on it until there is a turn to the left just as you come over the hill into town (a marker is the road sign warning of a change to speed of 70 km/hr.). Turn left onto Old Hedley Road.

From Old Hedley Road, quite quickly you will turn left onto the Princeton/Summerland Road (also known as Osprey Lake Road). Drive past the fair grounds and stay on that same road for approximately 7 km. You will pass Belfort Road on your left and then the road bends to the right. You will see a sign on your right for Jura Stock Ranch/Maverick Saloon. Turn right into the driveway and you are there!
