*\*Listed Dogs Dogs without an individual CKC registration number must obtain a Temporary Competition Number (TCN). The TCN allows a dog that is eligible for CKC registration or an Event Registration Number (ERN), to participate in CKC events. Temporary Competition Numbers must be obtained before the closing date of entries. Once the dog is permanently registered or has an ERN, the TCN will no longer be valid. While there is no fee for the Temporary Competition Number, exhibitors will still be required to pay listing fees when entering events.*

## Food

Due to public health measures associated with COVID-19, no food will be sold on site. Please bring your own food and drinks.

## Equipment

The table, teeter, dog walk, and A-Frame are rubberized. (Dogwalk and teeter are Galican Intercan models). Tire is Galican 24" breakaway tire (not self-healing). 24" weave poles will be used. Timing is manual.

## Eligibility

To be eligible to compete in these trials a dog must be 18 months of age or older and have a CKC Registration number, CCN, MRN, MCN, PEN or a TCN. Bitches in Season are not allowed to compete and will be refunded their entry and listing fees provided a veterinarian's note stating that the female was in season within 10 days before the start of the trial and is submitted to the Trial Secretary on or before the day of the trial.

As of January 1, 2020 as per CKC regulations, if a dog is injured after entry has been submitted to the Trial Secretary, a Veterinarian's certificate, certifying the dog was injured before a 3-day period preceding the trial, must reach the Trial Secretary on or before the start of the trial. The club will refund the entry minus the TCN fee and a \$10 administration fee.

## Non-Member Participating Fee

An annual non-member participation fee will apply to any exhibitor who is a Canadian resident and a non-member of the CKC earning awards/titles. In order to protect awards/titles earned, the non-member will have to pay the CKC fee for each dog being tracked by the CKC or become a CKC member within 30 days of notification. Failure to comply will result in loss of awards/titles.

## Foreign Exhibitors

Please note that fees are due and payable in Canadian dollars.

**General Information**

- **Entries must include correct fees and signed liability agreement to be valid.**
- Senior handlers (65+) or handlers with a disability may request a modified course time or point requirement as of Jan. 1, 2020. Please ensure you check the box on the entry form to qualify for this if you wish.
- **Volunteering is required, please indicate your preferences on the entry form.**
- Judging schedule and covid protocols will be emailed after the closing date.
- No provision for inclement weather.
- No obstacle familiarization shall be provided. Handlers in all classes are permitted to walk the course, without a dog, prior to the start of each class.
- **New CKC rule: Dogs can run in For Fun Only (FFO) class in any category. Toys are allowed but the toy must be identified to the judge prior to entering the ring. A maximum course time of 60 seconds is allotted, and course direction must be followed.**
- Flat carded ribbons will be awarded for 1<sup>st</sup> through 4<sup>th</sup> placements. Rosettes will be awarded for Qualifying runs and Titles.
- Whistles, clickers, audible toys, flexis and prong collars are NOT permitted on the trial precinct. Treats & toys not permitted in the ring, excepting toys approved by judge for FFO class only.
- Food cannot be within 10 ft of ring.
- **Please pick up after your dogs or risk excusal from the grounds without refund.**
- **NO SMOKING** on any of the property at 97 LeDrew's Road, except inside personal vehicle.

*“It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.”*
