Judges are not required to wait for dogs. The Handler of each dog is solely responsible for having it ready at the ring area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of locating dogs that are not brought into the ring when required.

General Information for Exhibitors

In order to make everyone's visit a safe and enjoyable one, The Poodle Farm has a few rules:

1. No outdoor shoes allowed on the turf indoors.

Please ensure you bring a clean, dry pair of indoor only shoes.

- 2. Please do not arrive before 8 am.
- 3. Indoor crating is not available. There is a warm up area inside, however you should be prepared to crate from your vehicle.
- 4. Dogs must be on a leash at all times except when competing in the ring. No "Flexi" lines allowed on the property.
- 5. There is a facility fee of \$40.00 for any occurrence where a dog eliminates on the turf. Fee is the responsibility of the Handler.
- 6. Please keep your dog under control and out of other dogs 'faces', give other dogs the room they may require.
- 7. Please pick up after your dog's waste. Please pick up after yourself. There are waste containers for your trash.
- 8. Please do your best to keep barking to a minimum.
- 9. No smoking, vaping or Cannabis anywhere on the property.
- 10. Per CKC rules, only dogs officially entered are permitted within the Trial Precincts.
- Per CKC rule 6.7.3 "There shall be no intensive or abusive training of dogs within the venue of the trial." The "venue" being the entirety of The Poodle Farm property.
- 12. Rally course maps will be posted outside, paper copies will be available only by request.
- 13. Outdoor shade/rain tents may be setup on any grassy area in the event of inclement weather.
