USA Exhibitors

Bank drafts or money orders in Canadian Funds and personal cheques, payable in U.S. funds, and for the full amount of the entry will be accepted. Personally discounted cheques will not be honoured. Please do not mark personal cheques "Payable in Canadian Funds" or "At Par" as such items are not cleared through the banks. Your cooperation is appreciated.

Catalogues

Catalogues are available on a PRE-ORDER basis. Those who wish to preorder at a price of \$5.00 (including HST) may do so by indicating this on their entry form. Your catalogue will be waiting for you at the show.

Entry Information

- 1. No entry will be accepted unless all particulars called for on the entry form are completed in full.
- Incomplete entries will be returned. No entry will be accepted unless accompanied by entry fees. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made
- 4. There is no refund for duplicate cheques. Every effort will be made to find all duplicate entries.
- 5. Only dogs that are already registered in the Canadian Kennel Club Stud Book, or are eligible for such registration can be entered. The committee reserves the right to refuse any entry subject to CKC Rules.
- 6. ENTRIES POSITIVELY CLOSE WEDNESDAY, JUNE 1, 2022, AT 8 P.M., OR WHEN THE ENTRY LIMIT IS REACHED, WHICHEVER OCCURS FIRST.
- 7. Identification cards and judging schedules will be mailed as soon as possible after the entries close. Identification cards must be presented upon arrival at the trial.
- 8. Tendering of NSF cheques in payment of fees shall be considered non-payment of fees and is punishable by disciplinary action. **Any NSF cheques will be subject to a \$25 service charge.**

General Information

- 1. The Trial Superintendent will be in full charge of the show which will be governed by CKC Rules.
- 2. The Southwestern Ontario Sporting Dog Club Inc. will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
- 3. If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the show, no refund of Entry will be made.
- 4. The trial precincts shall consist of the inside the Goldunn Training Centre and area immediately in front of the building. *The trials will be held outdoors.*

Bitches in Season

Bitches in season are not permitted to compete. When a bitch comes into season after entries close, a Veterinarian's Certificate, certifying that the bitch was in season within ten (10) days of the trial, must reach the Trial Secretary on or before the day of the trial, prior to the judging of the class, and the club will refund the entry fees.

Temporary Competition Number (TCN)

A Temporary Competition Number (TCN) allows dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN). A TCN must be obtained before submitting an entry for an event. The same TCN must be used for all event entries for a dog until the dog is permanently registered or has an ERN.

A TCN cannot be used for dogs that require a Miscellaneous Certificate Number (MCN), a PEN or a CCN number.

Note: There is no CKC fee to obtain a TCN. However, a TCN 'listing' fee is required each time a dog with only a TCN is entered in an event.

Event Registration Number (ERN)

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events, and do not have a CKC registration number, will require an Event Registration Number (ERN).

The ERN number MUST be applied for within 30 days of the first day of entering a CKC event.

Performance Event Number (PEN)

A Performance Event Number (PEN) allows a non-registrable dog of a **CKC-RECOGNIZED BREED** to participate in competitive events that are appropriate for the breed. To be eligible to receive a PEN, all of the following must be met:

- The dog must be of a breed recognized by the CKC (not on the CKC Miscellaneous Class List).
- The dog must not be eligible for CKC registration.
- The dog must be spayed or neutered.
- The dog must be properly identified with a CKC-approved microchip.

A dog that is eligible for a PEN may not be entered as a 'listed' dog.

Canine Companion Number (CCN)

Mixed Breeds & Unrecognized Breeds A Canine Companion Number (CCN) allows **MIXED-BREED DOGS** and **UNRECOGNIZED BREEDS** to compete in CKC performance events. To be eligible to receive a CCN, all the following must be met:

- The dog must be either a Mixed Breed or an Unrecognized Breed.
- Mixed Breed dogs must be spayed or neutered.
- Unrecognized Breeds are not required to be spayed or neutered.
- The dog must be properly identified with a CKC microchip.

A dog that is eligible for a CCN may not be entered as a 'listed' dog.

All the above 'registration' numbers can be obtained:

- Online through CKC's Portal (Note: Individuals who have not yet used the online Portal will be required to create a Portal account before they can submit an application online); or
- By submitting a completed paper application by mail to CKC.

In consideration of the acceptance of this entry I (we) agree to be bound by the rules and regulations of the Canadian Kennel Club and by any additional rules and regulations appearing in the premium list. Also by signing this form, I certify that I will not hold the Show giving Club, its members, directors, employees or agents liable in the event of any accident of misfortune however caused.

Limited Entry

OBEDIENCE: Entry in each obedience trial will be limited to the capacity of the judge to judge at the rate of 9 Pre-Novice, 8 Novice and Novice Intermediate, 7 Open, and 6 Utility dogs per hour. A judge may not be assigned more than 7 hours of judging.

RALLY: Entry in each rally obedience trial will be limited to the capacity of the judge to judge at the rate of 10 dogs per hour less time for walkthroughs. A judge may not be assigned more than 7 hours of judging.

Once a judge has reached his/her capacity, entries for that trial will be closed even if the closing date has not been reached. In the case of the entry limit having been reached, remaining entries will be assigned a position (by class) on a reserve list. Exhibitors will be notified of their position on the reserve list. If the entry of a bitch in season is pulled after entries are closed, it may be substituted with one from the reserve list up to and including the day of the trial. If the entry of another dog is pulled prior to the trial, it may be substituted with one from the reserve list up to 24 hours prior to the trial.

Non-Member Participation Fee

Effective January 1, 2011:

- a) A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The fee will be \$170.00 plus applicable taxes.
- b) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- c) In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the NMPF. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- d) The fee applies to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

BEFORE YOU ENTER A RALLY "A" CLASS!

If the dog you are entering has earned any CKC obedience title other than a PCD (e.g., CD, CDX, OTCH), the dog CANNOT be entered in any Rally "A" class. Handlers who have exhibited any dog to a CKC CDX title CANNOT enter the "A" classes.

Entering the wrong class will result in the cancellation of legs and titles.

Obedience Trial Rules & Regulations

The Exhibitor is responsible for knowing and complying with the Obedience Rules and Regulations of the Canadian Kennel Club.

Section 19.7 of the Obedience Rules and Regulations states: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial held under these regulations, is not subject to indignities of any kind. The Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Master Obedience Trial Champion (MOTCH)

Section 14.3.1 The CKC will permit the use of the letters MOTCH to be used as a prefix of the name of any dog that has met the requirements for that title as hereinafter provided.

Section 14.3.2 Points for this title may only be accumulated after the completion of the OTCH title.

Section 14.3.3 Points may be accumulated simultaneously with credits toward both the OTCHX and MOTCH titles. However, the MOTCH title will not be awarded until completion of the OTCHX title.

Section 14.3.4 One High in Class placement is required in either of the Open B classes or the Utility B class but no minimum score is required.

Section 14.3.5 A dog must acquire a total of 40 points to earn a MOTCH title. A minimum of 15 points must be obtained from either of the Open B classes and the Utility B class. The remaining 10 points can be obtained from either class.

Rally Obedience Trial Rules & Regulations

The Exhibitor is responsible for knowing and complying with the Rally Obedience Rules and Regulations of the Canadian Kennel Club.

Section 17.7 of the Rally Obedience Rules and Regulations states: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at a rally Obedience Trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Rally Champion (RCH)

Section 16.1 The CKC will permit the use of the letters RCH to be used as a prefix of the name of any dog that has met the requirements for that title as hereinafter provided.

Section 16.2 A dog may begin earning points toward the RCH title as soon as the Rally Master (RM) title requirements have been completed.

Section 16.3 The RCH title will be awarded to dogs that have successfully earned a minimum of 100 points total from competing in both the Excellent B and Master classes in the same trial.

- (a) 50 points must come from the Rally Excellent B class, including a minimum of five (5) scores of 95 or higher.
- (b) 50 points must come from the Rally Master class, including a minimum of five (5) scores of 95 or higher.

Section 16.4 A qualifying score must be earned in both the Excellent B class and the Master class in the same trial on five (5) different occasions under at least five (5) different judges

- Exhibitors will remove and retrieve their own leashes. A chair or other object will be placed in the ring for the leash.

Refund Policy:

- If the South Western Ontario Sporting Dog Club is required to cancel the show due to any federal, provincial, municipality or Canadian Kennel Club guidelines, policies, or directives, a full refund of all entry fees (less expenses) will be offered.

Trial Site

GOLDUNN TRAINING CENTRE

760 Gillard Street, Wallaceburg, ON N8A 4Z5

Gillard Street runs north and south and the driveway is next to the last building to the south on west side. It is indicated by a Goldunn sign and number. Proceed on this driveway turning left and following it to the building.

It is also easy to find from a driveway on the north side of the Baseline Rd., at the east side of the Baseline Bridge, do not go over the bridge. When you proceed on this drive way you will notice a brick building identified by the "Goldunn Training Centre Sign". Take this drive way to the end turn left and proceed to the brick building on your right.

FROM CHATHAM ON 40 HIGHWAY:

The first light you arrive at is the Baseline Road. Turn left on the Baseline Road passing Gillard Street on your right. Take the second driveway on your right just before the approach to the Baseline Bridge. Follow this driveway to the first red brick building on the right.

FROM DRESDEN:

Proceed west on the Baseline Road through the traffic light at Murray Street. Take the second driveway on your right just before the approach to the Baseline Bridge. Follow this driveway to the first red brick building on the right.

FROM SARNIA, FROM THE KIMBALL ROAD:

Turn right at the end of Kimball Road entering Wallaceburg on Margaret Ave. At the first traffic light turn left, going over the Murray Street Bridge. Proceed south on Murray Street to the second traffic light and turn right at the Baseline Road. Take the second driveway on your right just before the approach to the Baseline Bridge. Follow this driveway to the first red brick building on the right.

FROM SARNIA BY WAY OF THE NEW 40 HIGHWAY:

Turn left at the end of 40 Highway on to Dufferin Avenue, to Wallaceburg. Proceed east of Dufferin Avenue, to the second traffic light at Arnold Street turn right. Proceed to the end of Arnold Street turning left on to Mason Street. At the end of Mason Street turn right on Old Glass Road. At the next intersection which is the Baseline Road turn left. Go over the Baseline Bridge and just at the foot of the Baseline Bridge take the first driveway to your left. Follow this driveway to the brick building on the right which is the new Goldunn Training Centre.
