- Exhibitors or handlers are solely responsible for having their dogs at ringside when classes are called. It is not the responsibility of the Ring Steward to locate dogs. Absentees should be reported to the Ring Steward. Judges will not wait for any dogs not present when called. Judging will not be delayed by waiting for an exhibitor or handler in another ring – please arrange to have alternate handlers available. Your cooperation is appreciated.
- The Show & Trial Superintendent will be in full charge of shows, which will be governed by CKC rules.
- All exhibitors will be held responsible for clean up on the show grounds and surrounding areas for their own dogs or dogs they are handling and must use the designated areas.
- Children are welcome and must be accompanied by adults at all times. Please do not allow them to run amongst the dogs or set up areas or disturb or touch dogs without permission of owner/handler.

**DIRECTIONS TO SHOW SITE FROM CONFEDERATION BRIDGE**

Follow Trans-Canada Hwy/PE-1 W toward Charlottetown to Malpeque Rd/Veteran's Memorial Hwy/All Weather Hwy/PE-2 W in Charlottetown  
Turn left onto Malpeque Rd/Veteran's Memorial Hwy/All Weather Hwy/PE-2 W (signs for Kensington)  
Turn right onto Sherwood Rd  
At the roundabout, take the 3rd exit onto Brackley Point Rd/PE-15  
Drive to #693 Brackley Point Rd
