CKC Non-Member Participation Fee

The non-member participation fee applies to dogs wholly owned by a resident of Canada who is not a member of the CKC. It is not applicable to CKC members or dogs co-owned with a CKC member. For the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog can not be moved up to the next level. For membership application, please go to www.ckc.ca under CKC services and forms online.

GENERAL INFORMATION FOR ALL ATTENDING THE SHOWS This is a Show & Go – All current Covid 19 Guidelines will be followed

- No public or spectators permitted
- MASKS must be worn at all times
- Arrive with your Covid 19 WAIVER and you receive your wristband
- Wristbands must be worn at all times at the show venue
- Please try to know your ARMBAND NUMBER it will be on your confirmation email
- Please arrive 45 to 60 minutes before your scheduled ring time
- Report to the Staging Area
- If possible, please try to complete washroom stop before arrival
- Putting an exercise pen beside your car upon arrival is permitted but you must minimize your time
- Before arriving, please check your schedule for time and ring number
- 15 minutes prior to ring time you will advance to the ready ring area
- Upon arrival you may enter the ring area
- No personal grooming tables, or exercise pens permitted in the ring area
- No putting dogs on club ring tables or the ramp
- You must leave the ring area immediately following judging
- There shall be no lingering or gathering
- Dogs must exercise in pens only
- Anyone allowing a dog to lift its leg on the property or not picking up will be uninvited to future events
- People dropping dogs off to handlers may do so by prearranging a meeting time and location with their handler. You must leave immediately after dropping your dog. You can wait in the staging area until picking up your dog.
- Anyone arguing with an attendant or act of defiance will be asked to leave the venue immediately
- We will not tolerate bullying or unsportsmanlike behavior

IF THERE ARE CHANGES IN THE PROVINCAL COVID 19 GUIDELINES THEY WILL BE REFELECTED IN THE JUDGING SCHEDULE

CHAMPIONS AND CHAMPIONSHIP POINTS

<u>SECTION 1</u> – A dog awarded *Winners* at a championship show held under the Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5) and the determination of the number of championship points to be accredited to a dog awarded Winners shall be provided hereunder.

<u>SECTION 2</u> – The schedule to be employed in the determination of the number of points to be allocated to a dog awarded. *Winners* shall be as follows.

DOGS COMPETING	1	2	3-5	6-9	10-12	13 or more
Points Allocated	0	1	2	3	4	5

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge **shall not** be included in the calculation for championship points. The new system provides for additional points if a dog awarded *Winners* also places in the **GROUP** as listed below.

A class dog awarded **Best in Show** at an all-breed championship show will be credited with five (5) points inclusive of any points earned at the breed or group level. In **no** case may a dog earn more than **five (5)** points at a **single show**.

In order for a dog to be recognized as a Champion and its owner provided with a Championship Certificate, the dog must: (a) earn at least 10 championship points under at least 3 different judges; and, (b) be individually registered in the records of the CKC or have an Event Registration Number. (c) have earned at least one 2 point win either at the breed or group level. (15.1.13).

<u>Best Puppy in Breed</u> – Where a dog awarded Best of Breed is not a puppy, those puppies which have not been defeated either directly or indirectly by another puppy in the breed will compete for this award. Judging follows the award for Best of Breed. A puppy awarded Best Puppy in Breed, is <u>NOT</u> required to stay to compete for Best Puppy in Group (15.3.1f)

MOVING CLASS DOGS TO SPECIALS

A dog which is individually registered in the records of the CKC or has an ERN number at the time of closing of entries, and has completed the requirements for a championship in accordance with the provisions of **Chapter 20** of the **Dog Show Rules**, after the closing date and time for entries for a show, but whose championship is yet unconfirmed by the CKC may be transferred from one of the regular classes to "Specials Only" providing the transfer is submitted to the show secretary in writing **at least one** (1) hour prior to the opening of the show, by the owner or handler.

Effective January, 1994: If your dog has the required number of Championship points and you do not have your registration number before entries close, and you receive your registration **BEFORE** the date of the show, you may move your dog up to Specials if you provide the Show Secretary with the registration number and the dog has been entered in the classes as a **LISTED** dog. Listing fees, however, **WILL NOT be refunded.**

An error in the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show. Rule (8.2.5)

EXHIBITORS ARE EXPECTED TO KNOW THE RULES AND REGULATIONS FOR DOG SHOWS AND OBEDIENCE TRIALS. BOOKLETS ON DOG SHOW AND OBEDIENCE TRIAL RULES ARE AVAILABLE FROM THE C.K.C.

Covid 19 Safety Protocol for our shows If you can not comply with these rules – DO NOT Enter or Attend!

There will be a zero-tolerance policy on Covid-19 violations, including not wearing a mask or not social distancing when it is possible.

Waiver must be signed

by club members, judges, ring stewards, exhibitors, owners, handlers, breeders, assistants' volunteers.

Contact tracing information must be provided for ALL who attend (name & phone number)

Masks must be worn correctly over mouth and nose – this is mandatory

by exhibitors, judges, and ring stewards in the rings during judging. Each ring will have an entrance and exit and social distancing markers. Exhibitors will pick up the placement ribbons as they exit – there will be no recycling of ribbons so if you do not want to keep it please do not take it.

<u>Masks must be worn correctly over mouth and nose – this is mandatory</u> under the tents/pavilion, in washrooms, in any other location where 2 meters- 6 feet can not be maintained.

Social Distancing – 2 meters/6 feet this is Mandatory

in the rings, under the tents, adjacent ring areas, at the show secretary table and at the photographer's set up.
