**LISTING FEES:**

A Listing Fee of \$9.25 must accompany the entry form of a dog for which a CKC individual registration number or Event Registration Number (ERN) is not shown on the entry form.

Mail all entries and fees to the Test Secretary. All cheques or money orders should be made payable to the Nova Scotia German Shepherd Dog Club (or NSGSDC). No post dated cheques will be accepted.

CLOSING DATE: **Entries must be delivered to the Test Secretary by the closing date. The club cannot accept entries delivered after this date and time. After the closing date, the club will send out acceptance letters, advising entrants of the status of their entries.**

**DRAW for tracks: On Sunday, October 16<sup>th</sup>, 2011 at 8:30.**  
**Directions: On the 102 highway, take exit 9, Milford, exit at the parking lot of the Fruit Stand on Highway #2.**

Entries will be acknowledged by mail and accompanied by a map. When the advertised limit has been reached, all remaining entries received prior to the closing date shall be assigned a position on an "Alternate List" in the order received. Entries from the Alternate List may fill any absentee spaces up until one hour before the start of the Tracking Test. The person making the entry shall be notified of their position on the alternate list. Entries will be refunded within ten (10) days of the Tracking Test to those on the Alternate List who did not participate in the Test.

**ATTENTION USA EXHIBITOR**

If the dog is foreign born and foreign owned and enters Canada for the sole purpose of entering CKC events, it may be entered at a tracking test with an Event Registration Number (ERN). Such number must be applied for within 30 days of the test. Failure to do so will result in the cancellation of all awards and prizes
