Jim Black



Jim purchased his first pedigree dog in 1963, a Boxer, which was the beginning of a 25 year association with that breed, including importing dogs from Canada and America, in addition to a successful interest in Racing Greyhounds.

He is a Life Member and Patron of the Adelaide Hills Kennel Club.

Together with his wife Lyndall, success followed with Bearded Collies and more recently, Dachshunds (Long Haired) and Afghan Hounds.

During 2010 they successfully campaigned Grand Champion Keaton Kosciusko (Standard Long Haired Dachshund) to Number 1 Dog All Breeds in Australia (DOLPS), also earning an invitation to compete as Australia's representative at the prestigious Eukanuba World Challenge

in Paris and in March 2011 saw him crowned as Victoria's Dog of The Year at Dogs Victoria 'Night of Nights' competition.

Jim enjoys spending his time between judging, mentoring trainee judges and showing.

Jim is an ANKC licensed All Breeds Judge. His judging assignments have taken him to all Australian States, USA, The Philippines, Thailand, Japan, South Africa, Sweden and New Zealand. His Specialty assignments have taken him to Canada and New Zealand as well as The Bearded Collie Club of England 'Beardie Spectacular' Open Show. He

Prior to his retirement, Jim was a Project Manager in the Power Industry and now enjoys judging and mentoring new judges.

Lyndall Black



Lyndall's commitment to pedigree dogs began with Miniature Poodles, where she had much success in the Obedience ring both as a competitor and qualified trainer as well as in the show ring with all 3 Poodle varieties.

After being given her first Bearded Collie, they became her focus. Along with husband Jim, Lyndall imported Bearded Collies from Canada, England and New Zealand and bred/owned many Champions, All Breed Best in Show and Specialty winners.

Lyndall has judged The Bearded Collie Club of Canada National Specialty as well as The Bearded Collie Club of England 'Beardie Spectacular' Open Show.

For almost 30 years, Dachshunds (Long Haired) have been the focus of the Briarmist family. Breeding and owning many champions, Grand Champions and Supreme Champions including Australia's Number 1 Dog - All Breeds in 2010 & New Zealand's Number 1 All Breeds 2011

and in 2014/2015 an American Grand Champion and ROMO and DCA Top Standard Long Sire for 2015.

Also winning the Dogzonline Australia Show Dog of the Year Dachshund (long haired) point score in 2007, 2009 – 2015, 2019, 2022 and leading to date in 2024.

Dogs sports has also been a recent passion for Lyndall, with 2 dogs gaining their TKS titles in the last 12 months.

Lyndall is an ANKC licensed All Breeds Judge, at Championship level and her judging assignments have taken her to all Australian States, New Zealand, USA, The Philippines, Thailand, South Africa, Canada, Japan, Korea, Sweden, Mexico and the UK.

In her business life Lyndall holds a senior position at a Government Not For Profit organisation.

Lana Ferguson



Lana Ferguson has bred Dalmatians and Dobermans since 1973 under the kennel name Legendale. She has been judging since 2016.

Jeff Horswell



Jeff has been going to dog shows from an early age. It all started when his mother (Ann Foxwell) decided that a Great Dane was the ideal breed for a family pet, and they then decided to go along to a local show. A 'show' Dane followed and the Auldmoor Great Dane kennel produced a large number of Champions, both in the UK and around the world. Jeff decided to have Miniature Wire Dachshunds as his own breed. 23 Min Wire Champions have been made up by him, including 3 Crufts BOB winners and 4 group winners. Jeff has always had an interest in many breeds and has also made up a Greyhound Champion and 2 Field Spaniel Show Champions. He currently shares his home with Champion Whippets. Jeff first judged in 1982, and first awarded CCs in 1989, at the Scottish KC. He judged Min Wires at Crufts in 2000, his first Hound Group in 2000 and BIS in 2003. Jeff is approved to

award CCs in over 190 breeds across all 7 UK groups. He judged Best in Show at Crufts in 2017 and has also judged the Hound and Pastoral Groups at Crufts, with an invitation for the Working Group. Jeff has judged many parts of the world including Sweden, Finland, Denmark, Norway, Iceland, Russia, Australia, New Zealand, Estonia, Latvia, Switzerland, Spain, Portugal, Italy, Holland, Belgium, Hungary, Croatia, Slovenia, Poland, Romania, Slovakia, Czech Republic, Ireland, USA, Canada, Japan, South Korea, Argentina, Colombia, India, South Africa, Trinidad & Barbados. Previously a member of the UK Kennel Club Board he is now a member of the Breed Standards Committee.

Ramon Podesta



Since 1963, primary breed has been German Shepherds. He has produced more than 50 GSD Champions and has owned and held the top German Shepherd dog for more than 15 years. In addition, he has been involved in breeding and exhibiting Afghan Hounds, Basset Hounds, Beagles, Whippets, Borzoi, Old English Sheepdogs, Collies, Doberman Pinschers, Great Danes, Rottweiler's, Schnauzers, Yorkshire Terriers, Standard Smooth Dachshunds, Chows, Irish Setters, Pointers, Dalmatians, Maltese, Pekingese, Japanese Chins, Poodles, (all varieties) and Shih Tzu. Ramon has owned and bred a record number of champions and top dogs in the country including Latin American International and World Champions. In total he has produced more than 250 champions including International and World Champions and many BIS winners. Been an All Breeds judge since 1978 and has judged in all Latin American countries Argentina, Mexico, Canada, Spain, Portugal, Austria, Finland, Israel, Australia, New Zealand, Japan, South Africa, Portugal, Italy, Sweden, Denmark, England, including World Dog Shows in Argentina, Brazil,

Austria and Portugal and Royal Shows in Australia and Asian International Shows. He is a member of the Scientific Committee of the FCI and was President of the Kennel Club de Chile. Judged Sydney Royal 2005, and Melbourne Royal in 2008.

It is the owner of the dog entered that is responsible for any error in entering his/her dog regardless of how or by whom the entry was made. Please review email confirmations so corrections may be made **prior to closing date** to avoid disappointment.

8.6.1 The authorities of any show may decline to accept entries for just cause

4.1.5 No person may approach a judge wither directly or otherwise, orally, in writing or electronically, to favour his entry. Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the action.

19.7 It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

A service charge of 10% will be assessed. This includes entries sent online or post using a credit card or Interac for payment.

ALL Entries MUST be received by closing date: WEDNESDAY, Nov 13th, 2024 @ 9:00pm Pacific Time

The tendering of NSF cheque shall be considered non-payment of entry fees and is punishable by disciplinary action and cancellation of awards. A collection fee of \$25.00 will be added to the amount of any returned cheque. Exhibitors whose charges are declined by the Bank Card Authorization Department will be assessed a service charge of \$25.00 for each transaction declined. Telephone entries are not accepted by the Show Secretary. Incomplete entries or entries received without fees, or entries received after the advertised closing date will not be accepted.

Attention foreign exhibitors, please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian Funds. If you sent a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please DO NOT make cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian Funds.

CONFORMATION CLASSES

The following Regular CKC Classes (divided by sex) will be offered:

JUNIOR PUPPY CLASS - This class shall be for any dog 6 months of age and under 9 months of age on the day of the show

SENIOR PUPPY CLASS - This class shall be for any dog 9 months of age and under 12 months of age on the day of the show

12 to 18 MONTH CLASS - This class shall be for any dog 12 months but under 18 months of age on the day of the show

CANADIAN BRED CLASS - This class shall be for any dog born in Canada.
(Champions of any country excluded)

BRED BY EXHIBITOR CLASS - This class shall be for any dog owned and handled in the ring by owner/breeder. The handler **MUST** be the owner/co- owner **AND** breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

OPEN CLASS - This class shall be for all dogs

SPECIALS ONLY CLASS - This class shall be for any dog that has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. Note: A Listed dog may be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class **MUST** be received by the Show Secretary **ONE HOUR PRIOR TO THE OPENING OF THE SHOW ON THE DAY CONCERNED**. Listing Fees **WILL NOT** be refunded

EXHIBITION ONLY - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class **MAY NOT COMPETE** in any Regular class but may enter and compete in Non-Regular classes and/or Parades **ONLY**

NON-REGULAR CLASSES - Friday thru Sunday

VETERANS CLASS - Dogs must be 7 years of age and over on the day of the show. Dogs entered in this class may be spayed or neutered. Awards for this class are: Best Male Veteran, Best Female Veteran, Best Veteran in Breed, Best Veteran in Group, Best Veteran in Show (This class will be held on completion of Best Puppy in Breed, Best Puppy in Group and **PRIOR** to Best in Show)

BABY PUPPY CLASS - This class shall be for any dog 4 months of age and under 6 months of age on the day of the show. The award for this class are: Best Baby Male, Best Baby Female, Best Baby Puppy in Breed, Best Baby Puppy in Group, Best Baby Puppy in Show (This class will be held on completion of Best Puppy in Breed, Best Puppy in Group and **PRIOR** to Best in Show)

JUVENILE SWEEPSTAKES

Juvenile Sweepstakes is open to all puppies four months and under eighteen months of age regardless of place of birth. All dogs must be entered in one of the regular official classes on the same day. Dogs will be judged in one of the following eight classes (divided by sex):

Baby Puppy - 4 months and under 6 months
Junior Puppy - 6 months and under 9 months
Senior Puppy - 9 months and under 12 months
Juvenile Puppy - 12 months and under 18 months

For final judging the first place puppy from each of the classes will be brought together for the final judging of Best in Sweepstakes.

Best in Sweepstakes - rosette & 15% of total fees collected for the Juvenile Sweepstakes
Best Opposite in Sweepstakes - rosette & 10% of total fees collected for the Juvenile Sweepstakes
1st in Each Class - rosette & 6% of total fees collected for the Juvenile Sweepstakes
2nd thru 4th - rosette

Veteran Sweepstakes is open to all dogs 7 years of age and over and entered in a regular class or for exhibition only on the same day. Spayed and neutered dogs may compete provided they are also entered in exhibition only.

Dogs to be judged in one of the following four classes (divided by sex):

Junior Veteran - 7 years and under 10 years
Senior Veteran - 10 years and over

For final judging the first place winner from each of the classes will be brought together for the final judging of Best in Sweepstakes and Best Opposite Sex in Sweepstakes

Best in Sweepstakes - rosette & 15% of total fees collected for the Veteran Sweepstakes
Best Opposite in Sweepstakes - rosette & 10% of total fees collected for the Juvenile Sweepstakes
1st in Each Class - rosette & 12% of total fees collected for the Veteran Sweepstakes
2nd thru 4th - rosette
25% of fees collected will be retained by the club to defray costs

JUNIOR HANDLING

Competition is open to all Junior Handlers between the ages of 4 and up to 18 years of age (of the competition year). Pee Wees do not compete for best overall. Dogs handled by the juniors must be entered in a Regular Conformation class or in Exhibition Only at this event. Dogs do not need to be owned by the junior.

Please note that effective January 1, 2016, in accordance with Section 3.4.1 of the Junior Handling Rules & Regulations, Junior Handlers will be required to apply to CKC Head Office for a **Junior Handling Number**. Section 3.4.1 "Junior Handler with the exception of Pee Wees, must apply to CKC Head Office on the appropriate form for a Junior Handling Number within 30 days of competing in their first Junior Handling event. This Junior Handling Number will be used by the Junior Handler for the duration of their Junior Handling career. If a Junior Handling number is not obtained, Junior Handling points earned will not be tracked."

GENERAL RULES GOVERNING THESE SHOWS

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the Conformation Rule book is available online:

www.ckc.ca

1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
4. A Judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
6. **DOGS MUST BE READY FOR JUDGING.** The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed. All start times are PACIFIC TIME.
7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$115 plus GST (for Canadian residents) (\$230 non-resident), which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog BEFORE taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.
13. The tendering of NSF cheque shall be considered non-payment of entry fees and is punishable by disciplinary action and cancellation of awards. A collection fee of \$25.00 will be added to the amount of any returned cheque. Exhibitors whose charges are declined by the Bank Card Authorization Department will be assessed a service charge of \$25.00 for each transaction declined. Telephone entries are not accepted by the Show Secretary. Incomplete entries or entries received without fees, or entries received after the advertised closing date will not be accepted.
14. Attention foreign exhibitors, please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian Funds. If you sent a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please **DO NOT** make cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian Funds.

CANADIAN KENNEL CLUB SCHEDULE OF CHAMPIONSHIP POINTS

SECTION 2. The schedule to be employed in the determination of the number of points to be allocated to a dog awarded WINNERS shall be as follows: (*Includes the dog awarded Winners.)

Dogs Competing*	1	2	3 to 5	6 to 9	10 to 12	13 or more
Points Allocated*	0	1	2	3	4	5

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. A dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points. Further section 15.1.12 {C} has been added and states the dog must: "have earned at least one 2 point win either at the breed level or group level."

The system provides for additional points if a dog awarded winners also places in the Group as listed here under.

A class Dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five (5) points at a single show. To earn a Canadian Championship, a dog must earn at least ten championship points under at least three different judges; and be individually registered with the Canadian Kennel Club, or have a CKC Event Registration Number (ERN) and have earned at least one 2-point win either at the breed or group level.

In order to obtain a Grand Champion title, a dog must obtain a minimum of 20 points which must include a minimum of two wins of at least 2 points and at least two (2) points after 12 months of age. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points. (d) Only the highest points earned at a single show are carried forward.

15.2.4 Grand Champion Bronze (GChB) The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.

(a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship.

(b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

(c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

15.2.5 Grand Champion Silver (GChS) The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Bronze is attained, and do not include the points earned in attaining the Grand Championship Bronze.

(b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.

15.2.6 Grand Champion Gold: (GChG) The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Silver is attained, and do not include the points earned in attaining the Grand Championship Silver.

(b) To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best in Show/ Specialty level. Only the highest points earned at a single show are carried forward.

15.3 Grand Champion Excellent (GChEx) (48-06-12)

15.3.1 The title of Grand Champion Excellent may be granted only after the completion of the CKC Grand Championship Silver Title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website.

15.3.2 To earn the title a dog must have earned the following during their career as a Special:

(a) one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed)

(b) three (3) Group 1st, or three (3) breed specialty best of breed wins.

(c) a CKC performance title from any CKC Event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.

15.3.3 Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance title may be attained at any time in the dog's career.

1. Exhibitors are required to complete the Grand Champion Excellent Record Sheet form located on the CKC website and forward to CKC upon completion of requirements above.

2. Grandfathering of the previous version of the Grand Champion Excellent title will be honoured up until July 1, 2022

AGREEMENT

I (we) acknowledge that I (we), all exhibitors, handlers and patrons, know and abide by the "CKC Dog Show Rules", and that I am (we are) familiar with their content. I (we) agree that the Club holding this show has the right to refuse this entry for cause, which the Club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Show and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Tyee Kennel Club, their members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
