

Competitors, through submission of entry, acknowledge that they are knowledgeable of the rules and regulations of the AAC, including but not limited to the following:

This event is held under AAC Rules and Regulations and is open to all dogs being at least 18 months of age, pure bread or mixed breed, except bitches in season, aggressive dogs, or dogs suffering from any deformity or illness which may affect the dog's physical or mental performance.

Obstacles shall be chosen from those described in the current edition of the rules and regulations of the AAC and shall conform to AAC specification.

No leads, collars, food, toys or any other aids or devices shall be permitted on the course at any time. No pinch, choke or electric collars are permitted on the site.

It is expressly understood that competitors alone are responsible for the behavior of their dogs and / or children. Any competitor whose dogs and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may be asked to leave the show grounds and NO REFUND of fees shall be given.

All dogs must be penned, crated or on leash when not in the ring. All dogs must be under control when exiting the ring. Any dog engaging in aggressive or out of control behavior upon exit of the ring may be disqualified and / or required to leave the show grounds and NO REFUND of fees shall be given.
