Non CKC members who are Canadian, running a wholly-owned dog, cannot win a placement unless they pay a non-member fee to the CKC. Otherwise, Awards and Titles will be cancelled. The fee will be paid directly to the CKC.

**Awards**

CKC Rosettes & Prizes will be awarded to all dogs who place, and Rosettes are awarded for CM's.

Presentations will be made at the Tailgate, Saturday evening, Sunday and Monday upon completion of each stake. Excerpt from CKC Retriever Field Trial rules and regulations, dated 1 January 2011, 21.7 P 67

"It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Retriever Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred"

**Game**

Dead ducks and/or pheasants will be used in all stakes.

**Running Order**

Dogs will run in order of the draw with sexes mixed.

Running order will rotate in the Open & Amateur stakes.

Starting number in All-age stakes will be based on the two digits right of the decimal on the prior Wednesday TSX closing.

**HEALTH REMINDER**

No dog may be brought onto the grounds or premises of an event if it:

Is known to have distemper, parvovirus, kennel cough or other communicable disease; Has recovered from distemper, parvovirus, kennel cough or other communicable disease within the last 30 days (prior to the event); Has been housed within 30 days prior to the event on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease.

Clubs do have the right to remove a dog from the event premises and the exhibitor may be subject to disciplinary action if it is found that CKC rules have been contravened.
