A service charge of 10% will be assessed. This includes entries sent online or post using a credit card or Interac for payment.

Please note that entries will be accepted only through DogShow.ca – paper entries and entries through other online entry services will NOT be accepted. *The entry form attached is for information purposes only!*

Mixed breeds and unrecognized breeds with a Canine Companion Number (CCN) are welcome to enter these trials.

These events are being held under the rules of The Canadian Kennel Club. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. No person may approach a judge either directly or otherwise, orally, in writing or electronically, to favour his entry. Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the action.

While entries are not limited, parking is limited to 20 cars per day. When entering, please be sure to indicate whether you will need a parking space for each day. Once all 20 parking spaces have been claimed, we will only be able to accept entries for which no parking is required. Car-pooling is strongly recommended, and we ask that exhibitors and volunteers arrange to car-pool or be dropped off.

There will be a veterinarian on call throughout all shows via the Veterinary Specialty Center at 709- 221-7838.

This trial will use manual timing. The table, teeter, dog walk, and A-Frame are rubberized. Dogwalk and teeter are Galican Intercan models. Tire is Galican 24" breakaway tire (not self-healing). 24" weave poles will be used. Flat carded ribbons will be awarded for 1st through 4th placements. Rosettes will be awarded for Qualifying runs and Titles. No obstacle familiarization shall be provided. Handlers in all classes are permitted to walk the course, without a dog, prior to the start of each class.

- **Food cannot be within 10 ft of ring.**
- **NO SMOKING on any of the property at 97 LeDrew's Road, except inside personal vehicles.**
