The Dog Show Rules states a judge officiating at a show held under these Rules shall not be subjected to indignities of any kind during the progress of the show, and it shall be the duty and obligation of the club holding the show to see that this Rule is effectively carried out.

A copy of the Rules pertaining to Dog Shows & Obedience Trials is available from the Canadian Kennel Club. Each exhibitor is responsible for knowing and complying with the rules of the Canadian Kennel Club regarding their events.

## RALLY OBEDIENCE CLASSES

- Novice A** For dogs that have not earned the RN title or a CD or higher and are handled by the owner or immediate family member who have not exhibited a dog through as CDX title
- Novice B** For any dog until such time as a qualifying score in Advanced is earned.
- Intermediate** For dogs that have earned the RN title.
- Advanced A** for dogs that have earned the RN title but not earned the RA title and is handled by the owner or immediate family member member who have not exhibited a dog through as CDX title
- Advanced B** For any dog that has earned the RA tile. Any on who has obtained a CDX on a dog.
- Excellent A** For dogs that have earned the RA title but not earned the RE title and is handled by the owner or immediate family member member who have not exhibited a dog through as CDX title
- Excellent B** For any dog that has earned the RA title

### Unofficial Classes

Rally Novice team Rally Advanced Team

A Bitch in season may not compete in Obedience or Rally Trials. Entry fees will be refunded ONLY if the Trial Secretary BEFORE commencement of the trial receives a Veterinarian's Certificate.

Team This class is open to any 4 dogs that have earned a title of R N or higher.

### CATALOGUE

Catalogues will be available from trial and show secretary on a pre-order basis only - \$ 3.00. Catalogues will not be mailed to absent exhibitors.

### RALLY OBEDIENCE TROPHY & PRIZE LIST

Appropriate prizes and rosettes will be awarded for High in Class qualifying scores for all classes being offered.

Rosettes will be awarded to dogs placing 2nd, 3rd and 4th in all classes being offered.

### GENERAL INFORMATION

- The Trial Superintendent will be in full charge of the show.
- Children, accompanied by an adult, are welcome at our show, however, please do not allow them to disturb dogs without permission of owner/handler .
- All exhibitors will be held responsible for clean up on the trial premises and surrounding areas for their own dogs or dogs they are handling and must use the designated areas.
- It is the responsibility of the exhibitor to have their dog at ringside when it is scheduled.
- The MGRC and Stay N Play will not be held responsible for any equipment left on the grounds overnight.
- A judge officiating at a trial shall not be subject to indignities of any kind during the progress of the show and it is the duty and obligation of the show-giving club to see that this rule is effectively carried out. (Dog Show Rules, Sec. 4.1.3)
- The MGRC and the Show Committee will use care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume and liability in the event of an accident, or other misfortune to either the dogs or exhibitors or patrons. If, because of riot or civil disturbance or any other acts beyond the control of the MGRC and their Show Committee, it is impossible to open or close the shows, no refund of entries will be made.
- If because of riot, civil disturbance or other acts beyond the control of the MGRC, it is impossible to open or complete the Trials, no refund of entry fees will be made
- Only dogs entered in the Trials will be permitted on the show premises.
