**CKC LISTING FEE: \$8.50 + 5% GST**

**CLOSING DATE: THURSDAY, APRIL 13, 2017, at 6:00pm.** The Club cannot accept entries delivered after this date and time. Any entries received after the closing date will be discarded. **All duplicate entries received for the same dog in one event will be discarded. Multiple entries in one envelope will NOT be accepted (CKC rule 6.1.19). SEND BY MAIL ONLY.** No courier, emailed, faxed or hand delivered entries will be accepted. The Test Secretary will notify the entrant by email on the day the entry is received.

**ENTRY DRAW:** A random entry draw will take place on **SATURDAY, APRIL 15, 2017, at 1:00pm.**

**Location:** Tim Hortons, 37444A Highway 2 South, Red Deer County, AB T4E 1B2 (west side of Gasoline Alley). Entry draw will follow the draw procedure as outlined per CKC rule 2.2.4.

**CLUB WORKER DRAW:** At the entry draw one TD track and one TDX track will be reserved per CKC rule 6.6.2. "Club Worker" is defined by Central Alberta Tracking Society policy.

## **GENERAL INFORMATION:**

**\*\* SATURDAY/SUNDAY:** If the TDX tracks on Saturday and the TD tracks on Sunday do not fill, we may offer a different track level (up to maximum allowed exchange per CKC rule 6.2.2), depending on field and tracklayer availability. Exhibitors may send in an entry and cheque for a chance at a TD track on the Saturday or for a chance at a TDX track on the Sunday. If the TDX tracks fill on Saturday & the TD tracks fill on Sunday, a refund will be sent within 10 days of the test date for all TD entries received for Saturday and for all TDX entries received for Sunday.

**PAYMENT:** Please make all cheques payable to Central Alberta Tracking Society. Fees must accompany each entry. No post dated cheques will be accepted. A listing fee as established by the Canadian Kennel Club must accompany the entry of a dog where a Canadian Kennel Club individual registration number or Event Registration Number (ERN) is not shown on the entry form. **NOTE:** There will be a \$40.00 service charge on all **NSF** cheques received. Tendering an **NSF** cheque shall be considered **NON-PAYMENT OF ENTRY FEES** and is an offense punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club.

**REFUNDS:** Withdrawn entries after closing date will only be refunded where there is an "Alternate" available who chooses to fill that assigned entrant's vacancy on test day. Alternates will be contacted in catalogue order and advised of the opening. They may choose to accept the spot and become responsible for the entry fee or decline and bear no financial obligation. Anyone on the "Alternate List" may request a refund at any time prior to test day. Entries will be refunded within 10 days of the test date to those on the alternate list that did not participate in the test.

**RENDEZVOUS LOCATION:** UFA Parking Lot, 210 Burnt Lake Business Park, Red Deer West, AB., T4P 3R2

**TRACK DRAW:** On Saturday, May 6<sup>th</sup>, the draw will take place at 9:00 am in the UFA parking lot with the first dog starting its track at 9:30 am. On Sunday, May 7<sup>th</sup>, the draw will take place at 8:00 in the UFA parking lot with the first dog starting its track at 8:30 am.

**BITCHES IN SEASON:** Bitches in season will be permitted to compete but will be assigned the last track. Please advise the Test Secretary as soon as possible if your bitch is in season for the test.

**PRIZES:** A ribbon stating "Passed TD" or "Passed TDX" will be awarded to dogs earning these titles.

**AWARDS & NO-HOST LUNCHEON:** A no-host luncheon will be held at a local restaurant upon the completion of the tracking test each day with our Judge who will present ribbons (and sign gloves) to all successful teams.

**SPECTATORS:** Spectators will be expected to obey any instructions given by the Test Superintendent.

**PLEASE NOTE TO ALL NON-MEMBERS OF THE CANADIAN KENNEL CLUB:** Effective January 1st, 2011 an annual non-member participation fee for all awards and titles will be charged to a Canadian nonmember of CKC. The fee will match the ERN fee \$59.40 + 5% GST. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. This fee applies only to dogs wholly owned by non CKC members and not dogs co-owned by a CKC member. Entries shall not be accepted from any person who is not in good standing with the Canadian Kennel Club on the day of entries closing.

**US EXHIBITORS:** U.S. entrants may pay fees by money order payable in Canadian funds OR by personal cheque in U.S. funds for the full amount of the fees. Personally, discounted cheques will not be accepted and please do not mark cheques "Payable in Canadian Funds" or "At Par" as these will not be accepted. Bank drafts or money orders payable in Canadian Funds are the best choice. Please make bank draft, cheque, or money order payable to Central Alberta Tracking Society.

**RULE 14.7:** It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

**EXHIBITORS PLEASE NOTE:** It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. EXHIBITORS MUST BE PRESENT WHEN IT IS THEIR TURN TO RUN THE TRACK. Exhibitors that are not present when their name is called will be disqualified.

Do not leave dogs unattended, please pick up after your dog, all dogs must be kept on leash and under control at all times if not securely confined.

Central Alberta Tracking Society will exercise all reasonable care for the safety of the dogs competing, but will not be held responsible for the loss, damage, or injury to any dog, handler or owner, children not under the control of their parent or guardian and their property.

**DISCLAIMER OF LIABILITY:** Central Alberta Tracking Society members, volunteers and the land owners will use due care and diligence for the welfare of dogs and exhibitors, BUT will not be responsible for, nor assume any liability in the event of an accident or other misfortune to either dogs, exhibitors or patrons. By entering this Test each participant agrees to assume all risks and hazards incidental to participation in the Test and agrees to release and to save harmless and indemnify the owner(s) and/or leasee(s) of any property upon which the Test may be held together with their officers, agents, employees and representatives from all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to the person or property of the participant howsoever caused, arising out of or in connection with the participant's use or entry upon the property. My signature on the entry form indicates that I understand and agree to the above and to abide by rules of the current Official CKC Rules and Regulations as well as rules set forth by Central Alberta Tracking Society concerning this event.
