

Additional Information

- ☞ Overnight parking permitted on field. **Please park in the designated area.** Port-a-potty on site.
- ☞ Stakes will be split if the entry is 24 or more hounds at roll call.
- ☞ Hounds will be run twice, in braces or trios (except single dog entries) unless excused, dismissed, or declared ineligible.
- ☞ Lame hounds or bitches in season will be excused and their entry refunded, provided notice is given prior to or during roll call.
- ☞ Hounds not present at roll call shall be scratched with no refunds. **No Exceptions.**
- ☞ All handlers must use a slip lead when releasing a hound. A **Standing Start** will be used on Tally-Ho.
- ☞ Leg wrappings must be of a neutral colour to comply with CKC rules. Muzzles & catch collars may be used at the handler's discretion. **No Flexi-leads or shock collars allowed.**
- ☞ A \$5.00 fine will be assessed for loose dogs on the field after roll call and until after Best in Field.
- ☞ **There will be a canteen for your eating pleasure.**
- ☞ Bring your own water and shade.
- ☞ No catalogue will be published. Score sheets will be available.
- ☞ A veterinary clinic is within easy access to the field.
- ☞ **Please clean up after yourselves and your dogs. Do not stuff plastic bags down holes. Please use the trash receptacles provided.**
- ☞ **Please come early to help fill gopher holes they have been very busy.**

Entries

Open to any Afghan, Basenji, Borzoi, Greyhound, Ibizan, Italian Greyhound, Pharaoh Hound, Saluki, Scottish Deerhound, Whippet, Irish Wolfhound or CKC Miscellaneous Sighthound that is one year or older the day of the trial. All entrants must be registered or eligible for registration, with the Canadian Kennel Club, have ERN # or PEN #. Hounds presently disqualified under CKC, ASFA, CSFA OR AKC rules cannot compete. Hounds with breed standard disqualifications, or altered/neutered are eligible to enter the lure field trial. **Hounds must pre-qualify prior to entering their first trial in Canada. See information elsewhere in this Premium List.**

Your GPS may want to take you down Twp Rd 250. Ignore it and take Twp Rd 252.

From the North:

Hwy #2 South to Stoney Trial Hwy #201. Follow Stoney Trial East to the Country Hills Blvd Exit (exit 68) Go East on Country Hills Blvd (Hwy # 564) for 17.2 km to Hwy #9. South on Hwy #9 3.2 km (2 miles) to Dalroy Road (Twp Rd 252). East 1.6 km (1 mile) to Rge Rd 271. Right turn-South to first acreage. Use field entrance not private driveway.

From the South:

QE Hwy #2 North to Stoney Trail Exit 234A. Exit East (right) on Stoney Trail to Hwy #22X East Exit 96. Take Hwy #22X Exit East to Langdon Corner (Rge Rd 272). Signage for Boulder Creek Golf Course. North on Rge Rd 272 to 4-way Stop at Langdon. Continue North (now on Hwy 797) to Hwy #1. Cross Hwy #1 onto Hwy #9. North on Hwy #9 for 9.6 km (6 miles) to Dalroy Road (Twp Rd 252). At this point, follow directions from North. Your GPS may want to take you down Twp Rd 250. Ignore it and take Twp Rd 252.

From the West:

Trans Canada Hwy (#1) to Stoney Trial Hwy #201. Follow Stoney Trial to the Country Hills Blvd Exit (exit 68) At this point, follow directions from North.

From the East:

Trans Canada Hwy (#1) to Hwy #9. Turn Right on Hwy #9 and go North on Hwy #9 for 9.6 km (6 miles) to Dalroy Road (Twp Rd 252). At this point, follow directions from North.

SINGLES COMPETITION

9:00 AM Roll Call - If Your dog is DQ'd or not ready for running in competition, but you would like your dog judged? This is the place to be! Run individually, over the entire course (both directions) the dog is judged by one judge. No points are awarded and all ties are settled by a coin toss. A trophy and ribbon will be awarded to 1st place and ribbons for 2nd to NBQ.

Stakes Offered

<u>Open Stakes</u>	For all hounds including Field Champions
<u>Mixed Stake</u>	Combines breeds with entries of <u>three or less</u> with agreement of all owners.
<u>Best in Field</u>	For all Best of Breed winners & 1 st from Mixed Stake
<u>Singles</u>	See Description elsewhere <i>Both Days</i>
<u>Puppy Sweeps</u>	Puppies between 6 & 18 months are run <i>individually (SATURDAY ONLY)</i>
<u>Veteran Sweeps</u>	<i>Dogs 7 years & older on date of trial. Run individually. (SATURDAY ONLY)</i>
<u>Breeder Stake</u>	Open to any 2 hounds in the official classes bred by the same person(s). <i>SATURDAY ONLY</i>
<u>Kennel Stake</u>	Open to any 2 hounds in the official classes owned & kenneled by the same person(s). <i>SUNDAY ONLY</i>

*NOTE: Breeder & kennel stakes combinations must be declared prior to Roll Call.

Placements and Awards

Chapter 7, Section 1: Championship points are awarded in regular stakes only on the following basis:

1st:	4 x # of hounds competing in stake, to a max. of 40 points
2nd:	3 x # of hounds competing in stake, to a max. of 30 points
3rd:	2 x # of hounds competing in stake, to a max. of 20 points
4th:	1 x # of hounds competing in stake, to a max. of 10 points
NBQ:	No points

No hound shall receive a placement or points if it does not score at least 50% of the total possible combined scores. If a hound has been **excused** in the preliminary run, that hound shall not count as having been in competition. **Exhibitors please note:** As per rule 9.6.1(b) of the CKC Lure Field Trial Rules and Regulations a dog must "Attain 1 first or 2 second placements by **defeating dogs in head to head competition**". No placements will be awarded towards CKC championships if all dogs in a breed run as singles, but the points will stand.

Take a Walk with the Judges

As part of their judging assignment, our judges must walk the course to ensure that a safe course plan has been laid out for *your* hounds. On this field that means looking for and filling holes. You and a shovel are encouraged to join them in assuring the safety of *your* hounds.

All prizes must be claimed at the trial. They will NOT be mailed.

RMWAA wants YOU!! Help keep our trials running smoothly. Volunteer at Roll Call to judge our Puppy and Veteran runs, that way we don't have to beg for judges before the runs start.

First Time Entered Hounds: (This does not apply to Singles Competition)

Effective July 1 1998, hounds entering their first trial in Canada must be tested with another hound, **not** a kennel mate, and certified running clean by a licensed judge. The CKC Hound Certification Form must be completed and **submitted with the entry at the hound's first trial**. Hounds with the following titles are exempt: ASFA FCh or VFCh , AKC FC or SC, but are still required to submit the Hound Certification Form with their name and exempt titles circled.

A Hound Certification form may be downloaded from the Canadian Kennel Club website www.ckc.ca. Go to the CKC Services >CKC Forms On-line >Other Shows and Trial Forms and Select #5 Hound Certification.

ATTENTION ALL FOREIGN EXHIBITORS

Effective January 1, 1992 all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an **Event Registration Number (ERN)**. This ERN does not register a dog for breeding purposes as defined in the Animal Pedigree Act, but rather enables a foreign-owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number. To obtain an ERN, mail or fax a photocopy of the dog's foreign registration certificate with cheque or VISA/MasterCard number (expiry date, cardholder's name and signature). Provide your complete address for return of the ERN to you. Cost is \$56.70. ERN MUST BE APPLIED FOR WITHIN 30 DAYS OF FIRST DAY OF ENTERING A CKC EVENT TO AVOID CANCELLATION OF AWARDS.

Non Member Participation Fee

The following non-member participation fee now applies and is retroactive to January 1, 2011. The non-member participation fee applies to all Canadian residents who participate in a CKC event but are not CKC members and a participating non-member can chose to purchase a CKC membership or pay the non-member fee. This only applies to dogs wholly owned by non members and is not applicable to CKC members or dogs co-owned with a CKC member. In order for the CKC to efficiently manage recording and tracking points, it's important that non-members select one of the two options within 30 days of notification or, unfortunately, CKC will be forced to cancel any awards and titles

Non-Member Participation Fee

24-12-3. Non-member participation fee

- a) An **annual** non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) The Premium List must carry a note stating that "these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members."
