



# Sudbury and District Kennel Club Agility Trial July 5 2025 OUTDOOR Agility Trial Judging Schedule

If you have not already done so, please review your entry for classes and jump heights and notify the event secretary Candie Pritchard at <a href="mailto:agilitysdkc@gmail.com">agilitysdkc@gmail.com</a> as soon as possible of any concerns.

Parking is available in the laneway behind the barn, and beside the sheds, but please avoid parking on the grass. Trial site is open at 7:30 am for parking on Saturday morning. There is no cover for inclement weather. Feel free to bring shade tents to set up at the field.

You will get all course maps on the tables where the ribbons are located in the barn shelter/garage. Novice Standard maps will only be put out *after* the optional Novice Fun Run. You can register at the registration table on the day of with \$15 cash exact change, if possible, please. There is no contact familiarization available.

Please keep an eye on the easel with the running order. We will do our best to support you but we will not be able to rebuild courses. Please note day of trial entries will be accepted in the morning at this trial for official and FFO runs. Move-ups are not permitted at this trial.

You will find the results posted on the table where the ribbons are located. Your qualifying ribbon and placement ribbons will be in the binder. If you do not wish to take them that is okay, we will be able to reuse them. Congrats to those of you who achieved a new title and wish to get a new title ribbon!

As per CKC regulations, there cannot be food or toys within 10 feet of the ring. Non-squeaky toys are allowed in FFO runs and must be shown to the judge when entering the ring. \*\*Please announce it is a FFO run when entering the ring.\*\*

## In order to make everyone's visit a safe and enjoyable one, we have just a few rules:

- PLEASE drive slowly down the driveway. 5 km/hr limit!
- This is a private residence. Do not walk your dogs throughout the property. Stay in the field around the agility field.
- Please clean up after your dog. Anyone found not cleaning up after them will be asked to leave.
- Dogs must be on leash at all times, except when competing in the ring. No exceptions.
- Not all dogs love other dogs. Please keep your dog under control and out of other dogs' faces, even if your dog is friendly.
- Please pack out your garbage and poop bags!
- No smoking anywhere on the trial site.
- Please do your best to keep barking to a minimum
- Be nice to our judges and volunteers. Remember if you want to be treated with respect give others the same respect. We have a zero tolerance for any abuse of dogs or humans.
- Agility is a team sport, so please leave prong collars and other correction gear at home.

### Saturday July 5, 2025 Trial Running Order:

#### Running order for the day is: Small to tall.

\*\*There will be a 30-minute lunch break at judge's discretion.\*\*

8:30am General and Judge's Briefing, and walk through
8:45 First Dog on the line - Jumps & Tunnels (15 dogs)
Novice Jumpers with weaves (JWW) (4 dogs)
Intermediate Jumpers with weaves (JWW) (4 dogs)
Excellent/Master Jumpers with weaves (JWW) (5 dogs)
Optional Novice Fun Run (Each dog will have maximum 60 seconds)
Novice Standard (6 dogs)
Intermediate Standard (5 dogs)
Excellent/Master Standard (3 dogs)
Novice Points and Distance (PAD) (8 dogs)
Intermediate Points and Distance (PAD) (2 dogs)
Excellent Points and Distance (PAD) (0 dogs)
Jumps & Tunnels (13 dogs)

Remember we enter the ring as friends and leave the ring as friends.

In 2010 the Board of Directors of the CKC passed a motion with respect to a Non-Member Tracking Fee for Canadians that participate in CKC events and are not CKC members. At the December 2010 Board of Directors meeting, the Tracking fee motion was deleted and replaced with the following motion. Non-Member Participation Fee a) An annual non- member participation fee for awards and titles will be charged to a Canadian non-member of the CKC. This fee will match the ERN fee. b) In order to protect the awards/titles earned, the non-member will have a choice either, to become a CKC member or to pay the non-member Participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. c) The Premium List must carry a note stating that these fees apply only to dogs wholly owned by non- CKC members and are not applicable to CKC members. The Non-Member Participation Fee is effective January 1, 2011. Cost is \$63.90 + HST. The CKC has also asked clubs to remind competitors of the following;

#### **HEALTH REMINDERS:**

No dog may be brought onto the grounds or premises of an event if it:

- 1. Is known to have distemper, parvovirus, kennel cough or other communicable disease;
- 2. Has recovered from distemper, parvovirus, kennel cough or other communicable disease within the last 30 days (prior to the event);
- 3. Has been housed within 30 days prior to the event on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease.

Clubs do have the right to remove a dog from the event premises and the exhibitor may be subject to disciplinary action if it is found that CKC rules have been contravened.
