In consideration of acceptance of the entry and the opportunity to have the dog judged and to win ribbons or prizes at the events held on the date(s) above, I agree:

- To hold the Host Club including its members, directors, officers, employees and volunteers (collectively defined as "the Host Club"), as well as the owner and lessor of the real property on which the event is held, harmless from any claim for loss or injury which may be alleged to have caused directly or indirectly to any person or thing by the act of myself or my dog(s) while in or about the event premises or grounds near the entrance thereto and I assume all responsibility and liability for any such claim.
- To hold the Host Club harmless from any claim for loss of this dog by disappearance, theft, death or otherwise and from any claim for damage or injury, even if such loss or damage/injury was caused or alleged to be caused by negligence of the Host Club or any other person(s);

To assume the sole responsibility for and agree to indemnify, defend and save the Host Club harmless from any and all loss and expense, including legal fees, by reason of the liabilities imposed by law upon the Host Club for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person(s), including myself, or on account of damage to property, arising out of or in consequence of my participation in the event, however such injuries, death or property damage may be caused and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the Host Club or any other person(s);
- 4. That any cause of action, controversy or claim arising out of or related to the attendance at the event between the Host Club and myself or as to the construction, interpretation and effect of this waiver shall be settled by arbitration in the province of Ontario and
- 5. That the Host Club has the right to refuse this entry for cause, which the Host Club will deem sufficient.
