USA Exhibitors Only Bank drafts or money orders, payable in Canadian Funds and negotiable at a Canadian Bank, for the full amount of the entry will be accepted. The Club shall not be obliged to refund entry fees after the closing time to any USA or other foreign Exhibitor who cannot attend the event due to any restrictions placed on travelers to Canada by either Federal, Provincial, State or Local government authorities.

NSF Cheques: Tendering of a dishonoured cheque for entry fees shall be considered non-payment of entry fees, and is an offence punishable by disciplinary action and cancellation of awards (6.3.3 of the Obedience Trial Rules & Regulations) In addition, a \$40.00 service charge will be levied by the Club.

LIMITED ENTRY means advance entry will be limited when the judge's daily assignment reaches 7 hours of judging as calculated in accordance with CKC rules, and will close at the advertised closing time. 'When the advertised limit has been reached, all remaining entries may be assigned a position on the reserve list. The person making the entry shall be notified of his position on the list. Fees will not be refunded for any reason other than a bitch being in season and to those on the reserve list who did not participate in the trial.' The number of entries in any or all classes and/or levels may be limited in each trial due to COVID protocols.

TROPHY LIST

Through the generous support of its members and friends the Poodle Club of Canada will offer the following: Each **Obedience Trial** for qualifying scores only:

High in Trial – Trophy and Rosette

1st through 4th in official classes – Rosette

A Trophy will also be offered for High Scoring Poodle (any variety) each day.

Each Rally Obedience Trial for qualifying scores only:

1st through 4th in official classes – Rosette

New Title Rosettes – The Poodle Club of Canada is pleased to offer a rosette for each dog completing the requirements for a Rally Obedience or an Obedience title at these events.

Move-ups: A dog that fulfills the requirements for a title in accordance with the rules during the first Trial of the day may move to the next level of competition for the second Trial. The transfer must be on the appropriate move-up form and submitted to the Trial Secretary by the owner or handler 30 minutes before the start of the Class.

TCN – Temporary Competition Numbers

If a dog is not registered individually in the records of the CKC, it may be entered at a trial held under these rules with a Temporary Competition Number (TCN), providing that the number is obtained before the closing date of entries. Once the dog is permanently registered or has an ERN, the TCN will no longer be valid. TCN's can be obtained online through the CKC Member Portal. Exhibitors may also obtain a TCN by completing a printed application and submitting it to the CKC by mail, or by contacting the Shows and Trials Division at 1-855-364-7252.

Electronic Communication

All entry confirmations, Judge Schedule and any other notices will be sent from the Secretary@thepoodlefarm.com to the Handler or Owner as indicated on the Official Entry Form. It is the Entrants responsibility to ensure that their email account settings are configured to designate Secretary@thepoodlefarm.com as a Safe Sender, Trusted Sender, Always Allow or such other designation as may be required to prevent your email service from flagging such communications as Spam/Junk and blocking from your Inbox.

CKC REGULATION 20.7:

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Notes to Competitors – Special Information

Due to ongoing concerns with the coronavirus disease, we are asking for your cooperation to limit the possible spread of the disease, and ensure an environment which is safe and comfortable for all participants.

Please do not participate if you answer "Yes" to any of the following in the 14 days prior to the trial:

- Are you experienced any fever, cough, or have difficulty breathing?
- Have you returned from the US or other International destinations?
- Have you been contact traced to a COVID-19 case?
- Have you had close contact with a person with acute respiratory illness who has been outside Canada?

Competitors will familiarize themselves with the CKC **COVID-19 Obedience and Rally Rules General Guidelines** released July 31, 2020. These are allowable temporary changes to Obedience & Rally Obedience Rules and Regulations that a Club may opt to use during their event under COVID restrictions. Changes may be adopted on the Event Day after consultation between the Trial Officials and the Judge.

Special Measures and Instructions:

- Face Masks/Face Coverings are required in the building and when entering and exiting the indoor ring, but may be removed during your run. This requirement may be amended or waived depending on government & local health guidance 14 days prior to the trial.
- Indoor shoes will be mandatory as usual from the time you enter the building until you leave.
- Please park so social distancing is adhered to.
- There will be no indoor crating. Please crate from your vehicle while you are here for the trial. Pop-up tents are permitted on grassy areas and may be used for dogs provided the dogs are quiet and securely contained in crates/X-pens. All shade structures must be spaced to permit physical distancing.
- To facilitate social distancing, we ask that you do not bring friends, children, spouses or others unless you need them to provide mobility assistance at the trial.
- All notices and information will be posted outside the building on a bulletin board, feel to take a
 picture with your phone.
- All briefings will be done outside the building
- No special area will be set aside for reactive dogs.
- Unfortunately we may not allow spectators in the building and we may not allow additional people to video your runs indoors.
- Ribbons are not self-service; we will make every effort to have ribbons and scoresheets available as quickly as possible.
- We encourage you to leave the facility promptly when you are done for the day.
- No lunch will be served. You may bring your own refreshments if you are staying through multiple classes.

Health, Sanitization & Trial Workers:

- We will have a team member cleaning all "touch" areas during the day
- The restroom attached to the garage will be the only facility available to competitors.
- Paper towels, soap, and hand sanitizer is available throughout the facility.



GENERAL INFORMATION

- 1. The **trial precincts** shall be the non-residential buildings and surrounding grounds of The Poodle Farm. In accordance with CKC rules only dogs officially entered and competing are permitted within the Trial Precincts. *There is no "Exhibition Only" class being offered at this trial.*
- 2. No outdoor shoes allowed on the turf indoors. Please ensure you bring clean, dry indoor only shoes.
- 3. Handlers will be charged a "per occurrence" facility fee for any soiling/damage (including urinating and/or defecating) of the turf indoors.
- 4. Only park in the designated area. Physical distancing between vehicles. There will be signage.
- 5. Dogs must be on a leash at all times except when competing in the ring.
- 6. Please keep your dog under control and out of other dogs 'faces', give others the room they require.
- 7. Please pick up after your dog's waste. Please pick up after yourself. Waste containers are provided.
- 8. No smoking, vaping or Cannabis anywhere on the property.
- 9. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.
- 10. Flexi-leads may not be used on The Poodle Farm property
