8.2.5 – An error in the class, date of birth or sex of the dog may be amended on the entry form up to ONE hour PRIOR to the start of the show.

8.5.8 – In the case of a judge change (substitute or overload) an exhibitor may enter a dog under the replacement judge providing that the dog is entered in one of the regular classes within the show being held at the same venue by the same club and has been assigned a competition (armband) number. A new entry, along with accompanying entry fees and listing fees (if applicable), will be accepted by the Show Secretary up to ONE hour PRIOR to the opening of the show (see section 3.32, 3.51 & 8.5.4)

8.9.3 – When one or more all-breed and/or Specialty shows are held on the same day, in the same venue, the request for moving class dogs to specials MUST be made a minimum of one hour prior to the scheduled start of the all-breed or Specialty show.

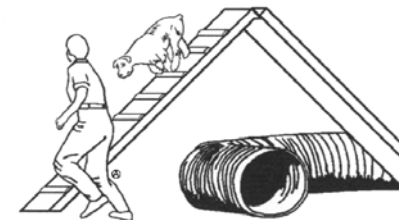

MS LESLEY HILTZ

I started in the sport of Pure Bred dogs in Australia in 1967, with the purchase of a beagle. This dog whilst not a great beagle was a great show dog, and was responsible for involving me in the sport. I subsequently purchased another beagle of better type and successfully showed him for a couple of years, before returning him to his breeder, as I was going to England on a working holiday for 2 years.

During my stay in England I purchased 2 beagles and showed them all over Britain in the 2 years I lived there it was during my stay in England and my association with Thelma Gray that I became involved with corgis, particularly Cardigan Corgis. When I returned to Australia in 1972, I took 2 beagles with me and a Cardigan corgi, followed shortly afterwards.

In 1995 my husband took early retirement and so we moved (with all our dogs) to Australia for 2 years. We took seven beagles and the first 2 American whippets to go to Australia. These 2 whippets changed the face of the breed in Australia (along with subsequent American imports by other people). We showed and bred both whippets and beagles with great success during this period and I also took the opportunity to show my husband many parts of Australia.

In 1997 we returned to the USA, and settled in SW Washington State (we had lived in Michigan before). We still breed and show Beagles. Over the years we have consistently produced Group and Specialty winning Beagles. And always have hopes of another star sitting in the whelping box.

My judging career started in Australia where I was approved to judge the Hound group in 1974 and the Toy Hound group in 1979. Since moving to the USA I continued to study and have now been approved the AKC to judge the Hound, Herding, Non Sporting and Toy groups as well as 9 working breeds.

I have been privileged to judge Beagle Specialties in Australia, Sweden, Denmark, Norway, Germany, Mexico, Philippines and the Czech Republic, as well as the US. I have judged the National Specialties for both Beagles and Basenji in the US along with regional specialties in many other breeds (miniature Pinchers, Papillons, Boston Terriers, Poodles, and several other clubs) I have judged Papillion's & Newfoundland Specialties in Denmark. I have judged at All breeds shows in Australia, England, Denmark, Norway, Italy, Taiwan & Sweden as well as the US & Canada.

JUDGE'S BIOS' (cont'd)

MR PIERRE LALONDE

I've had dogs all my life. I took my first obedience class in my late teens & was hooked. I joined a local dog club & the CKC in my early twenties & never looked back. As my obedience training experience grew, I volunteered to help the local instructor & soon was assisting, with hopes of becoming an obedience judge one day. That goal became a reality in 1995. Since then, I have had the opportunity to judge all across Canada & in Bermuda. My judging responsibilities are shared between agility, obedience & rally-obedience with the CKC & the AAC. I was involved from the beginning of the agility for the CKC & until recently, was also course approver. I still perform this duty with the AAC. I've had the honour of judging the AAC Nationals championship five times, several AAC Regional's and several obedience specialties for breed clubs.

I acquired my first Shetland Sheepdog in 1985 & bred Shelties for 10 years. When I moved from the city to the country, I purchased my first Belgian Shepherd dog in 1991.

The achievements with my dogs include an OTCH and the First National Agility Trial Champion in Canada with my first Sheltie, Phoenix. I also have a variety of titles in obedience, (CD, CDX) and in agility, (ADC, AADC, MADC), along with several masters' game titles. I still compete occasionally in obedience & agility handling my own dogs and some times my wife's shelties.

When I'm not out judging, training my dogs or giving classes, I spend my week days working as a kitchen designer for McDiarmid Lumber in Winnipeg. My 20 plus years of experience as a licensed carpenter, specializing in the finishing aspect of construction, have been a big asset for my cross over to the non-labour part of the trade.

MS JANICE LEACH

I have had GSDs since 1977, exhibiting in conformation, obedience, rally and occasionally agility and tracking.

Bred 3 litters producing 3 Champions and a breeder, owner handled BIS bitch. My dogs have achieved 4 UD's, a multi HIT MOTCh who was #2 GSD in Canada 2005.

Transition Obedience Classes

PRE-NOVICE - This class shall be for all purebred dogs and those breeds as designated on the list of miscellaneous breeds and of either sex, which have not earned the title of P.C.D. (Pre-Companion Dog) in Canada. Dogs being entered in this class may be handled or exhibited by the owner or any other person. A person may enter more than one dog in this class and must have an additional handler for each dog when they are judged together on the Group exercise. A dog may be entered in the Pre-Novice that has not earned the title of C.D. in Canada or a comparable title in any other country. The Pre-Novice class is an elective class and earning a title is not a requirement to advance to the Novice Classes.

NOVICE "C" - This class is open to any dog of either sex that has gained the title Companion Dog, Companion Dog Excellent, Utility Dog or any other advanced Obedience title in Canada prior to the closing date of the trial in which it is to be entered. Exhibitors may enter more than one dog in this class but must have a separate handler for each dog in the Long Sit and the Long Down Exercises when they are judged in the same group. The Novice 'C' exercises will be performed and judged as described in the official Novice Class except that exhibitors may compete in the Novice 'C' Class indefinitely. Scores earned by dogs entered in the Novice 'C' Class are not eligible for High In Trial. The P.C.D. and C.D.I. and Novice 'C' are elective classes which are offered for those people who feel the dog requires ring experience and acclimation to the trial situation or would like to earn additional titles. Dogs may be entered in the Novice – Intermediate (C.D.I.) and/or Novice 'C' class in addition to any of the Official Classes or Unofficial Classes.

NOVICE INTERMEDIATE CLASS - This class shall be for all purebred dogs and those breeds as designated on the list of miscellaneous breeds and of either sex, which have earned the title of (C.D.) Companion Dog, Companion Dog Excellent, Utility Dog or any other advanced Obedience title in Canada. A dog eligible for entry in the Open A or B Class at any obedience trial held under these rules is also eligible for entry in the Novice 'C' and Novice Intermediate Class at the same trial. The Novice Intermediate class (C.D.I.) is an elective class and earning a title is not a requirement to advance to a Companion Dog Excellent title. Scores earned by dogs competing in this class are not eligible for High In Trial. Dogs are eligible to compete in this class indefinitely. Dogs in this class may be handled or exhibited by the owner or any other person. A person may enter more than one dog in this class.

MRS ROSEMARY SHOREMAN

Rosemary Shoreman is an All-Breed Judge. Mrs. Shoreman has judged extensively in Canada, the United States and around the world, including Venezuela, Australia, New Zealand, Malaysia, Colombia, South Africa, Argentina and China. Rosemary has judged at prestigious shows such as Palm Springs, Hatboro, Greenwich in the United States and Royal Shows (Australia).

She has judged regional and national breed specialties, including futurities, in Canada, the U.S. and Australia for Weimaraners. She has also judge the national breed specialty for the Irish Red and White Setters in Canada as well as regional specialties for Irish Setters, Gordon Setters and Nova Scotia Duck Tolling Retrievers.

Rosemary Shoreman, with her husband Michael, originally bred Weimaraners and they are now successfully breeding and exhibiting Border Terriers. They have been active breeders and exhibitors in both the show ring and performance events (field dog tests and earthdog tests) under the affix Roschel (Perm Registered) since 1970. They have bred and shown numerous Canadian and United States All-Breed Best in Show, Group and National event winning dogs over the years.

Michael Shoreman is an All-Breed Judge and Chairman of the Canadian Kennel Club. Presently retired, in his professional life Michael was Executive Vice-President of the Royal Ontario Museum, in Toronto which is Canada's largest and premier cultural institution, and one of North America's largest museums and one of the leading museums in the world. MR BRENTON T WRIGHT

I exhibited a Boxer at my first dog show in 1963 when I was a youngster. Later, competing in Junior Handling I became the top Senior Boy Handler in B.C. in 1966.

In 1967 I purchased a Bedlington Terrier and finished his Canadian and American championship myself.

I have bred Bedlingtons for several years now and am fortunate to have bred the only 2 Canadian bred Bedlingtons ever to win BIS in the U.S. Afghan Hounds and Doberman Pinschers were two other breeds I bred and I also showed a BIS winning Doberman bitch.

Dogs have been a passion all of my life.

RALLY OBEDIENCE CLASSIFICATIONS

*NO DOG MAY BE ENTERED IN BOTH NOVICE "A" & NOVICE "B" AT SAME TRIAL.
NO DOG MAY BE ENTERED IN BOTH OPEN "A" & OPEN "B" AT SAME TRIAL*

RALLY NOVICE A: Dogs competing in this class may not have won a CKC Rally Novice (R.N.) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

RALLY NOVICE B: Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.

RALLY ADVANCED A: This class shall be for dogs that have won the Rally Novice (R. N.) title but have not won the Rally Advanced (R. A.) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

RALLY ADVANCED B: This class will be for dogs that have won the Rally Novice (R.N.) title. A dog completing the Rally Advanced (R.A.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash. All dogs must enter and leave the ring on leash.

RALLY EXCELLENT A: This class shall be for dogs that have won the Rally Advanced (R. A.) title, but have not won the Rally Excellent (R. E.) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

RALLY EXCELLENT B: This class will be for dogs that have won the Rally Advanced (R.A.) title. A dog completing the Rally Excellent (R.E.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash except the Honour Exercise. All dogs must enter and leave the ring on leash.

NOVICE "B" - This class is open to all dogs that have not earned the title of "CD" in Canada. Dogs in this class may be shown by the owner or any other person. The dog does not have to be CKC or ERN Reg'd to compete in this class

OPEN "A" - This class is open to all dogs which have earned the title of "CD" IN CANADA, but have not earned the title of "CDX" in any country. **One dog ONLY may be entered in this class by any one exhibitor.** The exhibitor **MUST BE THE OWNER** or **A MEMBER OF HIS/HER IMMEDIATE FAMILY** and **MUST SHOW THE DOG IN ALL EXERCISES.** No licensed handler, trainer or any

person who has previously exhibited a dog through its "UD" title in Canada or Elsewhere shall be allowed to compete, but **MUST COMPETE IN THE OPEN "B" CLASS.** A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class

OPEN "B" - This class is open to all dogs that have earned the title of "CD" in CANADA, and may be shown by the owner or any other person. This dog **MAY ALSO COMPETE IN THE UTILITY CLASS.** A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class

UTILITY CLASS 'A' - This class is open to any dog of any recognized or listed breed which has earned the title of "CDX" but has not earned the title of U.D. Any person who has trained or exhibited a dog that has earned a M.O.T.Ch title may not handle dogs in this class. This dog must be shown by the owner or a member of their immediate families. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class. Owners may enter More than one dog in this class. The same person must handle the dog in all exercises. When a dog is wrongfully entered in this class, any score will be cancelled.

UTILITY CLASS 'B' - This class is open to any dog of any recognized or listed breed which has earned the title of "CDX" or U.D. Dogs in this class may be handled by the owner or any other person. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. No dog may be entered in both the Utility A and Utility B classes at any one trial. Prior to the start of judging, the judge will decide the order of exercises to be performed. This order will not be disclosed to exhibitors until it is posted at ringside, approx. 30 mins. Prior to the start of the class.

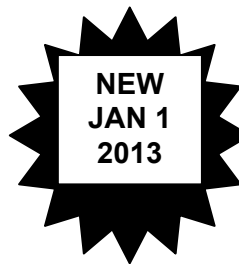

Points towards a Grand Championship cannot be gained until a dog completes its Canadian Championship. The accumulation of points began January 1, 2013. The dog must compete in the Specials Only class. Twenty points are needed for the title (the forms are available for download from the CKC website and it is the responsibility of the owner to keep track and when they reach the 20 points, submit the form to CKC who will verify the wins, and if correct will issue a certificate). In the 20 points there needs to be a minimum of 1 Best of Breed and at least 2 – 2 point wins. The scale of points is the same as for regular championships. A judge will select Best of Breed, Best of Opposite Sex, Select Dog, Select Bitch (the latter 2 will be chosen from the remaining Specials dogs competing, if any in competition). The points are based on the total number of dogs defeated

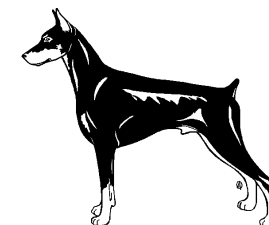

RULES GOVERNING THESE SHOWS AND TRIALS

1. THE CLUB RESERVES THE RIGHT TO REMOVE ANY PERSON FROM THE SHOW. THE SHOW SUPERINTENDENT SHALL HAVE FULL CONTROL OF THESE SHOWS AND TRIALS, WHICH WILL BE GOVERNED BY CKC RULES.
2. A DOG EXCUSED BY THE SHOW SUPERINTENDENT OR VETERINARIAN FOR ANY REASON SHALL NOT, COMPETE IN ANY CLASS FOR ANY AWARDS FOR BALANCE OF THE SHOW.
3. THE SHOW COMMITTEE WILL USE DUE CARE AND DILIGENCE FOR THE WELFARE OF DOGS AND EXHIBITORS, BUT WILL NOT BE RESPONSIBLE FOR, OR ASSUME ANY LIABILITY IN THE EVENT OF ACCIDENT OR MISFORTUNE TO EITHER DOGS, EXHIBITORS, SPECTATORS OR VENDORS.
4. DOGS MUST BE ON THE GROUNDS 1-HOUR PRIOR TO THE JUDGING OF THEIR BREED.
5. THE OWNER OF A DOG ENTERED IN THESE SHOWS IS ENTIRELY RESPONSIBLE FOR ANY ERROR IN ENTERING HIS/HER DOG REGARDLESS OF HOW OR BY WHOM ENTRY IS MADE
6. EXHIBITORS AND HANDLERS WILL BE RESPONSIBLE FOR THEIR DOGS AND EQUIPMENT LEFT AT THE SHOW GROUNDS.
7. DOGS TO BE EXERCISED IN DESIGNATED AREAS ONLY, NOT IN VICINITY OF RINGS
8. ALL RECREATIONAL UNITS WILL HAVE BUCKETS UNDERNEATH FOR THEIR SINK DRAINS. ANYONE FOUND DISCHARGING WATER ON THE GROUNDS WILL BE REMOVED BY ORDER OF THE HEALTH DEPARTMENT, AND MAY BE SUBJECT TO A FINE.
9. IF, BECAUSE OF CIVIL DISTURBANCE OR OTHER ACTS BEYOND THE CONTROL OF THE CLUB, IT IS IMPOSSIBLE TO OPEN OR COMPLETE THE SHOW, NO REFUND OF ENTRY.
10. DOGS MUST BE ON LEASH AT ALL TIMES ON THE SHOW GROUNDS OR WITHIN THE SHOW BUILDING WITH THE EXCEPTION OF THE OBEDIENCE RINGS.

ALL EXHIBITORS, HANDLERS AND PATRONS ARE EXPECTED TO KNOW AND ABIDE BY THE CKC DOG SHOW RULES.

CHAMPIONS AND CHAMPIONSHIP POINTS

SECTION #1. A dog awarded WINNERS at a Championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5), and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION #2. The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows;

DOGS COMPETING*	1	2	3 to 5	6 to 9	10 to 12	13 or more
POINTS AWARDED	0	1	2	3	4	5

*includes the dog awarded Winners

To determine the number of points earned by a dog awarded Winners, total all dogs in competition which were defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best Opposite Sex and then consult the schedule set forth above. The point system provides for additional points if a class dog awarded Best of Breed also places in the group as listed below;

A class dog awarded Best in Show at an all-breed Championship show will be credited with 5 points inclusive of any points earned at the breed or group level. In counting the number of eligible dogs in competition, a dog that is disqualified or that is dismissed, excused or ordered from the ring by the judge, **SHALL NOT** be included in the calculation for championship points (Absentees are not to be included). In order for a dog to be recognized as a Canadian Champion it must: (1) earn at least ten championship points under at least three different judges; (2) a two point win awarded either at the breed or group level; and (3) be individually registered in the records of the CKC or have a CKC Event Registration Number (ERN)
