GENERAL INFORMATION

PAYMENT: Please make all cheques or money orders payable to **2015 National Toller Specialty**. A listing fee of \$8.92 must accompany payment if the dog entered does not have an individually registered C.K.C. number or an E.R.N. number.

U.S. entrants may pay fees by money order made payable in Canadian funds or personal cheque in U.S. funds for the full amount of the fee(s). Personally discounted cheques will not be accepted. Please **DO NOT** mark cheques "Payable in Canadian Funds" or "at par" as these are not readily cleared by the banks. Tendering an NSF or post-dated cheque will be considered as non-payment of fee(s) and will subject the maker of the cheque to a \$15.00 "handling fee" and disciplinary action.(C.K.C.)

Due to the limited entry we shall be accepting entries by <u>MAIL ONLY</u>, with only **one** entry per envelope. **NO EXCEPTIONS!** Positions will be assigned on a first come first served basis - following Rule 2.2.4 - Option 2. Once the limit has been reached, all remaining entries will be assigned a position on the "Alternate List" in the order they are received. Entrants will be notified by phone or email that their entry has been received and accepted for the primary test or alternately the position number as an alternate. Entry fees will be returned within 10 days of the day of the test to Alternates who did not participate in the test.

MEETING PLACE AND DRAW: Rendezvous is scheduled for 6:00 a.m. at the Campbell River Store, 790 - 176th Street, Surrey, B.C. (corner of 176th Street and 8th Avenue), where the draw for tracks will take place. Any primary entrant(s) who is absent at this time will forfeit their position to the first Alternate present.

BITCHES IN SEASON may compete, however, they will run last. Please advise the Test Secretary upon arrival.

AWARDS & NO-HOST LUNCHEON: A no-host luncheon will be held following the tracking test at which time the Judge will present ribbons and keepsake trophies to all the successful teams.

REFUNDS: When an entered dog is withdrawn after the closing date, refunds will **only** be permitted when the vacancy is accepted by an "Alternate". If a position becomes available, Alternates will be contacted in catalogue order and asked to either accept or decline the position. (ie. if #1 declines #2 will be contacted, etc.)

RULE 14.7: It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Effective January 1, 2011 Non-Member Participation Fee

- A non-member participation fee will be charged to a resident of Canada who is a non-member of CKC.
- * The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- * In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- * All Premium lists will carry a note stating the fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.
