## FAX ENTRIES (450) 825-0894 VISA / MASTERCARD / AMERICAN EXPRESS

There will be a surcharge of 20% for all entries sent by Fax. Your Credit Card number plus the expiry date must accompany your entry. Cardholder's name and address must also be included on each entry. All entries with a credit card number will be treated as a faxed entry and charge the fax fee. A fee of \$25.00 will be levied on all Declined Credit Cards & NSF Cheques.

#### ATTENTION FOREIGN EXHIBITORS

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank You.".

#### NON-MEMBER PARTICIPATION FEE

- An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members."

Non-residents of Canada please note that discounted cheques or money orders will not be accepted due to fluctuating currency rates.



#### **GENERAL INFORMATION**

- 1. The Club and Diana Edwards Show Services will not be responsible of cash sent through the mail.
- Returned cheques do not constitute a valid entry fee. A collection fee of \$25.00 will be added by Diana Edwards Show Services in addition to any bank charges for each returned cheque.
- 3. There is no refund for duplicate entries. Every effort will be made to find all duplicate entries, however if the entry has been processed and appears in the official catalogue, no refund will be made.
- Entry fees shall not be refunded in the event that the dog is absent, excused by a Veterinarian or Judge, disqualified or barred from competition by action of the bench Committee.
- If because of riot, civil disturbance or acts of God, it is impossible to open or complete the show, no refund of entries shall be made.
- Exhibitors must abide by errors made in entering their dogs, regardless of how or by whom the entries were made. Change or cancellation of any entry after closing time is prohibited.
- 7. The Club reserves the right to refuse any entry subject to CKC rules.
- Dogs may arrive any time prior to their scheduled time of Judging. Dogs not required for further judging will
  be excused. Judges will not wait for any dog holding up a class. Owners/Agents are responsible to have
  their dogs present when their classes are called to be judged.
- Exhibitors are requested to keep their grooming and crating areas clean and tidy. If space is at a premium, exhibitors must remove exercise pens if requested by the Show Superintendent.
- 10. It shall be the duty and obligation of the show giving club to ensure that a judge is not subject to indignities. The Conformation Show Committee shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to such action as it deems fit on receipt of a report indicating that this has occurred.
- 11. The OBA will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for or assume liability in the event of accident, or other misfortunes to dogs, exhibitors or patrons
- 12. The Show Superintendent will be in complete charge of the show, which will be governed by CKC rules.

#### **BUILDING INFORMATION**

- The building will open Thursday at 2 PM, and will closed every night at 10 PM.
- All four rings will be in the main building, with a limited holding area available.
- Grooming area will be the complete second building.
- No private exercise pens will be allowed after the opening of the show.
- There is limited electrical hook-ups for RV's available on a first come first served basis at \$25 for the weekend. There are no water hook-ups.
- Improved ring access will be provided.

#### CLASSES

Junior Puppy	A dog between 6 mths & 9 mths on the day of the show.
Senior Puppy	A dog between 9 mths & 12 mths on the day of the show.
12 - 18 Months	A dog between 12 mths & 18 mths on the day of the show.
Canadian Bred	A dog which is born in Canada
Bred by Exhibitor	The handler of the dog is also the breeder and owner.
Open Class	All dogs.
Specials Only	Dogs who are Canadian Champions only.

#### CHAMPIONS & CHAMPIONSHIP POINTS

<u>SECTION 1:</u> A dog awarded WINNERS at a championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION 2: The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

Dogs Competing:	1	2	3-5	6 -9	10-12	13 or more
POINTS ALLOCATED*	0	1	2	3	4	5

<sup>\*</sup>Includes the dog awarded WINNERS

To determine the numbers of championship points earned by a dog awarded WINNERS total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. The new system provides for additional points (provided that the dog has defeated another as listed hereunder: BREEDS COMPETING AT GROUP LEVEL:

A class dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five points at any single show.
