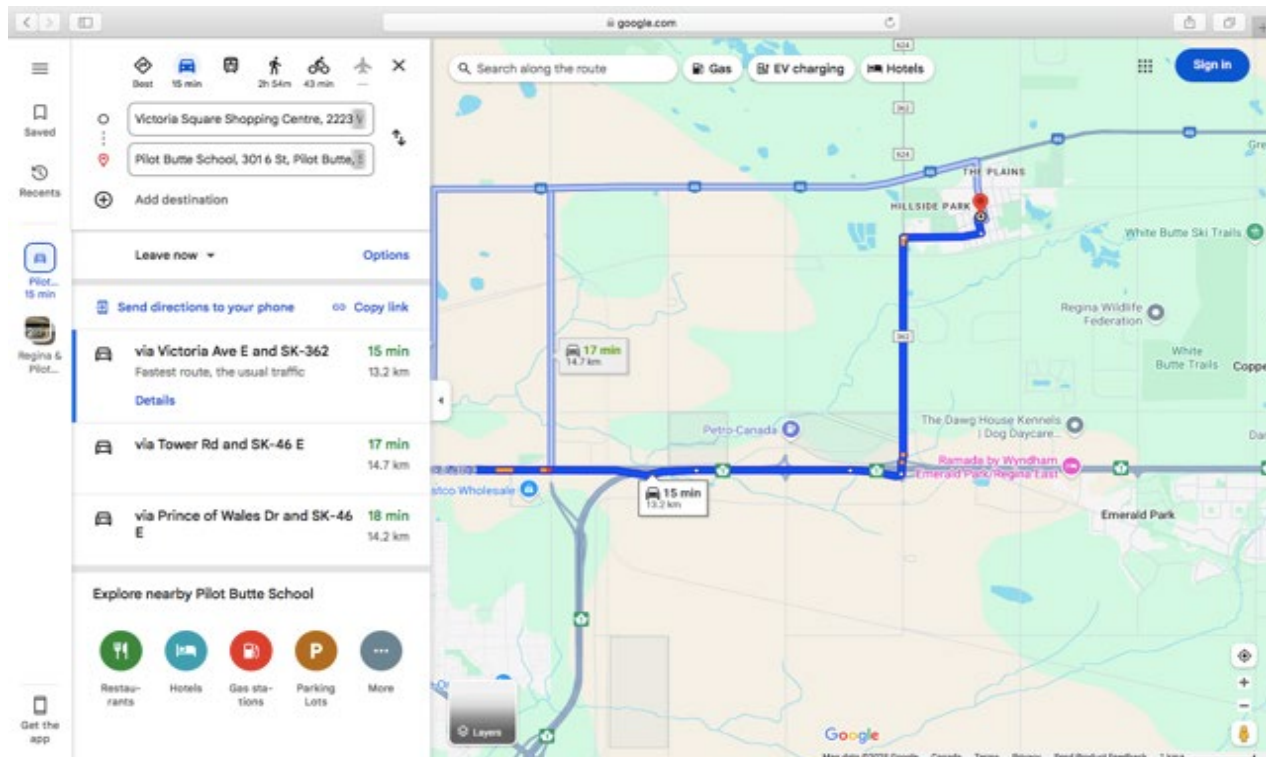
There is an off-leash dog park in Emerald Park adjacent to the RM of Edenwold Municipal Building on the corner of South Plains Road and Hutchence Road.

The Sleep Inn, 22 Great Plains Road, Emerald Park, is a pet friendly hotel and is close to the dog park, Tim Horton's, Shopper's Drug Mart and IGA, plus restaurants. It is a 10 minute drive to Pilot Butte Elementary.
