## DIRECTIONS FROM SWARTZ BAY FERRY TERMINAL

Head South on HWY 17 Towards Victoria for approx 11 kms then turn right at Mt Newton Cross Rd (traffic lights). Turn left at Wallace Drive (4 way stop). Turn right on Stellys X Rd & Saanich Fairgrounds will be on your right.

#### **DIRECTIONS FROM NANAIMO**

HEAD SOUTH ON HWY 1 TOWARDS VICTORIA & TURN LEFT ONTO MCKENZIE TO HWY 17 HEADING NORTH TOWARDS THE SWARTZ BAY FERRY TERMINAL. AT APPROX 15 kms, TURN LEFT AT MT NEWTON CROSS RD (TRAFFIC LIGHTS). TURN LEFT AT WALLACE DRIVE (4 WAY STOP). TURN RIGHT ON STELLYS X RD & SAANICH FAIRGROUNDS WILL BE ON YOUR RIGHT.

#### PARKING

PLEASE ENTER VIA "GATE 6" AT THE FAR END OF THE FIELDS. PARKING DIRECTLY ADJACENT TO THE RCMP BARN WILL BE RESERVED FOR JUDGES, STEWARDS AND TRIAL OFFICIALS, HOWEVER, THERE WILL BE SPACES ALLOTED FOR CRATE DROP OFF.


