USA Exhibitors To ensure your entry is not returned due to difficulties, we encourage you to use the services of The Entry Line to facilitate correct foreign currency transactions for the applicable entry fees.

NSF Cheques: Tendering of a dishonoured payment instrument for entry fees shall be considered non-payment of entry fees, and is an offence punishable by disciplinary action and cancellation of awards (6.3.3 of the Obedience Trial Rules & Regulations) In addition, a \$40.00 service charge will be levied by the Club.

LIMITED ENTRY means entries will be accepted until the Judge's assignment would exceed 7 hours of judging as calculated in accordance with CKC rules, and will close on the listed closing date.

'When the advertised limit has been reached, all remaining entries may be assigned a position on the reserve list. The person making the entry shall be notified of his position on the list. In the event that any entry is withdrawn after the closing date, it may be substituted with one from the reserve list up to 24 hours prior to the trial. Fees will not be refunded for any reason other than a bitch being in season (with veterinary certificate) and to those on the reserve list who did not participate in the trial.'

DAY-OF-TRIAL Entries: If time permits, Day of Trial entry may be available for the Second Trial *only* on each event day. Completed entry forms with full payment in accordance with the fee schedule must be submitted, in person, to the Trial Secretary by the owner or handler *at least sixty* (60) minutes before the start of the Second Trial.

CHANGE OF ENTRY: The entry of a dog in any trial may be changed to another class for which they are eligible within the same trial. The change must be submitted to the Trial Secretary in writing *at least* thirty (30) minutes before the start of the trial.

TCN – Temporary Competition Numbers

If a dog is not registered individually in the records of the CKC, it may be entered at a trial held under these rules with a Temporary Competition Number (TCN), providing that the number is obtained before the closing date of entries. Once the dog is permanently registered or has an ERN, the TCN will no longer be valid. TCN's can be obtained online through the CKC Member Portal. Exhibitors may also obtain a TCN by completing a printed application and submitting it to the CKC by mail, or by contacting the Shows and Trials Division at 1-855-364-7252.

Electronic Communication

All entry confirmations, Judge Schedule and any other notices will be sent from the Secretary@thepoodlefarm.com to the Handler or Owner as indicated on the Official Entry Form. CKC REGULATION 20.7:

The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

GENERAL INFORMATION

- 1. The **trial precincts** shall be the non-residential buildings and surrounding grounds of The Poodle Farm. In accordance with CKC rules only dogs entered in the official classes, including Exhibition Only, are permitted within the precincts of the trial.
- 2. The Poodle Club of Canada and The Poodle Farm will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
- 3. **BITCHES IN SEASON** are not permitted to compete. When a bitch comes into season after entries close a Veterinarian's certificate, certifying that the bitch was in season within ten days of the trial, must be received by the Trial Secretary on or before the day of the trial, prior to the judging of the class, and the club will refund the entry fees.
- 4. **Mix Breeds and Unrecognized Breeds** must have a Canine Companion Number (CCN) from the CKC to enter the trials. A dog eligible for a CCN may not be entered as a listed dog. Visit www.ckc.ca for more information.
- 5. If, because of riot, civil disturbance, or other acts beyond the control of management, it is impossible to open or complete the trials, no refund of Entry Fees will be made.
- 6. Per CKC rule 6.7.3 "There shall be no intensive or abusive training of dogs within the *venue* of the trail", the "*venue*" being the entirety of The Poodle Farm property.
- 7. Flexi-leads may not be used on The Poodle Farm property
