ENTRY ELIGIBILITY

- 1. Dogs must be permanently registered with UKC, or have a Temporary Listing (TL) number in order to enter. No exceptions will be made. Entries for ineligible dogs will be returned.
- 2. Dogs must be 6 months of age on the day of the event.
- 3. An unentered dog may not be substituted for an entered dog.
- 4. Temporary Listings are not available at the event.

ENTRIES

1. **Pre-Entries:** Licensed Classes: \$25.00 per entry, KSH members: \$22.00 per entry. CASH or CHEQUE ONLY.

Entries must be received by event staff before May 10th, 2020.

Entries received after this date will be charged Day of Show Price – NO EXCEPTIONS.

Day of show entries: \$28.00 per entry, KSH members \$25.00. CASH or CHEQUE ONLY.

SUBMITTING ENTRIES

- 1. Entries must be submitted on the current Official UKC Nosework Entry Form. Downloaded copies or photocopies of these forms may be used as well. Please be aware that the entry form has changed, please do not use an old version.
- 2. Entries received incomplete will not be accepted.
- 3. Pre-entries may be mailed, scanned and emailed, or hand-delivered to the Event Secretary.

4. **Mailed Entries** must include the entire form and be signed. Mailed entries received without fees shall not be accepted.

*By submitting an entry into a vehicle trial, the expectation is that your vehicle is available to be used during that trial.

Alternate indoor crating areas will be made available for competitors whose vehicles are chosen for the duration of the individual trial.*

PAYMENT

1. Payment may be made by cash or cheque.

Fees must be in Canadian funds. No entry will be accepted without payment.

U.S. competitors, please note that we are only able to accept payment via PayPal. Please contact the club for more information.

- 2. Make cheques payable to "Kootenay Scent Hounds".
- 3. Returned cheques do not constitute valid entry fees.

REFUNDS

- 1. Refund of entry fees will not be made for entries cancelled after the Pre-Entry deadline except in cases of extenuating circumstances which are approved by two members of the Kootenay Scent Hounds' Board of Directors on an individual basis.
- 2. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by Judge, or barred from competition by action of Event Committee.
- 3. If, because of riots, civil disturbances, or other acts beyond the control of the host organization it is impossible to open or to complete a show or trial, no refund of entry fee will be made.
- 4. Every effort will be made to find all duplicate entries before processing. If a duplicate entry is processed, however, no refund will be made.
- 5. If, in the opinion of the host club, the wellbeing of dogs, exhibitors or spectators is at risk due to extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, or extreme heat, the host club may cancel or stop a show or trial before completion. No refunds will be made in such cases.

Site Information: There will not be indoor crating space available. Dogs must be crated in vehicles. Owners are expected to pick up after their dogs. Please be prepared for hot weather (shade cloths, fans etc.), there is limited shade at either site.

Food will not be available on site, restaurants and grocery stores are within a 5 min drive at both locations.

Driving Directions:

Saturday: From both Nelson and Castlegar: at the junction of Highway 3A and Highway 6, turn north onto Highway 6 (towards Slocan, and Nakusp). Turn onto your second right (you will see a

fenced parking lot with school buses). If you reach the Evergreen Coop and Esso, then you've missed the turn.

Sunday: From Castlegar, stay on Columbia Ave and head north, you will cross the Castlegar-Robson Bridge, turn left onto Broadwater Road, and right onto Relkoff Road. From Nelson, take the exit directing you to Robson and Syringa Provincial Park, turn right onto Broadwater Road, and right onto Relkoff Road.

Hotel Information: Several pet friendly hotels/motels are located within Castlegar, as well as within Nelson. Castlegar options include the Quality Inn, Sandman Hotel, Super 8 Hotel, Fireside Inn, Flamingo Motel, Cozy Pines Motel, and Twin Rivers Motel. In Nelson, pet-friendly options include the Mountain Hound Inn, Alpine Inn and Suites, Best Western, and the Hume Hotel.

Liability: Neither KSH, L2P, nor the United Kennel Club, Inc. is responsible for the theft, loss, accident or injury to any dog, person or property at any of their events. Absolutely no alcoholic beverages or drugs are allowed. Aggressive behaviour by dogs shall not be tolerated at UKC events. Due to space limitations, only dogs entered will be allowed on the show grounds.

Awards to be Presented:

Kootenay Scent Hounds will award a qualifying ribbon for each element leg earned, ribbons for placements from 1st to 4th, and rosettes for Nosework Element titles and Nosework titles completed.

Move-Up Policy:

Participants may move up to the next level provided that the level is offered at this event. A completed Class Change form must accompany the request and the request is to be made while DOS entries are being accepted.
