Show Site**

From Toronto (via QEW):

Continue west on Queen Elizabeth Way (QEW) and merge onto Hwy. 403 West. Follow signs for Hamilton/Brantford. Exit onto Hwy. 6 South toward Caledonia/Port Dover. Stay on Hwy. 6 until Argyle Street North. Turn left onto Caithness Street east (Hwy. 54). Show site is on the right.

From Toronto (via 401 and no toll roads):

Heading west on Hwy. 401, merge onto Hwy. 403 (follow signs for QEW via Hwy. 403/Hamilton). Continue on Hwy. 403 (follow signs for Hamilton/Brantford). Exit onto Hwy. 6 toward Caledonia/Port Dover. Stay on Hwy. 6 until Argyle Street North. Turn left onto Caithness Street east (Hwy. 54). Show site is on the right.

From London/Brantford:

Continue east on Hwy. 401 toward Exit 189. Keep right onto Hwy. 403 (follow signs for Hamilton/Niagara Falls/Brantford). Take exit 41 for Garden Avenue toward Cainsville. Turn right onto Garden Ave (signs for Garden Avenue S/Cainsville). Continue onto Brant County Road for approx. 2.5 km. Turn left onto Hwy 54 (signs for County Road 54 E/ Cayuga/Caledonia). Show site will be on the right
