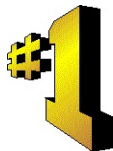


BRED BY EXHIBITOR - BEST IN SHOW

GENERAL SHOW INFORMATION

1. The Show Superintendent will be in charge of the show which will be governed by the rules of the Canadian Kennel Club (CKC).
2. Wine Country Kennel Club, its officers & associates will use due care & diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident, or misfortune, to either dogs, exhibitors or patrons. If because of riots, civil disturbances, or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry fees will be made.
3. The Exhibitor is responsible for knowing and complying with the conformation Show rules and Regulations of the CKC. Chapter 4 Section 4.1.3 A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out.
4. Show grounds will be opened at 3 p.m. Thursday. No one will be allowed on the grounds before that time. RV's must be parked in designated RV area. All RV's and exhibitors must leave the grounds by 10 p.m. on Monday.
5. Show precincts shall consist of all judging areas set aside for the show officials, judges, exhibitors and handlers, and thirty fee (30') from the outside of the rings.
6. Groups 4, 5 & 6 will be judged indoors. Groups 1, 2, 3 & 7 may be indoors or outdoors, depending on scheduling. No provision will be made for inclement weather.
7. Best In Show may be judged indoors or outdoors. To be determined each day by the superintendent.
8. Judging will not commence prior to 8 a.m. It is the responsibility of the exhibitor to have the dog in the ring when the dog's class is scheduled for judging.
9. There is limited space available for indoor grooming, in a separate building, on a first come basis. The building will be open from 7 a.m. to 10 p.m. daily. All dogs left in building or on the grounds overnight are left at owners risk.
10. There is ample room on the grounds for outdoor grooming.
11. No grooming or crates will be allowed under the canopies outdoors, or in the show building.
12. All exhibitors must clean up after their own dog(s) on the show grounds.
13. *U.S. Exhibitors* - For your convenience U.S. cheques and money orders will be accepted. All money issued on a U.S. funds account are payable in the U.S. funds amount noted. Any funds issued on a Canadian fund account shall be paid in the Canadian funds amount noted. U.S. entries can be sent to the U.S. postal address. U.S. money accepted at the show will be AT PAR.

CONFORMATION SHOW RULES & REGULATIONS

The exhibitor is responsible for knowing & complying with CKC Rules and Regulations. A judge officiating at a show or trial held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the shows and trials to see that this Rule is effectively carried out.

NON CKC MEMBER PARTICIPATION FEE

Effective Jan. 1, 2011, an annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will be \$58.50 plus applicable taxes. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

CHAMPIONSHIP AND CHAMPIONSHIP POINTS

Chapter 15, Section 15.1.1 A dog awarded WINNERS at a championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded Winners shall be as provided hereunder.

Section 15.1.2 The schedule to be employed in the determination of the number of points awarded WINNERS shall be as follows:

Dogs competing*	1	2	3 to 5	6 to 9	10 to 12	13 or more
Points allocated	0	1	2	3	4	5

* Includes the dog awarded Winners.

To determine the number of championship points earned by a dog awarded Winners, total all dogs in competition which the dog defeated, directly or indirectly, for the highest of the official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above.

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge **shall** be included in the calculation for championship points.

Section 15.1.8 A dog awarded Winners which also places in the regular Group competition shall be credited with the following additional points, provided that a dog was defeated at the Group level. No more than 5 points will be credited to a dog for a single show.

Section 15.1.9 A dog may not be credited with more than 5 championship points in a single show.

Section 15.1.11 A class dog awarded Best In Show at an All Breed Championship Show will be credited with 5 points inclusive of any points earned at the breed or group level.

Section 15.1.12 In order for a dog to be recognized as a Champion and it's owner provided with a Championship Certificate, the dog must have earned at least one 2 point win either at the breed level or group level.

MOVING A DOG TO SPECIALS

Chapter 8, Section 8.9: A dog which is individually registered in the records of the CKC and has completed the requirements for a Championship, after the closing date for entries for a show may be transferred from one of the Regular Classes to "Specials Only", providing the request for a transfer is submitted to the Show Secretary in WRITING one hour prior to opening of the show, by the owner or handler. Every day of a 2, 3 or 4 day show is a separate show.

NOTE: This rule is effective up to one hour prior to the Show, not one hour prior to judging.

EVENT REGISTRATION NUMBER (ERN)

Effective Jan. 1/92, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering a CKC event, will no longer require a CKC registration number, but will require an ERN number. The ERN number must be applied for within 30 days of the first day of entering a CKC event. Fee is \$58.50 per dog. For further information contact the CKC. www.ckc.ca
