

Dogs will be run in height order. Dogs being handled by the same person must be separated into different staged groups.

Judge of Record and Event Official dogs may be judged prior to Event start or as the first dogs of the Event.

Move-ups

Forms will be available at the Secretary's table. Previous trial move-ups must be submitted no later than 9:00 pm MDT March 23, 2020, via email to the Trial Secretary. Same day move-ups must be submitted no later than 30 minutes prior to the start of the trial you choose to move-up in. Next day move-ups must be submitted to the Trial Secretary no later than 30 minutes after the finish of afternoon trials.

All competitors will have to have a valid BHA registration number prior to submitting their entry form.

Day of Show Entries will be received during check-in each day.

Day of Show entries are not a guaranteed entry and will be accepted only up to Judging limits.

Confirmations will not be sent for Day of Show entries.

Awards

Qualifying ribbons will be awarded for all qualifiers in all classes, including Instinct. Placement ribbons will be awarded for 1st through 4th in each height division for all classes except Instinct. New title ribbons and High in Class ribbons will also be awarded. Ribbon tabs will be provided for all new titles. B Classes will receive 1st through 4th, with one HIC for all height divisions combined. A special prize will be awarded to those who earn a RATCH. Additional awards may be given at the discretion of the Trial Officials.

Exhibitor Information

Prairie Dog Sports Inc. reserves the right to refuse any entry Trial facility/grounds is defined as Prairie Dog Sports Inc. located at 27123 Hwy 597, #43 Bays 1-3 Millenium Centre, Blackfalds, AB T0M 0J0.

Facility is handicapped/wheelchair accessible.

Facility is 8,600+ sqft heated space with rubber matting over cement floor.

Rings are indoor with rubber matting and enclosed with 4' X 8' lattice panels.

Indoor Blind is a 10'X10' tent with chairs located a minimum of 10' away from the rings

You **MUST** park where directed.

Note: Gerbils are used in place of rats in Alberta.

It is expressly understood that participants alone are responsible for the behavior of their dogs. Any participant whose dog(s) create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the event site. In such case, no refund of any fees paid will be made. Prairie Dog Sports Inc. and all persons associated with running this event will assume no responsibilities for any loss damage or injury sustained by participants or spectators, or to any of their dog's or property.

- **Barn Hunt Registration Number and Barn Hunt Rules and Regulations may be obtained on the website, www.barnhunt.com.**
- **Entries made without fees or signature and a completed Waiver and Indemnity Form will not be accepted.**
- If you provide your email address, we will acknowledge receipt of your entry via email within a few days. If you do not receive an initial confirmation within one week of submitting your entry, contact the Trial Secretary. Any errors must be reported to the Trial Secretary prior to the commencement of the trial.
- All dogs must be on a short leash (6') and under control at all times, while on trial grounds, except when in the ring for judging. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale collars are allowed. Single piece slip collars/leads are allowed. Harnesses, with the exception of head-halter types, are allowed.

- Dog **must** run "naked," without a collar/harness. *The actual course area will be securely enclosed.* **No flexi-leads or head halters allowed within the facility.** Per BHA rules, electronic collars/devices are not allowed anywhere on the site – this includes electronic bark collars. Prong collars may be used on the site while walking dogs but are not allowed while the dog is competing.
- Bitches in season may compete. They will run at the end of each class. They **must** wear "pants" at all times when not being pottied, **including on the course. Owners of bitches in season should confine their dog(s) away from the trial area and other dogs, post "dog in season" signs in their area, and potty their dog(s) away from other competitors.** Owners should make their condition known to the Trial Secretary **prior to the start of the trials** and inform all exhibitors **at the judge's briefing.**
- The judge need not wait for any dog holding up a class because the exhibitor is not ready. It is the exhibitor's responsibility to be ready for their runs. **The Club has no obligation or responsibility for calling or locating dogs that are not brought to the ring when required.**
- There may be a short lunch break at the Trial Officials' discretion.
- **BHA rules and common courtesy:** Exhibitors are responsible to clean up after their dogs. Dispose of waste in appropriate containers provided around the facility.
- Possessing or training with personal, live quarry is not permitted on trial grounds at any time. Food and toys are **not** permitted in the ring. Squeaky toys are **not** permitted in the facility.
- These trials are held indoors. There will be crating space for entered dogs only. No ex-pens allowed in the building. Please observe marked crating locations. **Mats are required under crates.**
- **There is NO SMOKING/VAPING in this facility.** If you must smoke/vape please do so **inside your vehicle** and dispose of the butts in the vehicle. Anyone found smoking around the facility will be asked to leave the event site. In such case, no refund of any fees paid will be made.

- Competitors who withdraw any or all entries from a Fun Test, Trial or Trials after the closing date are not eligible for refund.
- Withdrawals after the closing date due to injury of the dog will be eligible for a 75% refund of entry fees paid minus any non-refundable credit card/PayPal transaction fees, if applicable, upon receipt of a note from your veterinarian. The note must be dated and emailed or mailed to the Trial Secretary prior to the close of the trial on Sunday afternoon. Priority mail is not necessary. Facility Rules & Conduct



Prairie Dog Sports Inc. reserves the right to refuse any entry.

No nose to nose contact with other dogs. You are here to work and engage with your dog.

If a dog is handled in an aggressive or inappropriate manner a warning may be issued or the team may be asked to leave without refund(s).

All dogs must be crated safely and securely when not working. Please bring a crate for your dog(s), if you do not have one you may rent one for a \$15 fee.

Acceptable crates include those that have a solid frame once together to keep the crate stationary, i.e. soft crate, wire crate.

Not acceptable crates include x-pens and those that do not have a solid frame once together to keep the crate stationary, i.e. pop-ups.

You may crate your dog from your vehicle, weather permitting.

Please show courtesy to all participants. Manage loud or disruptive dogs. Treat every dog as if they were reactive or spatially challenged. Remain aware of what your dog is doing at all times. Every dog and participant deserve to have a pleasant experience.

Dogs must be kept on a 6' or shorter leash at all times, Flexi leashes and long lines are not allowed on site.

Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale collars are allowed. Single piece slip collars/leads are allowed. Harnesses are allowed. Electronic collars/devices are NOT allowed anywhere on site – this includes electronic bark collars. Prong or pinch collars may be used on site while walking dog, but the collar must be removed before the dog/handler proceeds to work.

Potty your dog at least 30' away from any entrance/exit. It is preferred you potty on the grass area at the front of the building. DO NOT potty your dog on the building, vehicles, garbage cans, pylons or anything not natural.

You are responsible for picking up after your dog(s). Failure to comply will result in dismissal and/or a one-year ban from events and no refund(s) will be issued.

Females in season are permitted at BHA approved events. Females in season must potty and crate in designated area and wear panties when working.

Please bring your own water, water dish and poop bags for your dog.
