We will accept day of trial entries if not full. Day of trial entries must be submitted at least 1 hour before the start of the trial. We will accept entries for a second dog in the same class with the same handler.  
Entries are considered accepted when full payment is received.

**Youth between 10 years old and 16 years old must have a legal guardian present at all times.  
Children under 10 years old are not permitted to handle a dog at any time while on the trial premises.**

Permission has been granted by the Canadian Kennel Club for holding these events under the Rules and Regulations of the CKC, Rules and Regulations of the Canadian Kennel Club. No entries will be accepted, altered, canceled, or substituted after the official closing date and time, for entries, except for as provided in the rules.

\*\* It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.

If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to start or to complete this event, no refund of entry will be made.

CKC has a Non-Member Participation Fee of \$170.00 + HST. This fee only applies to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

These events are open to mixed and unrecognized breeds. In order to compete, mixed and unrecognized breed dogs must have a Canine Companion Number (CCN) from the Canadian Kennel Club and must have a CKC-approved microchip. Mixed-breed dogs must be spayed or neutered. Unrecognized-breed dogs do not need to be spayed or neutered. A dog eligible for a CCN may not be entered as a listed dog. If a dog is not registered individually in the CKC studbook it may be entered as a listed dog per CKC rules for this designation, as of July 1, 2018; exhibitors must apply to the CKC for "Temporary competition number (TCN), before event closing date".

As of January 1, 2020, as per CKC regulations if a dog is injured after entry has been submitted to the Trial Secretary, a veterinarian's certificate, certifying the dog was injured before a 3-day period preceding the trial, must reach the Trial Secretary on or before the start of the trial. The club will refund the entry minus the TCN fee and a 30% administration fee.

Effective January 1, 1992, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Event Registration Number (ERN). This ERN does not register a dog for breeding purposes as defined in the Animal Pedigree Act, but rather enables a foreign-owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number. To obtain an ERN, mail or fax a photocopy of the dog's foreign registration certificate with a cheque or VISA/MasterCard number (expiry date, cardholder's name and signature). Provide your complete address for return of the ERN to you. Cost is \$64.00 plus taxes.

### **LIABILITY AGREEMENT:**

I (we) acknowledge that Red Barn Event Centre and Simcoe Performance Dogs has the right to refuse this entry for cause, which the organizing committee shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and win ribbons, or trophies, I (we) agree to hold this club, its members, directors, officers, agents, superintendents, sponsors of the events, or trial secretary and the owner or lessee of the premises and any employees of the aforementioned parties harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the trial premises or grounds or near any entrance thereto. I (we) personally assume all responsibility and liability for any such claim and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death, or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage, injury be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this scent trial, howsoever such injuries death or damage to property may be caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

2.8 km


Continue onto Veterans Dr

## **RIBBONS AND TROPHIES:**

Ribbons and rosettes will be available.

Flat qualifying ribbons will be awarded for all passes.

New title rosettes offered at a cost of **\$10** each, including HST (please bring exact amount).

## **RULES:**

*To make everyone's visit a safe and enjoyable one, we have just a few rules*

No outdoor shoes allowed. Please bring a clean, dry pair of indoor shoes to trial in.

Please do not walk past the areas marked with caution tape and respect the pylons.

Dogs must always be on leash.

No prong collars, choke chains, or e-collars on the property. Dogs must be on a flat collar, martingale collar, or flat harness only.

Not all dogs love other dogs. Please keep your dog under control and out of other dogs' faces, even if your dog is not dog-aggressive. There is NO nose-to-nose contact.

No smoking anywhere on the trial site.

Please do your best to keep barking to a minimum.

Be kind to our judges and volunteers. Remember, if you want to be treated with respect, give others the same respect.

Garbage policy: If you bring it, you must take it home with you.

As per the CKC rules: "If anyone is found to be discussing a search before the class has ended, both parties in the discussion (speaker and listener) will be penalized with a "Not Qualified" score (NQ) for the class. Additionally, at the discretion of the Event Committee, persons discussing a search may be excused from the trial and asked to leave the trial grounds."

### **Entries:**

Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made. Alterations, substitutions, or cancellations of any entry after the closing date is prohibited, except as noted in this premium list.

### **Refunds**

There are NO CREDITS nor refunds for anyone wishing to pull their entries after the closing date. Lamé dogs will be excused. Entry fees will be refunded with a **30% processing fee** deducted, provided notice is given prior to or during roll call. If dog is not present for assessment, a note signed by a veterinarian will be required for any refund or credit consideration.

### **Foreign Exhibitors**

Personal US cheques will be accepted in US funds, but due to fluctuating currency rates they cannot be discounted. Please do not mark personal foreign cheques "Payable in Canadian Funds" or "At Par" as they will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Thank you.

### **Bitches in Season**

Bitches in season are permitted to compete. They must be run at the end of the run order for each class and must wear clean, properly fitted panties. Please notify the trial secretary as soon as possible.

### **Eligibility**

Scent participation is open to all purebred and mixed breed dogs at least 6 months of age that are individually registered with the CKC, or have an Event Registration Number (ERN) or a Temporary Competition Number (TCN), or a Performance Event Number (PEN) or are eligible for registration with the CKC and have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed, or have a Canine Companion Number (CCN) if it's a mixed breed.

### **Entry Confirmation and Judging Schedule:**

Entry confirmation will be emailed after payment is received.

A judging schedule will be sent approximately 5 days before the event date. PLEASE contact us prior to the event date if you have not received an emailed confirmation or judging schedule from us, and remember to check your junk mail folder. ## **CKC HEALTH REMINDERS:**

**No dog may be brought onto the grounds or premises of an event if it:**

1. Is known to have distemper, parvovirus, kennel cough or other communicable disease;
2. Has recovered from distemper, parvovirus, kennel cough or other communicable disease within the last 30 days (prior to the event);
3. Has been housed within 30 days prior to the event on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease.
4. Clubs do have the right to remove a dog from the event premises and the exhibitor may be subject to disciplinary action if it is found that CKC rules have been contravened.

## CKC NON-MEMBER PARTICIPATION FEE:

In 2010 the Board of Directors of the CKC passed a motion with respect to a Non-Member Tracking Fee for Canadians that participate in CKC events and are not CKC members. At the December 2010 Board of Directors meeting, the Tracking fee motion was deleted replaced with the following motion. Non-Member Participation Fee

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of the CKC. This fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either, to become a CKC member or to pay the non-member Participation fee.
- c) Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members. The Non-Member Participation Fee is effective January 9, 2025. Cost is \$170.00 + HST.
