GENERAL INFORMATION:

Eligibility to Compete - To be eligible to compete in these trials, the dog must be:

- a) Registered with the CKC or;
- b) Have an Event Registration Number (ERN) or;
- c) Have a Temporary Competition Number, and must be eligible for registration with the CKC.

The entry of a dog that is improperly entered in a class for which it is not eligible cannot be altered to another class after entries close except as outlined here:

a) Exhibitors incorrectly entered in the A class are permitted to move the dog to the corresponding B or C class up to one hour before the start of the trial. b) Exhibitors incorrectly entered in the Novice B class are permitted to move the dog to the Novice C class up to one hour before the start of the trial. c) Exhibitor entered in the Open H classes are permitted to move to the Open 18 classes and vice versa up to one hour before the start of the trial. 6.9.8 d) Exhibitors incorrectly entered in the Novice C class up to one hour before the start of the trial. 6.9.8 d) Exhibitors incorrectly entered in the Novice B class are permitted to move the dog to the Novice C class up to one hour before the start of the trial.

Bitches in season - Bitches in season are not permitted to compete under C.K.C. Rules. We will refund all entry and listing fees if a bitch comes into season after closing date, upon presentation of a veterinarian's certificate, certifying the bitch was in season within the 10-day period preceding the trials. This certificate must be delivered to or reach the Trial Secretary before the trial commences.

Rally Obedience Classes offered - All regular classes will be offered (Rally Novice A & B; Rally Intermediate; Rally Advanced A & B and Rally Excellent A & B and Master). Rally Novice Brace and Rally Novice Team Class will be offered.

Rally Obedience Prize List - Flat ribbons will be available on a table for all qualifying scores, upon exit of the ring. Rosettes for qualifying First placement for Novice A and Novice B, Intermediate, Advanced A and Advanced B and Excellent A and Excellent B, and Master level. Flat ribbons for all 2nd, 3rd & 4th placements and title ribbons will be available.

Important Notice to Rally Obedience Exhibitors - There is no limitation on the number of trials at which a dog may be entered as a 'listed dog', except that a dog which has obtained three qualifying scores at obedience trials held under C.K.C. rules, may not continue to compete at licensed obedience trials held under the Club's rules until the dog is registered individually with the C.K.C. Foreign born and owned dogs, please refer to Event Registration Number (ERN) information listed elsewhere.

Rally Obedience Trial Rules and Regulations - The Exhibitor is responsible for knowing and complying with the Rally Obedience Rules and Regulations of the Canadian Kennel Club. Section 20.7 of the Regulations states: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at an Obedience or Rally Trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indication that this has occurred.

If the entry has no CKC individual registration number, an E.R.N. or a P.E.N. is required and must appear on the entry form. A listing fee of \$11.30 per entry is also required.

CKC Non-Member Participation Fee / Non-member participation fee - An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be canceled. The Premium List must carry a note stating that "these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.
