TEST SITE: All dogs must be under control and on a leash except during the test (where off leash searches may be permitted). Neither the APWDC, nor Thiel's Greenhouse have any control over area dogs, which may be loose at or near the trial grounds. Please clean up after your dog. Exhibitors failing to do so will be dismissed from the trial.

NO non-trial odour is permitted on the trial grounds. No warm up area will be offered.

This is a greenhouse business used by customers and families in the community. Please pay attention to the directions of trial personnel so that we are not impacting the greenhouse business or customers.

The trial facility has limited wheelchair accessibility. Access to some of the test areas and the washroom facilities have stairs that during the trial will need to be used to access some search areas,

If you require accommodation of a disability, please make your accommodation known to the club well in advance. Please contact the show secretary by entry closing to determine if we can accommodate your needs.

Washroom facilities are available indoors(intermittently), but requires the use of stairs

PARTICIPANT ILLNESS: Any handler unable to attend these trials due to exhibiting COVID-19 or other serious illness symptoms after entries close must contact the trial secretary so they may try to fill the available spaces. If those spaces are filled you will receive a refund, if spaces cannot be filled you will forfeit your entry.

DAY OF TRIAL ENTRIES: Day of trial entries will be accepted if space allows and must be submitted prior to the judges briefing. Day of trial entries shall be \$35.00 per component. Move ups within the same trial/day ie: Novice to Open are not permitted.

ENTRIES MUST BE PAID IN FULL. Tendering of an NSF cheque in payment of entry fees will be considered non-payment of entry fees and is an offence punishable by CKC disciplinary action and

cancellation of awards. The owner of a dog entered in this Trial is entirely responsible for any error in the entering of his dog, regardless of how, or by whom the entry was made.

REFUNDS: Fees will not be refunded after closing date for any reason. If for any reason, APWDC has to cancel the trial prior to the closing date, all entry fees will be refunded.

BITCHES IN SEASON: Bitches in season are eligible to trial as of January 1, 2024. Should a bitch be competing while in season the handler must inform the club prior to the trial date. These entries will be scheduled to run last in each component and must wear snugly fit panties.

ROSETTES & PRIZES: Flat ribbons will be given for all qualifying scores and rosettes will be awarded for new titles.

ELIGIBILITY: Purebred or mixed-breed dogs may compete

Every dog entered in an approved event must be one of the following:

- a) Registered with the CKC
- b) Have an Event Registration Number (ERN)
- c) Have a Performance Event Number (PEN)
- d) Eligible for registration with the CKC, and have a **Temporary Competition Number (TCN)
- e) Mixed breeds must have a Canine Companion Number (CCN)

To be eligible to compete at approved trials or sanctioned matches a dog must meet the requirements of Section 6.1.1, and:

- a) Must be at least 6 months of age.
- b) May be spayed, neutered, or debarked.
- c) Must not be lame (judge reserves final determination on lameness).
- d) Must not compete if it has tape or bandages that may impair its working ability (such a dog must be immediately excused and under no circumstances may it be returned later for judging after the tape or bandages have been removed).

****NON-MEMBER PARTICIPATION FEE/TCN Number:** The CKC requires all owners of unregistered, recognized breeds entering events to obtain a Temporary Competition Number (TCN). TCNs will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN). <https://www.ckc.ca/en/News/2020/March/TCNs-What-Are-They-And-How-Do-You-Get-One>

If a dog is not registered individually in the records of the CKC, it may be entered at a trial held under these rules with a Temporary Competition Number (TCN), providing that the number is obtained before the closing date of entries. Once the dog is permanently registered or has an ERN, the TCN will no longer be valid. While there is no fee for the Temporary Competition Number, exhibitors will still be required to pay listing fees (\$10.50) when entering events. The request for a TCN will be self-serve; exhibitors should go to the CKC website to complete an online application and a TCN will be issued instantly. Exhibitors may also obtain a TCN by completing a printed application and submitting it to the CKC, or by contacting the Shows and Trials Division by telephone.

IMMUNISATION: The CKC Rules and Regulations for shows, trials and tests, with some exceptions, have explicit rules to minimise the transmission of communicable diseases. A dog may not be entered or exhibited at a show, trial or test if it has any communicable disease. Dogs entered in a show, trial or test must be able to provide proof of current immunisation status.

HANDLERS WITH MULTIPLE DOGS: Handlers with multiple dogs will not be permitted to enter more than one dog in the same class / components. I.e.: Two novice dogs handled by the same person cannot be entered in the same Novice components at the same trial. The handler may enter one dog in Instinct, and one dog in Novice as an alternative.

CKC REGULATION: "It shall be the duty and obligation of the trial- giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Event Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred."

GENERAL INFORMATION AND TEST RULES FROM THE CKC SCENT DETECTION RULES & REGULATIONS:

It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. WITHDRAWAL OF ENTRIES: Please note: An exhibitor has the right to withdraw an entry up to the closing date and time as published in the premium list. This may be done by telephone, but written or electronic notification must be received by the Show Secretary no later than the official closing date and time. If written notification is not received by that time, the dog will remain entered in the event.
