Mr. Steven Dainard

Steve Dainard comes from a second-generation dog show family. He began showing dogs in the late 1970's. His family started with Flat Coated Retrievers and later found their breed of choice - the English Springer Spaniel.

Steve, and his wife Kelly, bred under the 'KAS' prefix. He has shown Springers to the top winning male in Canadian history, as well number one all breed status. 'KAS' also bred and exhibited the top winning Springer female in Canadian history. In 2014, he had the honour of judging the ESSFTA National

Specialty and in 2018 he judged the flushing spaniel breeds at the Westminster Kennel Club.

Steve was an all-breed handler specializing in Sporting and Herding dogs. He has also owned and bred Australian Shepherds. Steve has a passion for continuing education. He has served terms on the executive of the Canadian Dog Judges Association and is currently the Vice President - Administration. He holds a Bachelor of Commerce degree in Entrepreneurial Management.

Steve is a licenced as an All-Breed judge with the Canadian Kennel Club and has judged in Canada, the U.S.A., Mexico, Colombia, Ecuador, Argentina, Ireland, Australia, South Korea, China, and the Philippines.

In his professional life he is a retired Manager with the Toronto Transit Commission in Administration and Financial Control and started his second career as a Mortgage Broker in 2014 with the professional designation of Accredited Mortgage Professional. In his personal life, Steve and his wife Kelly have three grown children and two grandsons and live in Niagara Falls, Ontario, Canada.



Mr. David Denis

David has been showing and breeding dogs since 1973. He has bred, owned and exhibited Bernese Mountain Dogs, Greater Swiss Mountain Dogs and Entlebucher Mountain Dogs. He has been judging since 1996. In addition to Canada, he has judged in Denmark, England, Finland, Scotland and USA. He is also licensed to judge all Levels of Obedience, both Levels of Drafting, all-breeds in Lure Coursing.

Ms. Ann Ingram



I was born into the dog world, with a father who was a Terrier Specialist and a mother who introduced the Boxer Breed to Ireland, both were All Breeds Judges. I began to show dogs almost as soon as I could walk and, under the Tirkane Prefix, I have bred or owned, over 100 Irish and 31 UK champions in Boxers, Boston Terriers, Poodles, and Lhasa Apsos, also 2 World Winners.

I was 16 when I started to judge, I awarded CCs (UK) in Boxers aged 25, the youngster person ever to do so, and I am now approved to award CCs in 60 breeds in UK, all the groups and Best in Show. I became an F.C.I. All

Breeds judge in 1984 and have judged in more than 50 countries, including Australian Royals, Several World Shows, AKC Shows, Orlando & Westminster, and most European countries.

I retired from breeding and showing a few years ago after an involvement of over 50 years but still retain a keen interest in the breeding and development of the breeds. Past President of The Poodle Club of Ireland and Irish Boxer Dog Club and currently chair of Munster Agricultural Club, Canine Section, I am still very involved in working with clubs.

Currently I judge regularly around the world and this year I judged the Working Group at Crufts, (2024 I will judge Best in Show) and have traveled to Canada, Peru and other European Countries over the last few months.



Ms. Margaret Jones

I am a retired Health Care Administrator who has been showing and training dogs since 1965, when I obtained my first Irish setter. Since then I have shared my home with Irish Setters, Cairn Terriers, Boxers and a number of different breeds including, Doberman Pinschers, a Great Dane, Afghan Hound and a Tibetan Mastiff.

As a small breeding kennel we raised and bred Irish Setters, Boxers and Cairn Terriers under the Kian Prefix and exhibited them to Group, Specialty and Best in Show wins. We gained top Dog Awards and many Obedience titles with our Irish Setters and Boxers. Cairn terriers

do not excel in the Obedience ring but they love to work at Rally, Scent detection and Earth sports.

As an All breed Judge I have been privileged to judge many times at All Breed and Specialty shows in Asia, Australia, Europe, South Africa, South America, U.K., Canada and USA.



Mr. Frank Kane

I had my first dog, a Cocker Spaniel, when I was 13 years old, and showed him with limited success as he was too big and too long..... but those early disappointments taught me a lot and I was fortunate to have the help and support of good breeders and going to shows in the 70s and 80s I was fortunate to see the golden age of Cockers with many famous kennels and wonderful dogs to train my eye.

Cockers remain my first love although greater success came with my American Cockers: I was fortunate to have 13 UK champions and several group winners. Also in the 70s I developed a love for Sealyham Terriers. With Jim Wilson of Gungrace fame I was fortunate to co-own two champions, one a group winner. I first judged at a championship show in 1974 and Cockers, Americans and Sealyhams came first,

and then expanded to take in other gundog breeds and then breeds in other groups. I am now approved to judge 140 breeds and all seven groups in the UK along with Best in Show. I judged Best in Show at Crufts in 2012. I have been fortunate to be invited to judge around the world, including Best in show appointments at Royal shows in Australia, USA and Japan and South America as well as many FCI shows in Europe. I joined the Board of the Kennel Club in 2004 and later became Chairman of the Breed Standards Committee. I have been involved with the television presentation of Crufts dog show for the past 20 years. Outside my canine activities, I am a keen horseman, having been going to horse shows with my father since I was 10 years old. I am looking forward to the World Dog Show in Helsinki and am confident it will be a great event befitting the country's reputation for clever breeders, great dogs and excellent judges. I hope to hear the great music of Sibelius, rightly so proud of his Finlandia!



Mr. Torbjorn Skaar

I started in 1961 with horse riding both jumping and dressage. My first dog was a Great Dane from kennel Airways in 1968 and we later imported from USA. In 1980 when I met Paul Stanton, I was introduced to his breeds Lhasa Apso and Tibetan Terriers. In 1992 our kennel Tintavon was awarded the Hamilton Plaque for outstanding breeding of Lhasa Apso. We have bred with great success Lhasa Apso, Tibetan Terriers, Whippet and Thai Bangkaew Dog. I got my official license in 1992 and became FCI all breeds judge in 2015. I have judged on all five continents. I love my judging and my favourite groups are Sighthounds and the Toy group. I have been Chairman of the Tibetan breed club since 2001. I enjoy judging junior handling and I was committee member in SKK Junior handling committee for many years.

My other interests include food, travelling and culture in general. Looking forward to visiting Vancouver Island again.



Mr. Paul Stanton

I acquired my first dog in 1964, a Shetland Sheepdog named Tint and as I lived near the river Avon I took the affix Tintavon. In 1966 I went to work for the famous Hardacre Kennels of Anne Matthews then breeding mainly Basset Hounds but Anne had just started with Lhasa Apsos and Tibetan Terriers where I fell in love with the Apsos temperament and in 1969 I acquired my first Apso and I have owned or bred 5 UK Ch.s plus 15 all breed BIS winners. My first Tibetan Terrier became the immortal UK Ch Dokham Cavarodossi of Tintavon who was the first TT in the world to win all breeds BIS, which he did twice in 1974 at the Birmingham shows, his double granddaughter Tintavon Desdemona (1 cc & 2 res CC.s) won Top Dog All Breeds in Sweden and Finland 1979. I am the only person to have owned/bred Ch.s in the 3 Tibetan breeds in the Utility Group.

I moved to Sweden in 1977 where I continued to breed Apsos and TT.s with great success. We (Torbjorn Skaar) kept brown Miniature Poodles for a short time making up 2 Int Ch.s and in our only litter we bred 2 Champions.

Whippets came into our lives in 1986 and we had good success with our few litters, keeping 1 female in each litter until our last litter where there were only 3 males which we kept one who was a group winner and he became our last whippet. With both of us judging internationally we cut back the breeding and showing our dogs.

In 2012 we introduced the Thai Bangkaew Dog to Europe (FCI group 5 Primitive Breed). Our dogs were the first in Europe to win a group and in the breeds first litter we bred World Winner and European Winners but sadly these dogs had or were carriers of PRA, so our breeding came to a halt although we have 2 eleven year olds at home.

I became an All Breeds Judge in 1996. I have now judged in over 60 countries on all continents. Some of my judging highlights are judging Lhasa Apsos at Crufts in 1981, Tibetan Terrier Silver Jubilee (UK), South Eastern Tibetan Spaniel Ch show (UK), The Chow Chow club Ch. Show and Chow of the year 2023 females (UK), Canadian English Springer Spaniel National specialty, 5 groups at AKC shows. Sydney, Perth and Hobart Royals, Judged BIS through out Europe, Asia and South America, Canada with a highlight judging BIS the Santa Barbara show 2022.

My other interests are gardening, opera and ballet and foreign culture.

CONFORMATION CLASSES

The following Regular CKC Classes (divided by sex) will be offered:

JUNIOR PUPPY CLASS - This class shall be for any dog 6 months of age and under 9 months of age on the day of the show

SENIOR PUPPY CLASS - This class shall be for any dog 9 months of age and under 12 months of age on the day of the show

12 to 18 MONTH CLASS - This class shall be for any dog 12 months but under 18 months of age on the day of the show

CANADIAN BRED CLASS - This class shall be for any dog born in Canada.
(Champions of any country excluded)

BRED BY EXHIBITOR CLASS - This class shall be for any dog owned and handled in the ring by owner/breeder. The handler **MUST** be the owner/co- owner **AND** breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

OPEN CLASS - This class shall be for all dogs

SPECIALS ONLY CLASS - This class shall be for any dog that has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. Note: A Listed dog may be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class **MUST** be received by the Show Secretary **ONE HOUR PRIOR TO THE BREED JUDGING** on that day. TCN Fees **WILL NOT** be refunded

EXHIBITION ONLY - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class **MAY NOT COMPETE** in any Regular class but may enter and compete in Non-Regular classes and/or Parades **ONLY**

NON-REGULAR CLASSES

PUPPY CLASS - This class shall be for any dog 4 months of age and under 6 months of age on the day of the show. The awards for this class are: Best Baby Male, Best Baby Female, Best Baby Puppy in Breed, Best Baby Puppy in Group, Best Baby Puppy in Show (This class will be held on completion of Best Puppy in Breed, Best Puppy in Group and **PRIOR** to Best in Show)

VETERANS CLASS - This class is for dogs 7 years of age and over on the day of the show. Dogs entered in these classes may be spayed or neutered.

BREEDER/OWNER/HANDLER- you must enter this class (no fee) to be considered. From regular classes only. You must handle the dog for all levels of competition.

SEXUALLY ALTERED

SEXUALLY ALTERED CLASS - This class is for dogs which have been spayed or neutered.



2. ENTER Online



A service charge of 10% will be assessed. This includes entries sent online or post using a credit card or interac for payment.

ALL Entries **MUST** be received by closing date: **WEDNESDAY, June 18th, 2025 @ 9:00pm Pacific Time**

The tendering of NSF cheque shall be considered non-payment of entry fees and is punishable by disciplinary action and cancellation of awards. A collection fee of \$25.00 will be added to the amount of any returned cheque. Exhibitors whose charges are declined by the Bank Card Authorization Department will be assessed a service charge of \$25.00 for each transaction declined. Telephone entries are not accepted by the Show Secretary. Incomplete entries or entries received without fees, or entries received after the advertised closing date will not be accepted.

Attention foreign exhibitors, please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian Funds. BREEDER/OWNER/HANDLER COMPETITION (BOH - Sunday)

Unofficial/Exhibitor Eligibility

1. Exhibitors must declare their dog eligible for Breeder/Owner/Handler Competition at the time of entry using the check box on the entry form (either paper or electronic). If the handler changes from the time of entry to exhibition, the exhibitor is responsible for advising the ring steward if the entrant is no longer eligible.
2. The handler must be a breeder/owner of record listed in the catalogue.
3. Dogs must be handled by a listed breeder & handler throughout the breed level competition for the regular show. This includes the class competition and subsequent competition in the breed ring. The same is true for all levels of group and show competition.
4. The BOH in Breed will be selected from the eligible dogs that competed in the Best of Breed competition for the regular show. This includes Winners Dog, Winners Bitch. This excludes all dogs defeated during class and winners competition for the regular show.

Determining Best BOH in Breed

The selection of the Best BOH in Breed is held immediately following regular judging of that breed in the same ring. The ring steward will excuse all exhibitors not eligible. The judge will then award Best BOH in Breed. Judging of the breed for the regular show may determine the dog that is awarded the Best BOH in Breed.

Guidelines:

- If the Best of Breed winner of the regular show is eligible for Best BOH in Breed it will also be awarded Best BOH in Breed. In this case the dog will be eligible to compete in group competition for the regular show and group competition for Best BOH in Group.
- If the regular show Best of Breed winner is not eligible for Best BOH in Breed and the regular show Best of Opposite Sex is eligible, the regular show Best of Opposite Sex will compete against the eligible exhibits of the other sex to determine Best BOH in Breed.
- If neither the Best of Breed nor the Best of Opposite Sex from the regular show is eligible for the Best BOH in Breed and both the Select Dog and Select Bitch are eligible, the judge is to choose Best BOH in Breed from the Selects and any eligible Winners Dog or Winners Bitch.
- If one of the Selects from the regular show is eligible for Best BOH in Breed, excuse all eligible champions and then choose Best BOH in Breed from the remaining eligible dogs of the opposite sex including the eligible Winners.
- If the regular show Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as the Best BOH in Breed.

If no dog remaining in the ring is eligible for the Best BOH in Breed competition, no award will be made and there will not be representation in group competition for the Best BOH in Group.

Group and Best in Show Competition

- In the Group and Best in Show competition, the dog must be handled throughout the competition by an eligible breeder.
- Group judging for the Best BOH in Group may take place in separate rings from regular group judging.
- Judging for the Best BOH in Show is after regular Best in Show judging.

JUVENILE SWEEPSTAKES - FRIDAY, July 11th, 2025, noon

Judge: Larisa Hotchin

Juvenile Sweepstakes is to all puppies six months and under eighteen months of age regardless of place of birth. All dogs must be entered in one of the regular official classes on the same day. Dogs will be judged in one of the following three classes (divided by sex):

- Junior Puppy - 6 months and under 9 months
- Senior Puppy - 9 months and under 12 months
- Juvenile Puppy - 12 months and under 18 months

For final judging the first place puppy from each of the classes will be brought together for the final judging of Best in Sweepstakes.

Best in Sweepstakes - rosette & 50% of total fees collected for the Juvenile Sweepstakes

Best of Opposite in Sweepstakes - rosette & 25% of total fees collected for the Juvenile Sweepstakes

25% of fees collected will be retained by the club to defray costs

VETERAN SWEEPSTAKES - FRIDAY, July 11th, 2025 following Juvenile Sweepstakes

Veteran Sweepstakes is open to all dogs 7 years of age and over and entered in a regular class or for exhibition only on the same day. Spayed and neutered dogs may compete provided they are also entered in exhibition only.

Dogs to be judged in one of the following two classes (divided by sex):

- 7 years and under 10 years
- 10+ years

For final judging the first place winner from each of the classes will be brought together for the final judging of Best in Veteran Sweepstakes.

Best in Sweepstakes - rosette & 50% of total fees collected for the Veteran Sweepstakes

Best of Opposite in Sweepstakes - rosette & 25% of total fees collected for the Veteran Sweepstakes

25% of fees collected will be retained by the club to defray costs

JUNIOR HANDLING - SUNDAY, JULY 13TH, 2025 AT NOON

Judge: Lisa Tremblay

Entries will be accepted at the show secretary's desk up to 11:00 am on Sunday with no exceptions.

Entry Fee \$2.00

The following classes will be provided:

Pee Wee (non-competitive) - 4 to 6 years

Junior Novice - 7 to 10 years

Junior Open - 7 to 10 years

Note: Pee Wees do not compete for best overall.

GENERAL RULES GOVERNING THESE SHOWS

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the Conformation Rule book are available online at www.ckc.ca

1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
4. A judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
6. **DOGS MUST BE READY FOR JUDGING.** The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed. All start times are PACIFIC TIME.
7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$115 plus GST (for Canadian residents) (\$230 non-resident), which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog BEFORE taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.
13. The tendering of NSF cheque shall be considered non-payment of entry fees and is punishable by disciplinary action and cancellation of awards. 15. No person may approach a judge wither directly or otherwise, orally, in writing or electronically, to favour his entry. Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the action.

CANADIAN KENNEL CLUB SCHEDULE OF CHAMPIONSHIP POINTS

SECTION 2. The schedule to be employed in the determination of the number of points to be allocated to a dog awarded WINNERS shall be as follows: (*Includes the dog awarded Winners.)

Dogs Competing*	1	2	3 to 5	6 to 9	10 to 12	13 or more
Points Allocated*	0	1	2	3	4	5

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. A dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points. Further section 15.1.12 {C} has been added and states the dog must: "have earned at least one 2 point win either at the breed level or group level."

The system provides for additional points if a dog awarded winners also places in the Group as listed here under.

A class Dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five (5) points at a single show. To earn a Canadian Championship, a dog must earn at least ten championship points under at least three different judges; and be individually registered with the Canadian Kennel Club, or have a CKC Event Registration Number (ERN) and have earned at least one 2-point win either at the breed or group level.

In order to obtain a Grand Champion title, a dog must obtain a minimum of 20 points which must include a minimum of two wins of at least 2 points and at least two (2) points after 12 months of age. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points. (d) Only the highest points earned at a single show are carried forward.

15.2.4 Grand Champion Bronze (GChB) The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.

(a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship.

(b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

(c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

15.2.5 Grand Champion Silver (GChS) The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Bronze is attained, and do not include the points earned in attaining the Grand Championship Bronze.

(b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.

15.2.6 Grand Champion Gold: (GChG) The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Silver is attained, and do not include the points earned in attaining the Grand Championship Silver.

(b) To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best in Show/ Specialty level. Only the highest points earned at a single show are carried forward.

15.3 Grand Champion Excellent (GChEx) (48-06-12)

15.3.1 The title of Grand Champion Excellent may be granted only after the completion of the CKC Grand Championship Silver Title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website.

15.3.2 To earn the title a dog must have earned the following during their career as a Special:

(a) one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed)

(b) three (3) Group 1st, or three (3) breed specialty best of breed wins.

(c) a CKC performance title from any CKC Event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.

15.3.3 Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance title may be attained at any time in the dog's career.

1. Exhibitors are required to complete the Grand Champion Excellent Record Sheet form located on the CKC website and forward to CKC upon completion of requirements above.

2. Grandfathering of the previous version of the Grand Champion Excellent title will be honoured up until July 1, 2022

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
