
Judges' Biographies

BENJAMIN CHIN

Benjamin's journey into the world of dogs began in Malaysia, where his family welcomed an American Eskimo Dog (Toy) into their home, sparking his passion for purebred dogs. His fascination deepened upon encountering his first Pekingese.

In 1990 a high school friend's family bred and exhibited Golden Retrievers and Benjamin assisted them with their dogs. This experience laid the groundwork for his future endeavors when he moved to Canada.

In 2003, he exhibited Pekingese in a Canadian show and gained a championship on the Pekingese that same year, marking a significant milestone in his journey.



Co-breeding his first litter of Pekingese in 2009, leading to numerous successful litters and championships.

Active involvement in the dog show community, including roles as a ring steward, show committee and exhibitor, honed his skills and understanding of the dog shows. In 2020, Benjamin obtained his first CKC permit to judge half of the toy group.

He strives to make the experience a positive experience for both the dog and the exhibitor.

He continues to learn and grow in this area. Despite his fast-paced employment in high tech, dogs and dog shows remain his cherished escape, providing solace and rejuvenation amidst professional demands, while his dedication to dogs and dog show community remains steadfast.



CHRISTIAN GÓMEZ ORTIZ

I'm from Bogotá Colombia, started in the world of dogs, thanks to the intense hunting activity developed in my father's family, which led me to become passionate about life in the countryside and above all for sharing and observing hunting dogs beating all lands. In this way and as a gift from my father to his children, I have my first experiences with American Cocker Spaniel dogs, used for the purpose.

In my first years of University, I managed to get involved with the Lasallian Canine Club, of which I would later become the first President directly elected by its members, where I had the fortune of "learning by doing", the official exhibitions scheduled under the responsibility of the Club.

Later, I became interested in the professional handling of show dogs, starting with the German Shepherds. I decided to venture into the Rottweiler Breed in the early 90s, not only as a breeder but as a professional handler, exhibiting Dalmatian, OESD, Bullmastiff, Boxer, Bulldog, Dobermann, American Akita, Bouvier de Flanders, Bull Terrier as well. In 1999 I was awarded the Lasallian medal of merit, for my work and development in the canine environment.

I join as a member of the ACCC where I had the opportunity, as a member of the Technical Committee and Board of Directors, to assume direct responsibility in the management of the breeding of the Rottweiler breed for several years.

I obtained my license as a Specialized Judge for Rottweiler and Boxer Breeds in 1998, extending it to group II F.C.I. in 2003 and groups I, VII, VIII and IV in 2008 FCI all-rounder Judge in 2009.

I have carried out judging in Canada (Bathurst, London On., Camrose, Nanaimo, Edmonton), Japan (Narita), China (Hangzhou, CKU), Mexico (Rottweiler specialty Monterrey), Club 00, FCM (Expocan), Guatemala, El Salvador, Cuba, Dominican Republic, Puerto Rico, Ecuador, Peru (Peruvian Kennel Club, Lima Rottweiler Club, Arequipa Canine Club, Bolivia (Cochabamba, Santa Cruz), Brazil (All breeds and Specialized APRO and others), Argentina (Specialized Rottweiler and Boxer), Rosario Can Club, Cordoba Kennel Club, Venezuela, Chile, in addition to those specialized for group II breeds and all breeds, under the auspices of several clubs in my country.

I am a graduate of the De La Salle University of the Faculty of Agricultural Business Administration in Bogota, specialized in Dairy Farming and Agricultural Business Creation and Management.

I have been working for 28 years as Technical and Commercial Manager of an important pet food and products company with coverage throughout Colombia.

PATRICK MUDGE

Patrick Mudge purchased his first purebred dog (a Samoyed) in 1969, which sparked an obsession with all things related to the dog show world. As a teenager he spent as much time as possible at shows lurking around the handlers' setups waiting for an opportunity to take in that second-place dog for Reserve!

An early fascination with the Winterfold whippets of Martine Collings led to a lifetime of involvement with that wonderful breed. Since that time Patrick has owned several different breeds and has shown dogs (many owned by others) to group first in six of the 7 groups (all but herding) and to Best in Show.

His most recent involvement (since 1997) has been with miniature poodles, co-owning Canada's Puppy of the Year for 1997 (BIS Can.Am/Ch Minstrel der Letzte Tanz, "Swayze") #1 mini and #4 non-sporting dog for 1998 and #2 sire in the breed. Patrick has bred Group winning, BPIS and BISS winning mini poodles.



A music educator by profession, teaching piano and voice, he has recently retired, with his partner Walter, to a small (266 acre) farm outside of Fredericton, NB.



JO ANN PAVEY

I have owned, bred, trained, and shown Shetland Sheepdogs for over 50 years. Our dogs have been very successful in all rings on both sides of the border. I am a lifetime student of all purebred dogs and to that end, as of March 23, 2024, I will be an All-Breed judge.

I have judged Group Specialty Shows for Herding and Toys, as well as Specialty Shows for Collies, Belgian Shepherd Dogs, Cavalier King Charles Spaniels, Pembroke Welsh Corgis, Finnish Lapphunds (National), Gordon Setters and Australian Shepherds (ASCA).

I have been very fortunate to have judged many Sheltie Specialties all over the United States and Canada, including having judged both Canadian and American Shetland Sheepdog National Specialties, the first and only Canadian to have been so honoured.

I have judged in Canada, the U.S. and Japan.

VICKIE UMPLEBY

My passion for purebred dogs began in 1969 at ten years of age when I had a part time job working for a breeder of American Cocker Spaniels. It was there that I learned to groom and show them and from there that I got my very first cocker. I started breeding and showing cockers in 1980 under the kennel name Nonnies, adding English Cockers Spaniels to my kennel in 1997. I have bred or owned more than one hundred champions in these two breeds. My top winners include Best In Show, Best Puppy In Show, Group, and Best In Specialty show winners in both Canada and the USA as well as winners at Westminster and American Spaniel Club.

In 1992 my husband and I purchased our first bulldog puppy who I showed to her championship. Though we only bred a few bulldog litters over the years I have



owned or co-owned many bulldog champions. Highlights included co owning a Best In Show and National specialty winner who was the number one bulldog in Canada in 2012. And in 2018 our homebred veteran dog won Best of Breed at the Bulldog Club of Canada National Specialty.

My judging career started in Canada in 2002 and I have been licensed to judge all breeds since 2017. I have judged across Canada, in many states in the USA, Denmark, Czech Republic, Mexico, Argentina, New Zealand and Australia.

I have been a member of the Canadian Kennel Club since 1978 and am a founding member of the American Cocker Spaniel Club of Canada since its inception in 1984. I am also a member of the Bulldog Club of Canada and the Canadian Dog Judges Association.

In 2018 I retired from a 38-year career in the airline industry. In addition to spending time with my family, my dogs, and horses, I also enjoy running, cycling, gardening and travelling and of course attending dog shows, both as an exhibitor and as a judge.

Sunday, July 28, 2024 (lunchtime)

Held under CKC Rules. Judge to be announced the day of the show.

Class Structure (Age Requirements)

1. PEE WEE

For handlers 4 years of age up to 6 years of age. Optional and non-competitive. No placements are to be awarded, participant ribbons, rosettes and token trophies may be presented.

2A. JUNIOR NOVICE

For handlers 7 to 10 years who have not won six first places in the same class with competition.

2B. JUNIOR OPEN

For handlers 7 to 10 years of age, who have won six first places with competition in the Junior Novice Class, OR any handler wishing to enter this level. It is understood that once that handler has entered and competed in the Open Class, he/she may not compete in the Novice Class again.

3A. INTERMEDIATE NOVICE CLASS

For handlers 11 to 14 years of age, who have not won six first places in the same class with competition.

3B. INTERMEDIATE OPEN CLASS

For handlers 11 to 14 years of age, who have won six first places in the same class with competition.

4A. SENIOR NOVICE CLASS

For handlers 15 years of age and up to 18 years of age, who have not won six first places in the same class with competition. Handlers from the Intermediate levels progress to this class.

4B. SENIOR OPEN CLASS

For handlers 15 years of age and up to 18 years of age, who have won six first places with competition in the Senior Novice Class and for any handler who has progressed through the Intermediate Open level and feels that he/she has enough experience to compete at this level.

5. BEST OVERALL

Optional at the discretion of the host club.

All dogs must be entered in one of the Official Classes or Exhibition Only on the day of competition. Entry to be made at the show.

Dogs being used in the competition must be of appropriate size and temperament for the Junior Handler.

If Pee Wee handler cannot lift dog, it is not appropriate in size for the competitor.

Best Overall and each First In Class Junior Handler Participant will be receiving a Prize Sponsored by **BEST IN SHOW Dog Supplies.**

In consideration of the acceptance of this entry I (we) agree to be bound by the rules and regulations of the Canadian Kennel Club and by any additional rules and regulations appearing in the premium list. Also by signing this form, I certify that I will not hold the Show giving Club, its members, directors, employees or agents liable in the event of any accident of misfortune however caused.

Entry Information

- 1. No entry will be accepted unless all particulars called for on the entry form are completed in full. Handlers or agents please note the full name and address of all owners must be filled in.
- 2. Incomplete entries will be returned. No entry will be accepted unless accompanied by entry fees. Telephone entries cannot be accepted. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.
- 3. The Club and MJN Show Services will not be responsible of cash sent through the mail.
- 4. The Club reserves the right to refuse any entry subject to CKC rules.
- 5. There is no refund for duplicate cheques. Every effort will be made to find all duplicate entries, however if the entry has been processed and appears in the official catalogue, no refund will be made.
- 6. Entry fees shall not be refunded in the event that the dog is absent, excused by a Veterinarian or Judge, disqualified or barred from competition by action of the bench Committee.
- 7. Alterations, substitutions or cancellations of any entry after the closing date is prohibited. Moving Class Dogs to Specials or unfinished Specials back to the classes is permitted. An error in the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show. Only dogs already registered in the Canadian Kennel Club Stud Book, or eligible for such registration, can be entered. The committee reserves the right to refuse any entry subject to CKC Rules. Entries close 8 P.M. (ET) Tuesday, July 2, 2024, and must be in the hands of the Show Secretary by that date.
- 8. Identification cards and judging schedules will be e-mailed as soon as possible after the entries close.
- 9. Tendering of NSF cheques in payment of fees shall be considered non-payment of fees and is punishable by disciplinary action. **Any NSF cheques will be subject to a \$35 service charge.**
- 10. All dogs must be attended to by its owner and/or handler day and night (24hrs). No dogs are to be left unattended on the premises and/or buildings of the events.
- 11. The Limestone City Kennel & Obdience Club and its Executive/ Members will not be responsible for, or assume liability in the event of theft.

General Information

- 1. The Show Superintendent will be in full charge of the show, which will be governed by CKC Rules.
- 2. The Kars Dog Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
- 3. If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the show, no refund of Entry will be made.
- 4. Dogs may arrive any time prior to their scheduled time of Judging. Dogs not required for further judging will be excused. Judges will not wait for any dog holding up a class. Owners/Agents are responsible to have their dogs present when their classes are called to be judged.
- 5. Judging start times to be specified in the judging schedule Starting time of each ring will be specified in judging schedule.
- 6. SHOW PRECINCTS: Lombardy Agricultural Fairgrounds. Dogs not entered in these shows will **not** be allowed within the show precincts.
- 7. Exhibitors are requested to keep their grooming and crating areas clean and tidy. The Show Superintendent has the authority to ask exhibitors to move or take down crates and private exercise pens, etc. Failure to do so when requested could result in disciplinary action.

Refund Policy

If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the show, no refund of Entry will be made.

Exhibitors, handlers, judges and assistants are expected to participate with honesty, fairness and integrity, ever mindful of the practice of "good sportsmanship," before, during and after this show. Any person engaging in an activity that might be considered malicious, threatening or constitutes bullying, including but not limited to social media, will be asked to leave this show without compensation and will be banned from any future shows held by this club.

Temporary Competition Number (TCN)

A Temporary Competition Number (TCN) allows dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

A TCN must be obtained before submitting an entry for an event.

The same TCN must be used for all event entries for a dog until the dog is permanently registered or has an ERN.

TCNs can be obtained through your CKC member portal or by contacting the CKC.

Note: There is no CKC fee to obtain a TCN. However, a TCN 'listing' fee is required each time a dog with only a TCN is entered in an event.

Event Registration Number (ERN)

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events, and do not have a CKC registration number, will require an Event Registration Number (ERN).

The ERN number MUST be applied for within 30 days of the first day of entering a CKC event.

Fee is \$64.00 per dog, plus applicable taxes.

Non-Member Participation Fee

Effective January 1, 2011:

- A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The fee will be \$170.00 plus applicable taxes.
- b) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- c) In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- d) The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

CH and Champion Points

Section 15.1.1 A dog awarded Winners at a conformation show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded Winners shall be as provided hereunder.

Section 15.1.2 The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

Dogs competing* 1 2 3 to 5 6 to 9 10 to 12 13 or more Points allocated 0 1 2 3 4 5 *includes the dog awarded Winners

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge <u>SHALL NOT</u> be included in the calculation for championship points.

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed, or Best of Opposite Sex and then consult the schedule set forth above.

Section 15.1.8 In addition to championship points allocated at the breed level, a dog awarded Best of Breed that also places in the regular group competition shall be credited with the following additional points, provided that a dog was defeated at the group level.

Section 15.1.11 A class dog awarded Best in Show at an all-breed Championship show will be credited with five points inclusive of any points earned at the breed or group level.

Section 15.1.12 In order for a dog to be recognized as a Champion and its owner provided with a Championship Certificate, the dog must have earned 10 championship points under at least three (3) different judges, with at least one 2-point win either at the breed or group level.

GCH and Grand Champion Points

Section 15.2.1 The title of Grand Champion may only be earned after the completion of the CKC conformation championship.

15.2.2 Points for this title are only accumulated after the completion of the conformation championship and do not include the points earned in attaining the conformation championship.

Section 15.2.3 To be awarded a Grand Champion title, a dog must attain a minimum of 20 points, which must include a minimum of two (2) wins of at least two (2) points each. Points may be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward.

a) Grand Champion Point System Points towards the Grand Champion title, are attained at breed level and are awarded to Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch. Points are calculated based on the number of animals competing at the breed level for the Best of Breed winner and the number of similar-sex dogs competing for the other three (Best of Opposite, Select Dog, Select Bitch). The following schedule shall be employed in the determination of points awarded at breed level for all levels of GCh:

- c) In order to obtain a Grand Champion title, a dog must obtain at least two (2) points after 12 months of age. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points.
- d) Only the highest points earned at a single show are carried forward.

Section 15.2.4 Grand Champion Bronze (GChB)

The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.

- a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship.
- b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.
- c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

Section 15.2.5 Grand Champion Silver (GChS)

The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained.

- a) Points for this title are only accumulated after the completion of the Grand Champion Bronze is attained, and do not include the points earned in attaining the Grand Championship Bronze.
- b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.

Section 15.2.6 Grand Champion Gold (GChG)

The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained.

- a) Points for this title are only accumulated after the completion of the Grand Champion Silver is attained, and do not include the points earned in attaining the Grand Championship Silver.
- b) To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.

GCHEX and Grand Champion Excellent Points

The title of Grand Champion Excellent may be granted only after the completion of the CKC Grand Championship Silver Title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website.

Section 15.3.2 To earn the title a dog must have earned the following during their career as a Special:

- a) one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed).
- b) three (3) Group 1st, or three (3) breed specialty Best of Breed wins.
- c) a CKC performance title from any CKC Event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.

Section 15.3.3 Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance title may be attained at any time in the dog's career.

Altered Champion and Altered Points

Section 13.8.1 Championship points will be awarded as per Chapter 15, with the exception of 15.1.11. The winner of an Altered Best in Show shall be awarded points according to the total number of dogs in competition following the point schedule in Section 15.1.2.

Section 15.1.12 In order for a dog to be recognized as a Champion [Alt] and its owner provided with a Championship Certificate, the dog must have earned at least one 2-point win either at the breed or group level.

Conformation Show Rules and Regulations

The Exhibitor is responsible for knowing and complying with the Conformation Show Rules and Regulations of the Canadian Kennel Club.

Section 4.7.1 of the Conformation Show Rules and Regulations states: A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out.

Moving Class Dog to Specials Only

Section 8.9 of the Conformation Show Rules and Regulations has been amended to allow a dog which is individually registered in the records of the Canadian Kennel Club, and has completed the requirements for a Championship, after the Closing Date for entries for a show, may be transferred from one of the Regular Classes to "Specials Only," providing the request for a transfer is submitted to the Show Secretary in WRITING at least one hour prior to the judging of your breed by the owner or handler.

When one or more all-breed and/or specialty shows are held on the same day, in the same venue, the request for moving of class dogs to Specials Only must be made a minimum of one (1) hour prior to the breed judging scheduled start of the show for which the dog is being moved up to Specials Only.

Moving from Specials Back to the Classes

Section 8.10.5 A dog can be moved back into the classes from a Special if it has been entered incorrectly, only where the shows have already closed.



HEALTH REMINDERS

No dog may be brought onto the grounds or premises of an event if it:

- 1. Is known to have distemper, parvovirus, kennel cough or other communicable disease;
- 2. Has recovered from distemper, parvovirus, kennel cough or other communicable disease within the last 30 days (prior to the event);
- 3. Has been housed within 30 days prior to the even on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease.

Clubs do have the right to remove a dog from the event premises and the exhibitor may be subject to disciplinary action if it is found that CKC rules have been contravened.



ZERO TOLERANCE – Any individual initiating bullying tactics at the Limestone City Obedience & Kennel Club Events will be asked to leave the Event grounds premises immediately and for the remainder of the event (no refunds). A report will be filed with CKC and the Disciplinary Committee shall have the authority to take such action as it deems fit.

Definition of Bullying: Refers to a range of behaviors in which targeted individuals are repeatedly, and over time, treated in a mean, insulting or abusive way. Bullying can be initiated deliberately or unconsciously. The affected person may feel upset, afraid, isolated, or humiliated. The bully sometimes acts alone and sometimes as part of a group of people.

Examples include:

- insulting a person's skills, looks, or habits
- spreading false or malicious rumors, gossip, or innuendo
- berating/belittling an individual
- unwarranted criticizing or ridiculing, especially in the presence of others
- giving insulting Nicolaasnames
- engaging in practical jokes that humiliate
- undermining or deliberately impeding a person's work
- physical gesturing that intimidates, offends, degrades, or humiliates
- mocking a person's accent, abilities or mannerisms
- yelling or shouting which intimidates, coerces, or belittles
