#### **Howard Ogden**



TIKO'23 is Howard's first time judging in Canada.

In the UK there are 7 Groups of show dogs and Howard is passed for 5 of them and on the cusp for the remaining 2. In addition he is passed for all breeds BIS and is a Championship show judge of 85+ breeds across all 7.

He remains the youngest ever Crufts judge, invited aged just 22!

His Beauview Griffon Bruxellois are known worldwide with 7x BOB owned or bred @Crufts, making history in 2011 with the 1st b/t to top the breed. He has judged Griffon specialties from Australia/NZ to USA via Russia, Belarus, Cz and Scandinavia, hence the Griffon Club of Canada are delighted to have him judging their inaugural Specialty and delivering his renowned breed lecture that demonstrates & differentiates the breeds' roots, comprising the Affenpinscher, Pug and King Charles (to be royally topical!)

He "skived off" school to make up his 1st Champion in 1971, having spent 3 summer holidays at the breeders' learning the ropes of feeding, trimming, whelping and picking up "the proverbial ".

A defence crime lawyer by trade, Howard was the man to defend you if you were hauled up before the KC Disciplinary Committee and he later Chaired the Canine Alliance formed to support those breeds that were initially singled out, one Crufts, as unable to claim their BOB, nor compete in the Group, w/o passing a veterinary check.

Now retired, and even Griffonless, he seeks to concentrate on his judging education, expressing the view it is a "continuous learning curve" whereas, as a teenager, he reckoned to know everything of course!

#### Breed Lecture/Judges Education Opportunity

After Best in Show on Saturday, Howard Ogden will present "From the Rough to the Smooth", explaining the origin and develeopment of the Griffon Bruxellois. Howard has presented this lecture in multiple countries and it is a fantastic opportunity for judges, breeders and exhibitors to learn more about this wonderful breed. #### Lee Steeves

Lee, with her husband Ken Curren, brought Regalridge Kennel into being in the early 1980's. A lifelong owner of purebred dogs, she has grown up with her grandfather's sporting dog kennel (Weimaraners and English Springer Spaniels) and surrounded by the family Miniature Poodles, Smooth Fox Terriers, Miniature Schnauzers, one great Beagle, her Great Dane and, of course, Airedales. On meeting and marrying her husband, there was little question that it would be a dog family in the making. Ken had also grown up with Airedales, and one Newfoundland dog around whom legends have been built. Regalridge has had considerable success in the show rings with many number one Welsh and Airedale terriers in Canada, several in the top ten Terriers in the country and all owner handled. Regalridge bred two Airedales, both of whom were number one Airedale in Canada (Logan) and also the number one Airedale in the United States (Jaxson) in the same year. We have also owned, bred and/or campaigned Norwich Terriers, Great Danes, Statfordshire Bull Terriers, Bull Terriers, Wire Fox Terriers, Miniature Schnauzers, a Cirneco and American Cocker Spaniels.

Lee is the Past Chair of the Canadian Kennel Club Board of Directors. Appointments as Chair of the Obedience Council, Responsible Dog Ownership Committee, Chair of the Strategic Planning Committee, the Earthdog Council and of the Beagle and Basset Hound Council have ensured that time has not weighed heavy on her hands

Lee is a Past President of the Atlantic Terrier Association, Past-President of the Welsh Terrier Association of Canada and a member and/or on the Executive of several local, regional, national and international breed clubs. She is semi-retired from an executive position in federal government and works occasionally as a Communications Consultant in the PR Sector for both Government and NGO's.

Licensed for all breeds, her judging background includes Airedale, Welsh, Glenn of Imaal, Parson Russell and Skye Terrier, Chihuahua, Barbet, Havanese, Great Dane and Chinese Crested National,

Flat Coated Retriever and/or Regional Specialties, many Terrier and NS Duck Tolling Retriever regional breed and group specialties, international assignments including BIS at the Sydney Australia Royal as well as the Colombia 'Show of Shows' and supported entries and Specialties throughout the US, Sweden, Mexico, Australia and South America.

#### Doris Willis



Doris' love for dogs began early in life with her family's pair of German Shepherds followed by a variety of other breeds. Her appreciation for conformation and pedigrees derived from junior handling of purebred livestock. With marriage came her husband's Doberman which had attained CKC and AKC titles in Tracking and Obedience. "Dandor Kennel" was later developed by Doris, her husband and children, with Cairn Terriers as the primary breed. It expanded over the years to include West Highland White, Sealyham and Cesky Terriers, PBGV's and Golden Retrievers. Dedication to a standard of excellence resulted in numerous champions and multiple awards. She is a member of the CDJA and lifetime member of the CKC. For the first 16 years of retirement her constant companion was a sweet and clever Tibetan Spaniel shown to her Championship by Doris. Besides devoting time to judging, her other loves are gardening, embroidery, sewing, reading, painting and astronomy. Along with judging Rare Breeds, she has enjoyed the honour of assignments in Colombia, Mexico, Australia, New Zealand, Argentina and USA. She looks forward to seeing the dogs and exhibitors at your show.

I am a retired psychologist living in St-Gilles, Quebec, Canada . I am married to Madeleine Charest and we have three children and eight grand children. Our permanent registered kennel name is Chablais. We bought our first Labrador Retriever in 1979 and we registered our first litter with the Canadian Kennel Club in 1981. We , until now , have produced over 135 Canadian Champions & 35 American Champions (most of them owner/handler and shown in biggest Labrador Specialties) . We also have many Champions in different countries worldwide . Over the years , our most prestigious wins have been many times BOB at the Canadian National , BOB at the American National and three times BOB at the canadian National , BOB at the American National and three times BOB at the prestigious LRC of Potomac Spring Specialties . I am now an approved judge for the Sporting , Hound , Working , Non-Sporting & Herding Groups with a new permit for Group 4 . I started judging in 2006. I have been invited to judge mostly in Canada and in USA but also in Mexico (two times) , Brazil (two times) , Spain, Philippines, Finland (two times), France , Italy (two times) , Japan, Poland, Denmark , Argentina , Costa Rica and in UK (LRC of Wales) . I was particularly honoured to judge Canadian and American National Specialties and Best of Breed and Non Regular Classes at LRC of Potomac .

This year I will judge in Canada, New Zealand , Australia , USA and the Labrador Retrievers and Golden Retrievers at the prestigious Westminster. Kennel Club's 147<sup>th</sup> Annual Dog Show . It is a real pleasure and honour to be invited to judge at your shows

#### Dr. Vandra L. Huber

Dr. Vandra L. Huber has owned and bred more than 160 American Kennel Club (AKC) champion Scottish Terriers. She is the only Scottish Terrier breeder and one of only five terrier breeders to have attained AKC's top breeder award namely Breeder of Merit. Scottish Terriers owned or bred by Dr. Huber have gone Best in Show at four of the most prestigious dog shows in the world including Westminster Kennel Club, Crufts in England, Benelux World Dog Show and Eurasia World Show. McVan Scottish Terriers have won American breed's national specialty more than 12 times. A McVan Scottish Terrier holds the record for the most breed-specific specialty wins. Her Scottish Terrier GCHG CH McVan's Stardust aka Dusty Rose was the top Scottish Terrier in the USA, all systems in 2021. McVan® Scottish Terriers is a boutique kennel located in the Pacific Northwest. The focus has always been on quality, not quantity. A believer in breed preservation through gene diversity, Vandra has partnered with breeders around the world. The results have produced No. 1 Scotties Terriers in Australia

, Brazil, Chile, Denmark, England, Japan Russia, People; Republic of China, Singapore, and Taiwan. These champions have gone on to produce numerous other breed winners, and sires and dams. In addition to Scottish Terriers, Dr. Huber and her husband have bred/owned Border Terriers, Cairns, Russell Terriers, Parson Russell Terriers, Smooth and Wire Terriers. She also has shown and owned Miniature Poodles, Bearded Collies, and Affenpinchers.

Dr. Huber is licensed to judge all AKC terriers and toys breeds, all variety of poodles, and the majority of herding breeds. Internationally, she has judged in Australia, Canada, China, Denmark, Estonia, Finland, Germany, Japan, New Zealand, Norway, Russia, South Korea, Sweden, and Thailand Dr. Huber is active in the Olympic Kennel Club. She is President of the Washington State Scottish Terrier Club and was the founder of the Scottish Terrier Club of America (STCA) Top 20 competition. She is a frequent speaker on Scottish Terrier history and conformation and conducts comparative seminars on short legged terriers. She has frequently spoken to judge and to exhibitor groups on the topic of Decision Making Biases associated with the sport of purebred dogs. She is a frequent contributor to dog magazines with various articles such as Breeding the Scottish Terrier, Deep Smart Breeders, Scottish Terrier Vintage Jewelry, Famous People Owned by Scottish Terrier, She was a finalist for Dog New's Winki Award and McVan Scottish Terriers was featured in the Terrier Issue of Best In Show magazine.

Dr. Huber is an Emeritus Professor of Human Resources and Management, Foster School of Business, University of Washington.

SECTION 1: A dog awarded WINNERS at a championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION 2: The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

The new system provides for additional points (provided that the dog has defeated another as listed hereunder:

15.2 Grand Champion (GCh) 15.2.1 The title of Grand Champion may only be earned after the completion of the CKC conformation championship. 15.2.2 Points for this title are only accumulated after the completion of the conformation championship and do not include the points earned in attaining the conformation championship. 15.2.3 To be awarded a Grand Champion title, a dog must attain a minimum of 20 points, which must include a minimum of two (2) wins of at least two (2) points each. Points may be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward. (d) Only the highest points earned at a single show are carried forward.

15.2.4 Grand Champion Bronze (GChB) The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained. (a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship. (b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward. (c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

15.2.5 Grand Champion Silver (GChS) The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained. 


