CATALOGUES

Catalogues are available on a PRE-ORDER basis. Those who wish to pre-order at the price of \$4.00 may do so by indicating this on the entry form. A limited number of catalogues will be available for sale at the trials for a price of \$5.00.

TROPHIES & ROSETTES

Trophies will be offered at each obedience trial (for qualifying scores only) for:
High in Trial, High Scoring Retriever (Golden)

Rosettes will be offered at each obedience trial (for qualifying scores only) for:
High in Trial, 1st to 4th in Each Class

Rosettes will be offered at each rally obedience trial for 1st to 4th in Each Class.

LIMITED ENTRY

Entry in each trial will be limited to the capacity of the judge to perform 7 hours of judging at the rate of 9 Pre-Novice, 8 Novice, 8 Novice Intermediate, 7 Open, and 6 Utility dogs per hour in obedience and 15 dogs per hour less time for walk-throughs in rally obedience. Once a judge has reached his/her capacity, entries for that trial will be closed even if the closing date has not been reached. In the case of the entry limit having been reached, remaining entries will be assigned a position (by class) on a reserve list. Exhibitors will be notified of their position on the reserve list. If the entry of a bitch in season is pulled after the closing of entries, it may be substituted with one from the reserve list up to and including the day of the trial. If the entry of another dog is pulled prior to the trial, it may be substituted with one from the reserve list up to 24 hours prior to the trial.

USA EXHIBITORS

Bank drafts of money orders in Canadian Funds and personal cheques, payable in U.S. funds, and for the full amount of the entry, will be accepted. Personally discounted cheques will not be honoured. Please do not mark personal cheques “Payable in Canadian Funds” or “At Par” as such items are not cleared through the banks.

BITCHES IN SEASON

Bitches in season are not permitted to compete. When a bitch comes into season after entries close, a Veterinarian's Certificate, certifying that the bitch was in season within ten days of the trial must reach the Trial Secretary on or before the day of the trial prior to the judging of the class and the club will refund entry fees.

ENTRY INFORMATION

1. No entry will be accepted unless all particulars called for on the entry form are completed in full.
2. Incomplete entries will be returned. No entry will be accepted unless accompanied by entry fees. Telephone and telegraph entries cannot be accepted. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.
3. Alterations, substitutions, or cancellations of any entry after the closing date is prohibited. Only dogs which are already registered in the Canadian Kennel Club Stud Book, or are eligible for registration can be entered. The committee reserves the right to refuse any entry subject to CKC Rules. **ENTRIES POSITIVELY CLOSE FRIDAY FEBRUARY 14, 2020, OR WHEN THE ENTRY LIMIT IS REACHED, WHICHEVER OCCURS FIRST.**
4. Identification cards and judging schedules will be emailed as soon as possible after the entries close. Identification cards must be presented upon arrival at the trial.
5. Tendering of NSF cheques in payment of fees shall be considered non-payment of fees and is punishable by disciplinary action. **Any NSF cheques will be subject to a \$30.00 service charge.**

GENERAL INFORMATION

1. The Trial Superintendent will be in full charge of the trial which will be governed by CKC rules.
2. The Golden Retriever Club of Greater Toronto will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability, in the event of accident, or other misfortunes, to either dogs, exhibitors, or patrons.
3. If, because of riot, civil disturbance, or other acts beyond the control of management, it is impossible to open or complete the trial, no refund of Entry will be made.
4. The trial precincts shall be the entire building of Companion Dog Training.

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience or Rally Obedience Trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

JUNIOR HANDLING

Junior Handling Obedience will be held on Saturday February 29 prior to the lunch break.
Judge: Leslie Marshall.

Entries will be taken up to 11:00 am on Saturday, at the Trial Secretary's desk.

Classes Offered: Junior Obedience Pre-Novice, Intermediate Obedience Pre-Novice, Senior Obedience Pre-Novice, Junior Obedience Novice, Intermediate Obedience Novice, Senior Obedience Novice, Junior Obedience Open, Intermediate Obedience Open, Senior Obedience Open.

Held under CKC rules. Dogs entered in the Junior Handling competition must be entered in the trial on that day. The Golden Retriever Club of Greater Toronto will offer a rosette and prize for the Best Overall Junior Handler.

Junior Handling Numbers: Effective January 1, 2016 – Section 3.4.1 “All Junior Handlers with the exception of Pee Wees, must apply to the CKC Head Office on the appropriate form for a Junior Handling Number within 30 days of competing in their first Junior Handling event. This Junior Handling Number will be used by the Junior Handler for the duration of their Junior Handling career. If a Junior Handling Number is not obtained, Junior Handling points earned will not be tracked.”

From Toronto: Take Hwy. 401 to Townline Rd. (Exit 286). Head south, continue through the roundabout onto Canamera Parkway. Turn right onto Bishop St., take the first exit at the next roundabout onto Franklin Blvd. Turn right onto Turnbull Court and left into the parking lot. Park in front of units 3& 4.

From London: Exit the 401 at Franklin Blvd. and go south (you can only go south). Travel straight through the first roundabout, remaining on Franklin Blvd. At the second roundabout take the third exit onto Sheldon Dr. and turn immediately into the first driveway on the right. Continue around the first building and come down a small hill into the second parking lot. Park in front of units 3 & 4

From the North: Exit the 401 at Franklin Blvd. and go south (you can only go south). Travel straight through the first roundabout, remaining on Franklin Blvd. At the second roundabout take the third exit onto Sheldon Dr. and turn immediately into the first driveway on the right. Continue around the first building and come down a small hill into the second parking lot. Park in front of units 3 & 4
