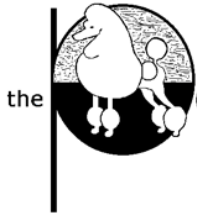

The change must be on the appropriate move-up form and submitted to the Trial Secretary by the owner or handler 30 minutes before the start of the class.

General Information for Exhibitors

In order to make everyone's visit a safe and enjoyable one, The Poodle Farm has a few rules:

- 1. No outdoor shoes allowed on the turf indoors.**
Please ensure you bring a clean, dry pair of indoor only shoes.
- Please do not arrive before 8 am. There will be no admittance to the building before that time.
- Indoor crating is very limited. There is a warm up area inside, however you should be prepared to crate from your vehicle.
- Dogs must be on a leash at all times except when competing in the ring. No "Flexi" lines allowed on the property.
- Please keep your dog under control and out of other dogs 'faces', give other dogs the room they may require.
- Please pick up after your dog's waste. Please pick up after yourself. There are waste containers for your trash.
- Please do your best to keep barking to a minimum.
- No smoking, vaping or Cannabis anywhere on the property.**
- Per CKC rules, only dogs officially entered and competing are permitted within the Trial Precincts.
- Per CKC rule 6.7.3 "There shall be no intensive or abusive training of dogs within the venue of the trial." The "venue" being the entirety of The Poodle Farm property.
- Rally course maps will be posted outside, paper copies will be available only by request. Check on arrival for on-line course maps that you can view on your device from the comfort of your vehicle.
- Outdoor shade/rain tents may be setup on any grassy area in the event of inclement weather.
