Only dogs entered in the Trials will be allowed in the building.

**GENERAL:** We ask that all attendees show respect to all exhibitors, AOG club volunteers, stewards, Judges and the venue. Disrespect of Trial participants, volunteers, and officials will not be tolerated. We ask that you also respect the health of others, and do not attend if you or your dog(s) are presenting with symptoms of a communicable illness. You are responsible for picking-up after your dog, and will be asked to leave the Trial if you do not.

**Note to Exhibitors:** The 2025 CKC Obedience Rules are in effect. Significant changes have been made to the Pre-Novice, Novice and Open classes. Pre-Novice and Novice Handlers will require a 1.8M (approx. 6ft.) leash for the group stay exercises. There is now only one stream of Open classes (A&B), which no longer include group stay exercises. Handlers are responsible for familiarizing themselves with the 2025 rules and any changes that affect them.
