Pre-entry: (up to June 1, 2018)
\$20.00 1st dog, \$18.00 2nd and subsequent dog

Post-entry: \$25.00 per dog

OTHER FEES

\$10.00 CKC listing fee for all non-CKC registered dogs (includes 5% GST)
\$25.00 fee for NSF cheques

THERE IS A WAIVER FORM IN THIS PREMIUM LIST THAT MUST BE SIGNED AND WHICH MUST ACCOMPANY YOUR ENTRIES OTHERWISE THEY WILL NOT BE ACCEPTED.

ELIGIBLE BREEDS: The Chase Ability Program participation is open to all purebred and mixed-breed dogs at least 12 months of age that are individually registered with the CKC; or have an Event Registration Number (ERN); or have a Performance Event Number (PEN); or eligible for registration with the CKC; or have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed; or have a Canine Companion Number (CCN) if it's a mixed breed.

Dogs with Breed disqualifications are eligible to enter.

Females in season may not enter.

A dog may enter only once per test.

Running order determined by order in which entries are received,

Dogs run in singles (by themselves)

RIBBONS:

Gold Qualifying ribbons will be awarded to dogs passing their test.

300 YARD COURSE

This distance is for dogs shorter than 12 inches at the withers or brachycephalic (flat faced) dogs. The CKC has determined the following breeds are brachycephalic.

- Affenpinscher
- Boston Terrier
- Boxer
- Brussels Griffon
- Bulldog (all breeds)
- Chihuahua - Apple-Headed
- Chow Chow
- English Toy Spaniel
- Japanese Chin
- Lhasa Apso
- Pekingese
- Pug
- Shih Tzu
- Shar-Pei
- Tibetan Spaniel

600 YARD COURSE

This distance is used for all dogs that do not run the 300 yard course.

IF THERE IS A QUESTION AS TO WHICH COURSE A DOG SHALL RUN THE JUDGE SHALL DECIDE.

ATTENTION EXHIBITORS:

- There will be a \$10.00 fine for dogs loose on the field or in the area of the event other than the dog running the course.
- Dogs will be run once per test.
- Lame dogs or bitches in season will be excused and their entry refunded, provided notice is given prior to or during roll call.
- Dogs not present at roll call shall be scratched with no refunds. No exceptions.
- Muzzles and catch collars may be used at the handler's discretion. **NO FLEXI LEADS, SHOCK COLLARS OR PRONG COLLARS ALLOWED.**
- Catch collars must be free of any item that could become entangled in the line (eg: tags)
- A veterinary clinic is located in the town of Portage la Prairie.
- There is plenty of parking. Bathrooms available.
- Lots of room for crates but bring shade for your dogs and plenty of water.
- People are expected to clean up after their dogs. There will be a \$10.00 fine for caught NOT cleaning up after their dogs.

DIRECTIONS TO THE FIELD

Traveling West from Winnipeg: Head west on Trans Canada HWY #1 towards Portage la Prairie for approximately 55 km (from West Perimeter).

Turn left onto HWY 13 (south). There are signs for Oakville/Carman.

After 2.5 km turn right (west) onto HWY 331. There is a sign for Newton.

Park entrance is on the left hand side (south) very near this intersection.

Traveling East from Portage la Prairie: Head east on Trans Canada Hwy #1 towards Winnipeg. It is approximately 32 km from the CanadInn to HWY 13.

Turn right onto HWY 13 (south). There are signs for Oakville/Carman.

After 2.5 km turn right (west) onto HWY 331. There is a sign for Newton.

Park entrance is on the left hand side (south) very near this intersection.

To hold the Manitoba Gazehound Association including their members, directors, officers and employees (collective defined as the "MGA"), as well as the owner and lessor of the real property on which the event is held, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of myself or my dog(s) while in or about the event premises or grounds near the entrance thereto and I assume all responsibility and liability for any such claim;
2. To hold the MGA harmless from any claim for loss of this dog by disappearance, theft, death or otherwise and from any claim for damage or injury, even if such loss or damage/injury was caused or alleged to be caused by negligence of the MGA or by the negligence of any other person for any other cause(s).
