

### Directions to Pine Point Arena

# Rally Obedience Rules

1. Swansea Dog Obedience Club will use care and diligence for the welfare of all dogs and exhibitors, but will not be responsible for, nor assume liability in the event of, an accident or misfortune however caused to dogs, exhibitors or property. Dogs must be kept under control at all times.
2. There is no limitation on the number of trials at which a dog may be entered as a 'listed dog', except that a dog which has obtained three qualifying scores at obedience trials held under C.K.C. rules, may not continue to compete at licensed obedience trials held under the Club's rules until the dog is registered individually with the C.K.C. Foreign born and owned dogs, please refer to Event Registration Number (ERN) information listed elsewhere.
3. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at a Rally Obedience Trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
4. Moving Up - A dog that is registered in the records of the CKC or has a PEN, an ERN or a MCN and has fulfilled the requirements for a title in accordance with the rules may be moved to the next level of competition. The transfer must be submitted to the trial secretary on the appropriate move-up form by the owner or handler 15 minutes before the start of the class, schedule permitting.
5. To comply with CKC regulations, no entries may be accepted, altered, cancelled or substituted after the official closing date and time for entries except for as provided in the CKC Rules.
6. These events held under the rules of The Canadian Kennel Club
7. Bitches in season are not permitted to compete. Refunds for bitches in season will be given provided the exhibitor supplies a veterinary certificate stating that the bitch is in season after the closing date of the trials. This certificate must be presented to the Trial Secretary prior to the commencement of judging for the day.
8. The listing fee for a dog not registered with the CKC is \$9.50 per trial (includes HST). A dog must be listed unless it has an individual registration number or an Event Registration Number (ERN) issued by the CKC. Only dogs eligible for registration with the CKC are eligible to compete at these Trials. Failure to obtain an ERN within 30 days of the event will result in any scores being cancelled by the CKC. Please note that dogs are not allowed to compete above the Novice level without a CKC registration number or an ERN. Applications for an ERN can be obtained from the CKC.
9. Non-member participation fee – an annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice to either become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.
10. Only those dogs entered in the Trials will be allowed within the precincts of the trial. This area includes the obedience floor, the arena stands and surrounding concrete areas outside the arena boards and glass enclosure.
11. Exhibitors should follow their veterinarians' recommendation to ensure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.
12. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of and will comply with the CKC Rally Obedience Trial Rules & Regulations, effective January 1, 2015.

# Rally Obedience Classes

- Rally Novice A** Dogs competing in this class may not have won a CKC Rally Novice (RN) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC CDX title or instructed dog training classes shall be eligible for this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate family. A person may enter more than one dog in this class. All exercises are judged on leash and dogs must enter and leave the ring on leash.
- Rally Novice B** Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. All exercises are judged on leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.
- Rally Intermediate** This class is elective and shall be for dogs that have earned the R.N. title. A dog completing the R.I. or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.
- Rally Advanced A** For dogs which have won the title of RN in Canada, but have not won the title RA (Rally Advanced) or any CKC Novice Obedience Title. No handler who has exhibited a dog through its CKC CDX title or instructed dog training classes shall be eligible for this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. All exercises are judged off leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.
- Rally Advanced B** This class shall be for dogs that have won the Rally Novice (RN) title. The owner or any other person may handle dogs in this class. All exercises are judged off leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.
- Rally Excellent A** This class will be for dogs that have won the Rally Advanced (R.A.) title but not the Rally Excellent (R.E.) title or any CKC Novice Obedience title. No handler who has exhibited a dog its through the CKC CDX title or instructed dog training classes shall be eligible for this class. A dog may not be entered or exhibited in this class after official notification from the CKC that the dog has won the title (R.E.). No dog may be entered in both Rally Excellent A & B at one trial. The handler of any dog in this class must be the owner, co-owner or member of their immediate family. All exercises are judged off leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.
- Rally Excellent B** This class will be for dogs that have won the Rally Advanced (R.A.) title. A dog completing the Rally Excellent (R.E.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

High Scoring Veteran Dog (7 yrs old or older) -----Trials 127/128 & Trials 129/130

High Scoring Swansea Member -----Trials 127/128 & Trials 129/130

**High in Trial:**

The High In Trial dog for Saturday in trial 127 and trial 128 will receive a special rosette and trophy. The High in Trial dog for Sunday in trial 129 and trial 130 will receive a special rosette and a complimentary 8x10 photograph with our Trial photographer, as well as a picture frame.

- Novice C and Novice Intermediate class winners are not eligible for High in Trial or Special Awards.
- Special awards will be presented at the end of the trials on each day. All winners or their designated agent must be present to receive these awards.
- All trophies and awards must be picked up by the end of the last trial on Sunday May 29<sup>th</sup>. None will be mailed. Trophies or awards not picked up become the property of the Club.

# Obedience Rules

1. The Swansea Dog Obedience Club will use care and diligence for the welfare of all dogs and exhibitors, but will not be responsible for, nor assume liability in the event of, an accident or misfortune however caused to dogs, exhibitors or property. Dogs must be kept under control at all times.
2. A judge officiating at an Obedience Trial held under these Regulations shall not be subject to indignities of any kind during the progress of the Obedience Trial, and it shall be the duty and obligation of the Club holding the Trial to see that this Regulation is effectively carried out. The Obedience Chairman shall promptly report to the CKC any infringement of these Regulations, and the Discipline Committee shall have the power to take action as it deems fit, on receipt of a report indicating that this Regulation has been violated.
3. Bitches in season are not permitted to compete. Refunds for bitches in season will be given provided the exhibitor supplies a veterinary certificate stating that the bitch is in season after the closing date of the trials. This certificate must be presented to the Trial Secretary prior to the commencement of judging for the day.
4. The listing fee for a dog not registered with the CKC is \$9.50 per trial (includes HST). A dog must be listed unless it has an individual registration number or an Event Registration Number (ERN) issued by the CKC. Only dogs eligible for registration with the CKC are eligible to compete at these Trials. Failure to obtain an ERN within 30 days of the event will result in any scores being cancelled by the CKC. Please note that dogs are not allowed to compete above the Novice level without a CKC registration number or an ERN. Applications for an ERN can be obtained from the CKC.
5. Non-member participation fee – an annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice to either become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.
6. One dog only may be entered in the Novice "A" and Open Class "A" by any one exhibitor, who must handle the dog in all exercises. Every dog in these classes must be handled by its owner or a member of the immediate family. No licensed handler, trainer, nor any person who has previously exhibited a dog through its utility degree in Canada or elsewhere shall be allowed to compete in these classes.
7. Novice "A" is for dogs and handlers where the dog has not achieved a CD title and the handler has not put a CDX title on any dog. Novice "B" is for dogs and handlers where the dog has not achieved a CD title and the handler has put a CDX title on any dog. Novice "C" is for any dog which has earned a CD, CDX, UD or any obedience trial championship title prior to the closing date of the trials. A dog eligible for entry in the Open or Utility classes is also eligible for entry in the Novice "C" class at the same trial. Novice Intermediate is for dogs which have earned the title of CD, CDX, UD or any obedience trial championship. Dogs entered in Novice C or Novice Intermediate classes are not eligible for High in Trial awards.
8. Open "A" is for dogs and handlers where the dog has achieved a CD title and not achieved a CDX title and the handler has not put a UD title on any dog. Open "B" is for dogs and handlers where the dog has achieved a UD title, and for dogs and handlers where the handler has put a UD title on any dog.
9. Utility "A" is for dogs and handlers where the dog has achieved a CDX title and not achieved a UD title, and for dogs and handlers where the handler has not put a MOTCH title on any dog. Utility "B" is for dogs and handlers where the dog has achieved a CDX and a UD title, and for dogs and handlers where the handler has put a MOTCH title on any dog.
10. If any exhibitor enters more than one dog in the Novice B or Open B classes, he/she must have an additional handler for each additional dog when they are judged together in the group exercises.
11. Only those dogs entered in the Trials will be allowed within the precincts of the trial. This area includes the obedience floor, the arena stands and surrounding concrete areas outside the arena boards and glass enclosure.
12. Exhibitors should follow their veterinarians' recommendation to ensure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.
13. The Obedience Trial Chairperson shall have full control of the Trials.
13. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of and will comply with the CKC Obedience Trial Rules & Regulations, effective January 2015.
