US CHEQUES WILL BE ACCEPTED IN US FUNDS AT PAR. In payment of entry fees, the tendering of NSF cheques shall be considered non-payment of entry fees, and is punishable by disciplinary action and cancellation of awards. A collection fee of \$30.00 will be added to the amount of any returned cheque. Telephone entries are not accepted. Incomplete entries or entries received after the advertised closing date will not be accepted. There will be no refund on overpayments or duplicate entries. Please mail entries early to ensure that they are received before the closing date.

**DIRECTIONS TO SHEEP THRILL FARM** - map available on [www.sheepthrills.ca](http://www.sheepthrills.ca) and Google maps. From Saskatoon, go west on 22nd Street on Hwy 14. Turn left (south) at the Sandyridge Gas station, onto Young Road. Go 1 mile to the stop sign, then turn right (west) onto the paved road. Go about a mile, Sheep Thrills is the last place on the left hand side just before the train tracks. Signs will be posted.

**PLEASE PICK UP AFTER YOUR DOG!!!** Dogs must be on leash when not in the arena or the designated exercise area. There is other livestock on the premises, please control your dog, close gates behind you if you find them close, leave them open if you find them open.

### Non-Member Participation Fee :

An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply with in 30 days of notification will cause all awards and titles to be cancelled.

**Attention Foreign Exhibitors:** ERN numbers must be applied for within 30 days of the first day of entering a CKC event. A CKC ERN registration form can be downloaded from the CKC website: <http://www.ckc.ca>

**Section 18.1 of the CKC Herding Rules states:** The CKC shall not be responsible to any member, person, partnership, club or corporation for any loss, damage or injury arising at or by reason of any herding trial held under any rules adopted by the CKC.

**Section 15.7 of the CKC Herding Rules states:** It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward volunteer or competitor at a Herding Trial held under these regulations, is not subject to indignities of any kind. The Herding Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.
