

Canadian residents only Effective Jan 01 2011 the Canadian Kennel Club instituted a non member participation fee for all Canadian residents who Participate in a KC event , but are not CKC members. In order to protect titles/awards earned the non-member will have a choice. Either to be a CKC member or pay the Non member Participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. This applies to dogs wholly owned by non members who reside I Canada and does not apply to US exhibitors or CKC members or dogs co-owned with a CKC member

#### **IMPORTANT NOTICE:**

Effective July 1998, hounds entering their first trial in Canada must be tested with another dog, not a kennel mate, and certified running clean by a licensed judge. The CKC Hound Certification form (included with this premium list) must be completed and submitted with their entry at the hound's first trial. Hounds with the following are exempt: ASFA F.Ch. or LCM, AKC F.Ch., S.C. or D.C., but are still required to submit the Hound Certification form with their name and exempt title(s) circled.

US owned dogs may compete with an Event Registration Number. This number must be obtained within 30 days of obtaining points, awards, or scores to avoid cancellation. An ERN can be obtained by submitting a copy of your AKC registration with a letter of request to the CKC offices. Fee is \$58.85(request may be faxed using VISA). An \$8.52 listing fee per trial is payable for each dog not showing a CKC or ERN registration number.

#### **ADDITIONAL INFORMATION:**

- •Stakes will be split if the entry in any breed reaches 24 or more at Roll Call.
- •Bitches in season/lame hounds will have entry fee refunded provided notice is given at or before Roll Call.
- Dogs not present at Roll Call will be scratched and entry fee not refunded. No Exceptions.
- Hounds will be run twice, in braces or trios (unless dismissed, excused or disqualified.)
- •All handlers must use a slip lead when releasing a hound. A Standing Start will be used on Tally-Ho.
