

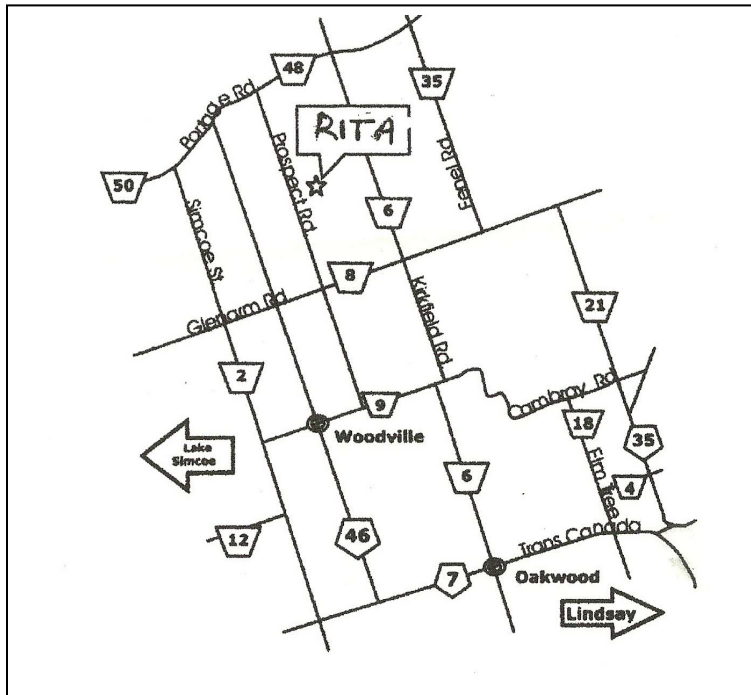
DIRECTIONS:

The show grounds are located at **1374 Prospect Road**, north-east of Woodville, Ontario. Look for signs on routes as you get close to the site.

From the East, follow Highway 7 west of Lindsay approximately 10 km to the hamlet of Oakwood. Turn north (right) at the traffic lights in Oakwood and follow the Oakwood Road to a "T" junction. At the "T" junction, turn left onto Woodville Road 9. Drive approximately 2.4 km (1.5 miles) and turn north (right) onto Prospect Road. Follow the road north to show grounds (**1374 Prospect Road**), located on the east (right) side of the road.

From the West, follow Highway 7 east to the hamlet of Oakwood. Turn north (left) at the traffic lights in Oakwood and follow the Oakwood Road to a "T" junction. At the "T" junction, turn left onto Woodville Road 9. Drive approximately 2.4 km (1.5 miles) and turn north (right) onto Prospect Road. Follow the road north to show grounds (**1374 Prospect Road**), located on the east (right) side of the road.

From the North, follow Highway 12 south and turn east (left) onto Highway 48 East. Drive through Bolsover. Turn south (right) onto the third road on the right (Prospect Road). Drive approximately 2.4 km (1.5 miles) to show grounds (**1374 Prospect Road**), located on the east (left) side of the road.

<p>MOVING CLASS DOGS TO SPECIALS</p>	<p>Chapter 8, Section 8.9 of the Conformation Show Rules and Regulations has been amended to allow a dog which is individually registered in the records of the Canadian Kennel Club, and has completed the requirements for a Championship, after the Closing Date for entries for a show, may be transferred from one of the Regular Classes to "Specials Only", providing the request for a transfer is submitted to the Show Secretary in WRITING at least one hour prior to the opening of the show, by the owner or handler. Every day of a 2 or 3 day show is a separate show. Please note that this rule is effective up to one hour prior to the opening of the show, NOT one hour prior to the judging of the breed.</p>														
<p>ERN (EVENT REGISTRATION NUMBER)</p>	<p>ERN (Event Registration Number) Effective as of January 01, 1992, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC Registration Number, BUT, will require an ERN (Event Registration Number). The ERN MUST be applied for within 30 days of the first day of entering a CKC event.
