It shall also within ten days after the trial, report to the CKC the nature of the alleged indignity, the names of the parties concerned and it’s findings. the Discipline Committee of the CKC shall have the power to take such action as it deems fit on receipt of the report indicating that this rule has been violated.

DEFINITION OF STAKES

- PUPPY For dogs 6 month of age but not over 1 year on the day of the trial
- JUNIOR For dogs not over 2 years on the day of the trial
- QUALIFYING For dogs how have never won 1st, 2nd, 3rd, 4th or a certificate of merit in an Open All Age stake nor a 1st, 2nd, 3rd, or 4th in an Amateur All Age Stake nor have won 5 Qualifying's
- OPEN ALL AGE For dogs over 6 months of age
- AMATEUR ALL AGE For dogs over 6 months if handled by a person deemed an Amateur by the Field Trial Committee
