ENTRIES LIMITED TO 45 RUNS

This event will be held INDOORS and OUTDOORS (outdoors for exterior searches only). If you are crating your dogs in your vehicles, you must provide adequate ventilation and water or adequate warmth/protection if the weather is inclement. Please be prepared for any kind of weather. The trial will go on regardless of the weather unless it is deemed unsafe to continue.

THERE WILL BE INDOOR KENNELING AND INDOOR WASHROOM FACILITIES. THE WASHROOMS CANNOT BE USED DURING THE START OF THE TRIAL AND DURING THE ACTUAL PHYSICAL SEARCHING OF A DOG IN THE TRIAL IN ANY OF THE ROOMS. WE ASK THAT IF YOU ARE USING INDOOR KENNELING THAT YOU ARRIVE EARLY –LIMITED KENNELS TO BE USED IN THE DAY CARE AREA OF THE STORE – YOU MUST ENSURE THAT YOU CLEAN OUT YOUR KENNEL AT THE END OF THE MATCH. IF YOUR DOG IS MAKING NOISE DURING THE SEARCHING OF ANOTHER DOG YOU WILL NEED TO REMOVE THE SAID DOG TO YOUR VEHICLE.

ELIGIBLE PARTICIPANTS:

Every dog entered in an approved event or sanctioned match must be one of the following:

- (a) Registered with the CKC
- (b) Have an Event Registration Number (ERN)
- (c) Have a Performance Event Number (PEN)
- (d) Eligible for registration with the CKC, and have a Temporary Competition Number (TCN)
- (e) Have a Miscellaneous Certification Number (MCN) if it belongs to a CKC listed breed
- (f) Have a Canine Companion Number (CCN)
- (g) Must be a least 6 months of age
- (h) May be spayed, neutered or debarked
- (i) Must not be lame (it is judge's responsibility to determine whether a dog is lame)
- (j) Must not compete if it has tape or bandages that may impair its working ability (such a dog must be immediately excused and under no circumstances may it be returned later for judging after the tape or bandages have been removed)

Entries shall not be accepted from any person who is not in good standing with The Canadian Kennel Club on the day of entries closing.

RECEIPT OF ENTRIES AND ASSIGNMENT OF POSITIONS

We will be accepting entries by email and mail only. No telephone, faxed or couriered entries will be accepted.

Once the advertised limit has been reached, all remaining entries will be assigned a position (BY CLASS) on the "Alternate List" in the order that they are received. On closing date the club will notify all applicants by **email** of their entry in the test or on the Alternate List. Any day of entries received will go last in their respective class.

Dog Show Rule books - Scent Detection Test regulations are available from the Canadian Kennel Club via their website or you may order a hardcopy at a cost. The Match Superintendent will be in full charge of the show, which will be governed by CKC rules.

REFUNDS

After the respective tests have been filled, entries are automatically closed even though the published "Closing Date" may not have been reached. An entry received after entries have closed (but before the posted closing date) will be assigned a position on the Alternate List. If a dog is withdrawn after entries are closed, **refunds will only be permitted where there is an "Alternate" available and actually fills the vacancy on test day.** Anyone on the "Alternate List" may request a refund at any time prior to test day. Entry fees will be refunded within 10 days following the test for those on the alternate list who did not participate in the test.

BITCHES IN SEASON ARE NOT ALLOWED TO COMPETE

Bitches in Season are not permitted to compete. The judge of an event must remove from competition any bitch in season, or any bitch, which appears attractive to males as to be a disturbing element. Please see Rule 6.5.

DISCLAIMER OF LIABILITY

In attending this test, competitors, spectators and guests acknowledge they do so at their own risk and that of any dog. They also agree they will not hold liable the C.K.C., Rottweiler Club of Canada Especially For Pets (employees/clients/guests), test officials, the Judge or the land owner(s) for any loss, damage or injury, however arising, to themselves, their dog(s), or any chattels.

DISCIPLINE-INDIGNITIES (Rule 14.7)

It shall be the duty and obligation of the testgiving club to see that a judge, club official, steward, volunteer or any competitor at a Scent Detection event held under these regulations, is not subject to **indignities** of any kind. The Event Chair shall promptly report to CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
