Directions to Komoka Top Dogs Obedience Club

From Toronto: Take 401 west to 402 exit 82 (Cty Road 14 Glendon Drive/Komoka/Mt Brydges). Turn left onto 14 at stop sign. Proceed north until you get to lights at 14 and Vanneck Road (Home Hardware is on right). Turn left onto Vanneck Road. As you start up first grade it is on the left at 20215 Vanneck Road.

From Windsor: Take 401 East, Exit 157 Road 14 Iona Road, Melbourne, Iona. Turn left towards Melbourne on County Road 14. This will change to County Road 9. Follow through Melbourne, second road is Glendon Drive. Turn Right onto Glendon Drive and follow through Mount Brydges and Komoka until you get to lights at Glendon Drive and Vanneck Road, Turn left onto Vanneck Road. As you start up first hill it is on the left at 20215 Vanneck Road.

From North: Take Vanneck Road South to 20215 Vanneck Road. Facility is on your right as you descend hill.
