Closing date: Day of trial or automatically when time limit has been reached. Please note: The trial may fill very quickly. To ensure your space, we recommend that you complete your entry via EMAIL. On site entries accepted *if* space is available.

Limit: When estimated time allotment is reached to a maximum of 150 runs per day including SpeedStakes, maximum of 1 dog per handler.

Entry: Accepted on a first come, first served basis. In order for your entry to be processed we must receive both the payment and form. (Please note confirmations of entry will not be emailed between February 7-14 due to company holidays. We will process any entries received during that time upon our return)

Payment: Accepted methods of payment will be – Email money transfer, money order or cheques only.
Separate entry forms must be completed for each dog entered, however, payments may be combined.

Payment (For US competitors): PayPal will be accepted for those competitors in the United States who do not have access to Email money transfer. All PayPal payments must be sent in Canadian dollars and are subject to an additional \$10 fee per transaction. Please send payment to quintecanine@hotmail.com

Running Order: will be determined by random draw prior to the trial date. The run order will be emailed to entrance prior to the trial date but is subject to change up to and including the date of trial. The final run order will be posted the day of trial. Bitches in heat are allowed to compete, and will run last in each component level. We ask that you notify us ASAP if your bitch is in heat so that we can adjust the running order. Bitches in season must wear panties at all times on trial grounds.

SpeedStakes: On site entries, will be accepted if time allows. A maximum of 20 dogs will be entered into each SpeedStakes offered (20 dogs maximum accepted pre-trial for Saturday and 20 dogs maximum accepted pre-trial for Saturday). Entry is \$15 per dog and cash prizes will be awarded. 1st place receives up to \$75, 2nd place receives up to \$50 and 3rd place receives up to \$25. Prize money award will be determined by number of entries received. Please note this is not an SDDA titling class.

FEO: FEO dogs are entered as entries but should the trial fill their spaces may be removed to allow titling dogs to enter. In this case competitors will be notified prior to trial date and a full refund will be provided.

Refunds for Medical Reasons: entry fee refunds will be given for any dog withdrawing for medical reasons. A Veterinary Certificate must be submitted before the start of the trial.

Refunds for Other Reasons: If a dog is removed from the trial prior to the trial date and a substitute person on the waiting list is able to fill the space (if trial fills) a refund will be provided less a \$5 per component fee. Refunds will not be issued for persons who do not show up to the trial.

Awards: Qualifying ribbons will be presented per component and rosettes for titles. We will be issuing additional awards for such areas as time and score which will be announced after all competitors within the level have been judged. There will be a High in Trial rosette and prize.

Food: There will be no food available on site. (A few restaurants are within a 2-minute drive)

Trial Grounds: These trial grounds back onto the beautiful Lower Trent Trail/Hasting Heritage Trail. Should you need to walk or exercise your dog please note that you will be on public property and must obey leash laws.

Crating: There will be no indoor crating available. Please be prepared to work from your vehicle. Feel free to bring portable tents if they can be secured.

Hotel Accommodations: Ramada Inn Trenton (less than 10 minutes from trial site) – 99 Glen Miller Rd, Trenton ON K8V 5P8 613-394-4855. A special rate has been arranged for participants of the trial who quote group rate “Quinte Canine”. The special rate deadline for hotel confirmation is Friday April 7th, 2017. Rooms are limited.

SDDA Notes:

- 🐾 This titling event is being held under the rules of Sporting Detection Dogs Association (SDDA). Open to all breeds and mixes. Dogs must be registered with the SDDA and be over six months of age.
- 🐾 Unofficial scent is not permitted on the trial site.
- 🐾 Separate entry forms **MUST** be completed for EACH dog entered, however, payments may be combined.
- 🐾 Dogs must be under control at all times. Please keep barking to a minimum and pick up after your dogs. All dogs must be on a leash at all times when not in the search area. All dogs must be on a flat collar or search harness in the search area. Leashes must be cloth or leather of any length in the search area.
- 🐾 Any handler displaying inhumane or aggressive treatment toward any dog, the public, or others at the trial (including but not limited to: physical and verbal) will be asked to leave the property without refund of fees.
- 🐾 Competitors, through the submission of their entries, acknowledge that they know the Rules and Regulations. See Master Rule Book on the SDDA web site www.sportingdetectiondogs.ca to familiarize yourself with all rules.
