Conformation



Jeff Horswell (Drakesleat)

Jeff has been going to dog shows from an early age. It all started when his mother (Ann Foxwell) decided that a Great Dane was the ideal breed for a family pet, and they then decided to go along to a local show.

A 'show' Dane followed, and the Auldmoor Great Dane kennel produced a large number of Champions, both in the UK and around the world, including the #1 in USA.

Jeff decided to have Miniature Wire Dachshunds as his own breed. 23 Min Wire Champions have been made up by him, including 3 Crufts BOB winners and 4 group winners.

Jeff has always had an interest in many breeds and has also made up a Greyhound Champion and 2 Field Spaniel Show Champions, along with winning Reserve CCs with a Basenji and Soft Coated Wheaten Terrier. He

currently shares his home with Champion Whippets.

Jeff first judged in 1982, and first awarded CCs in 1989, at the Scottish KC, to Wire & Min Wire Dachshunds. He judged Min Wires at Crufts in 2000, his first Hound Group in 2000 and BIS in 2003. Jeff is approved to award CCs in over 190 breeds across all 7 UK groups. He judged Best in Show at Crufts in 2017 and has also judged the Hound and Pastoral Groups at Crufts, with an invitation for the Working Group.

Jeff has judged many parts of the world including Sweden, Finland, Denmark, Norway, Iceland, Russia, Australia, New Zealand, Estonia, Latvia, Switzerland, Spain, Portugal, Italy, Holland, Belgium, Hungary, Croatia, Slovenia, Poland, Romania, Slovakia, Czech Republic, Ireland, USA, Canada, Japan, South Korea, Argentina, Colombia, Uruguay, Chile India, South Africa, Trinidad & Barbados.

Previously a member of the UK Kennel Club Board he is now a member of the Breed Standards and Vice Chairman of the Judges Committee.



Ken Murray

Ken Murray showed his first dog in 1959 at the Texas Kennel Club and that became the beginning of a lifelong love of the Irish Setter breed and the sport of showing dogs.

During his teenage years, growing up in Dallas, Texas, he handled the finished numerous Irish Setters for the famous Draherin kennels and English Springer Spaniels for LeeVee Kennels.

In 1968, he was granted a professional handler license from the AKC, but gave it up a year later to move to Chicago to work as an assistant handler for the legendary Dick and Ruth Cooper. Ken won 23 BIS's and a Kennel Review "Winkie" award for Best Assistant Handler in his first few years with the Coopers. In 1978 he met his wife Virginia and they started their own successful handling business.

They showed many big winning dogs over the years and won four Top sporting Dog of the Year awards. Mr.

Murray handled the Gordon Setter, Ch. Bit 'O Gold Titan Treasure, to three consecutive Sporting Group wins at Westminster Kennel Club in 1997, 1998 and 1999.

In 2005, he retired from handling to concentrate on his boarding kennel business and judging. He currently judges the entire Sporting, Hound, Working and Toy groups and the majority of the Non-sporting group.

He has judged in U.S., China, Japan, Columbia and Mexico.

He and his wife, Virginia, currently live in Island Lake, Illinois with several Portuguese Water Dogs.



Cheryl Patterson

I started showing and breeding Alaskan Malamutes under the "Terrapin" Registered prefix back in 1990.

We have bred over 45+ Canadian, American, European, Australian and Mexican Champions. Over the years we have been involved in obedience, backpacking and sledding as well as conformation

Wanting to have something different to show, I bought our first Saluki in 2006, and we now have three of them which have taken over our household. We enjoy Lure coursing with them as well as conformation. I have owned one of the top Salukis in Canada for the past two years, this past year our Saluki went Best of Opposite at our Canadian National Specialty over a lovely entry. We show our Salukis in conformation in Canada and the United States.

I am an all breed judge and have been licensed by the Canadian Kennel Club to judge since 2006. I have had the honour of judging several breed Regional and National Specialties in Canada as well as in many different

countries.

I have judges in Canada, United States, Brazil, Estonia, Australia, England, Ireland, France, Spain, Japan, Korea and the Czech Republic.



Ramón Podestá

Mr. Ramón Podestá has been involved in pure breed dogs since his childhood. At the early age of twelve he finished his first champion dog. And at age seventeen he founded his world famous Von Hausman Kennel.

Ramon has owned and bred a record number of champions in Latin America North America, England, International and World Champions.

Breeder of Best In Show winners in the following breeds: German Shepherd, Afghans Hounds, Beagles, Whippets, Borzoi, Old English Sheepdog, Doberman, Rottweiler, Dachshunds, Chow Chow, Irish Setter, Weimaraner, Dalmatian, Maltese, Pekingese, Standard Poodle, Miniature Poodle and Siberian Husky, Shiba Inu, English and American Cockers .

Breeder of Top Dog All Breed in Chile during the last four decades, having great success around the world make him top breeder in Latin America

He is a former member of the Scientific Committee of the FCI serving three terms and is a past President of the Kennel Club of Chile. He founded the Pekingese Club and Working dog Club of Chile. And honorary member of Kennel Club of Chile.

All breed judge since 1978, he has judged in different continents and important Shows like World Dog Shows, European Dog Shows, Royal Shows, Asian International Dog Shows, National Shows in America.

In resume have had the privilege of judge around the world.



Bea Sawka

Bea has owned, bred and handled Bearded Collies since obtaining her first dog in 1976 and has bred over 200 Champions in many countries. Her Beardies have won more than 70 BCCA & BCCC Annual Awards, numerous Specialties including 20 National Specialties and approximately 120 All Breed Best In Shows.

She bred, owned and handled Canada’s Top Dog All Breeds in 1997 – Harrison, Can.Am.Ch. Classical Image Of A Legend. She has had the Top Winning Beardies in Canada and the US on numerous occasions including the #1 Beardie in the US and the #1 Beardie in Canada in 2015. Most recently, #1 Beardie in Canada in 2022 and #3 in the US in 2023 in only 3 weekends of shows.

She has owned and bred many outstanding dogs that have gone on to be the foundation of some of the most successful Bearded Collie kennels around the world.

In 2003 she obtained our first Havanese and now shares her home with several of them.

She also co-owns the #1 Pointer In Canada 2018, 2019 & 2020, Stewart, MBIS, Can.GchEx.Am.Ch. Seasyde Some Guys Have All The Luck and the #1 Pointer in Canada in 2021 & 2022, Riggs, Can.Am.Gch Seasyde Casino.

She began judging in 2012 and has judged in several countries including both the Canadian & American Bearded Collie Club National Specialties.

I just recently (this August) retired from handling and moved across the country to Nova Scotia to be near my new granddaughter and am looking forward to new adventures and my path to becoming a CKC judge.



Brian Proctor

I have a long-standing relationship with Labradors. I got my first Labrador in 1960 when I was only days old. Pat was my constant companion for the first 13 years of my life and really is the start of my love affair with dogs in general and Labradors in particular. Of course, Pat was a black bitch. My family also had an Irish Setter, Toy Poodle, and a few shepherd/husky crosses growing up. My love for dogs likely comes from my father who was a letter carrier for the post office. He often had dogs that would wait for him at the bus stop and would accompany him on his delivery routes every day before returning home.

I had a long career as a meteorologist with Environment Canada and was transferred frequently. When we were transferred to Vancouver in 1993, we decided to get a registered dog. We contacted numerous breeders across Canada and Washington State. We settled on a chocolate female puppy bred by Linda

Squires and Nina Mann, Ch Sunnydaze Western Skye CD. This was the start of our journey in the Pure Breed dog fancy.

After having a few very successful litters we were fortunate to meet Mary Wiest (Beechcroft Labradors) and we imported a 9 week old black bitch puppy who became Am/Can Ch MBOSS Beechcroft Rumor Has It WC out of Beechcroft and Lindall lines. Rumor went on to BOS at the 2001 National Specialty, as well as numerous other specialty wins including best gun dog at the 2005 National Specialty. Rumor and then later her cousin Pride (Am Can Ch Beechcroft's Pride of High Society) are behind all of the dogs in our household now. We have been fortunate enough to have owned or bred 11 American Champions and many, many more Canadian Champions. Our most successful Labrador in the show ring was MBISS MBPISS Am/Can Grand Ch Cambridge Points North aka Compass. He was BPISS at the National in 2010 and then followed this up by winning the LRCC National in 2014. He was also the number one Conformation Labrador in 2014. We are currently showing a very promising young male MBPISS Can Ch Cambridge's Bam Bam. We are known as primarily breeders of Blacks and Chocobars but have had a few yellows over the years.

When judging dogs, I look for a balance of type and movement; it is important not to lose the purpose our dogs were originally bred for. I have judged sweeps in BC, Alberta, Washington state, and New Jersey.

1. Dog Show Rule books and Obedience/Rally Trial regulations are available from the Canadian Kennel Club.
2. The Show Superintendent will be in full charge of the show which will be governed by CKC rules.
3. ENTRIES WILL BE ACKNOWLEDGED BY EMAIL after entry closing, with receipt, judging schedule and exhibitor passes. If such acknowledgement is not received one week before the show date, please contact the Show Secretary.
4. "It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities" – CKC rule book, Section 19.7.
5. ENTRY FEES SHALL NOT BE REFUNDED AFTER THE CLOSING DATE in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Show Committee, or because it has been entered incorrectly. If because of riot, civil disturbance, or other acts beyond the control of the Club, it is impossible to open or complete the show, no refund of entry will be made.
6. ALL DOGS MUST BE KEPT ON LEASH WHILE ON THE GROUNDS. You are responsible for cleaning up if you permit your dog to relieve itself outside the show building. Failure to do so may result in being expelled from the building for one day's showing by the Superintendent.
7. All empty rings are to be kept free of dogs.
8. SHOW PRECINCTS Show precincts will be entire AG Building at Stampede Park
9. "ALL DOGS MUST BE KEPT UNDER CONTROL AT ALL TIMES." If not in competition the dog must wear a collar and be on leash a maximum of six (6) feet or appropriately confined in the benching area.

EXTRACTS FROM THE DOG SHOW RULES - BREEDS, CLASSES, AWARDS AND STAKES CONFORMATION CLASSES OFFERED:

12.2.1 Regular official classes at a CKC conformation show shall be as described in (a) to (k) of this section. All classes must be divided by sex (except for Specials Only). Only dogs entered in one of the regular, non-regular, or unofficial classes shall be allowed within the show precincts.

JUNIOR PUPPY: shall be for dogs at least six months of age and under nine months of age on the day of the show.

SENIOR PUPPY: shall be for dogs 9 months of age and under twelve (12) months of age on the day of the show.

12-18 MONTH - for dogs over 12 months of age but under 18 months of age.

CANADIAN BRED: shall be for dogs born in Canada, Champions of any country excluded

BRED BY EXHIBITOR: shall be for dogs owned and handled in the ring by the Breeder. The handler must be the owner/co-owner AND breeder/co-breeder of the dog. The owner/breeder must handle the dog in this class but need not handle the dog for further awards.

OPEN CLASS: shall be for all dogs.

SPECIALS ONLY: is for dogs which have a recorded CKC Registration or Event Registration Number and have attained the required points for Championship status including at least one 2-point win either at the breed or group level. Should a dog which is entered in this class be found either not to be registered or has not completed the requirements for Championship status, all awards earned at the show will be cancelled. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex and Best Puppy if eligible.

UNOFFICIAL/NON-REGULAR CLASSES OFFERED

BABY PUPPY Dogs 4 months of age and under 6 months of age on the day of the show. The awards for this class are: Best Baby Male and Best Baby Female Best Baby Puppy in Breed Best Baby Puppy in Group Best Baby Puppy in Show

VETERAN In this optional class for All Breed Shows, dogs must be 7 years of age and over on the day of the show. Dogs entered in this class may be spayed or neutered. The awards for this class are: Best Male Veteran and Best Female Veteran, Best Veteran in Breed, Best Veteran in Group, Best Veteran in Show. A Veteran awarded Best Veteran in Breed is not required to stay to compete for Best Veteran in Group. A Veteran awarded Best Veteran in Group is not required to stay to compete for Best Veteran in Show.

RESERVE BEST IN SHOW: will be selected from the remaining 6 Breeds competing for BIS

Novice A, Novice B, Novice C, Novice Intermediate, Open HA, Open HB, Open 18A, Open 18B, Utility A, Utility B, Pre -Novice, Exhibition Only

RALLY OBEDIENCE CLASSES OFFERED:

Novice A & Novice B, Intermediate, Advanced A & B, Excellent A & B, Masters, Exhibition Only

A Canine Companion Number allows mixed and unrecognized breed dogs to participate in the CKC Performance Events of Agility, Obedience and Rally Obedience Trials. The CCN Application form and information on requirements are available at www.ckc.ca (other Show and Trial Forms).

See OBEDIENCE & RALLY OBEDIENCE TRIAL RULES AND REGULATIONS for complete information on classes.

CHAPTER 4 – JUDGES

SECTION 19.7 It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation,

and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

EVENT REGISTRATION NUMBER Effective Jan/1992 all dogs that are foreign-born and foreign-owned and enter Canada for the sole purpose of entering CKC (Canadian Kennel Club) events will no longer require a CKC registration number but will require an ERN - Event Registration Number. This ERN does not register a dog with CKC for breeding purposes as defined in the Animal Pedigree Act but rather enables a foreign-owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number. To obtain an ERN, mail or fax a photocopy of the dog's foreign registration certificate with cheque or VISA/MasterCard number (expiry date, cardholder's name and signature). Provide your complete address for return of the ERN to you. **Cost is \$64.00.** ERN MUST BE APPLIED FOR WITHIN 30 DAYS OF FIRST DAY OF ENTERING A CKC EVENT. A CKC ERN registration form can be downloaded from the CKC website: <http://www.ckc.ca>

CKC Non-Participation Fee:

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) *"these fees apply only to dogs wholly owned by Canadian resident non-CKC members and are not applicable to CKC members"*

*Please note that the CKC Membership Application and the Non-Member Participation Fee forms are available on the website, <http://www.ckc.ca> under CKC Services and then Forms On-line. If submitting a Membership Application, please ensure that you also complete the Non-Member Participation Fee form so that we are aware of the dogs involved. ***This fee does not have to be paid before entering this show.***

Attention Foreign Exhibitors: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you pay by credit card, bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated.

Entries sent by Courier must be sent prepaid; To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept any entry reaching our Show Secretary after the closing time and date.

Entries sent requiring a signature WILL NOT BE accepted.

Please allow ample time for delays in the mail.

Exhibitors Please Note: An exhibitor has the right to withdraw an entry at any time up to the closing date and time as published in the premium list. This may be done by telephone but **written or electronic notification must be received by the show secretary not later than closing date and time.** If written or electronic notification is not received, the dog will remain entered in the show.

Section 9.9 Effective January 1, 2024

The CKC will not consider a request for any corrections to results if received more than 90 days following the date(s) of the event(s).

Section 19.7

19.7 It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

Entry fees will be refunded when a bitch entered in Rally/Obedience comes into season (CKC Rule 6.5) after the close of entries if a Veterinarian's Certificate (certifying that the bitch was in season within the 10-day period preceding the trial) is delivered to the Show Secretary **before the starting date and the time of the trial**. The Club will refund entry, recording and listing fees if the above conditions are met. No Refunds will be given for the service fees provided by the dogshow.ca

A 50% refund of entry fees only will be made for a bitch in season without a Veterinarian's certificate with written notification presented to the Show Secretary at least ONE HOUR before the start of the Trials for Performance events ONLY. The bitch must be available to be examined by the Show Superintendent to verify she is in season.

There will be no refunds after close of entries on duplicate entries or overpayments.

The Evelyn Kenny Kennel and Obedience Club reserves the right to refuse any entry subject to CKC Conformation Show Rules and Regulations (8.6.1). In consideration of the acceptance of this entry, I (we) agree to be bound by the rules and regulations of the Canadian Kennel Club and by any additional rules and regulations appearing in this premium list.

I (we) agree to hold the Evelyn Kenny Kennel and Obedience Club, their members, directors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim.

I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.

An "In Transit Area" for owner/handlers who are transporting dogs not entered in the show is offered. The dog's information and reason for its presence must be recorded with the Show Secretary and identifying information attached to the dog's crate.

Please note: Dogs shall be exercised only in specified areas provided by the Club. Private exercise pens will be limited.

Dogs should arrive in adequate time for their breed judging (allowing for absentees). It is the responsibility of the exhibitors to have the dog at ringside when the dog's class is scheduled for judging. Waiting for dogs will not be possible and handlers with several breeds must arrange for alternate handlers if judging times for their breeds' conflict.

The Evelyn Kenny Kennel and Obedience Club will not allow the use of spike or pinch collars on its show grounds.

If because of riot, civil disturbance or other acts beyond the control of the Evelyn Kenny Kennel and Obedience Club, it is impossible to open or to complete the show, no refund of entry fees will be made.

The welfare of an exhibitor's child is the responsibility of the exhibitor. It should be understood that exhibitors will exercise control and restraint over their children. The Evelyn Kenny Kennel and Obedience Club will not be responsible for injury to any child whether by accident or any other cause.

ERRORS IN ENTRIES An error in an age-specified class, date of birth or sex, may be amended up to one hour before the start of the breed judging for that breed for that day. Should the owner/breeder be unable to handle a dog entered in the bred By Exhibitor class, the dog may be moved to the Open class (at least one hour prior to the judging of the breed in question). Please note: **The show is a public event, candid photos and/or videos may be taken on the show premises. Such images may be published in print or on a website without your consent. By entering this dog show, you waive all rights to such images and agree that the Evelyn Kenny Kennel and Obedience Club shall not be held responsible for their use.**

MOVING A CLASS DOG TO SPECIALS

A dog that is registered in the records of the CKC or that has a Miscellaneous Certification Number (MCN), or Event Registrations Number (ERN) and has completed the requirements for a championship in accordance with these rules but at the time of the closing of entries for show has not received confirmation of the title, may be transferred from one of the regular classes to Specials Only providing the transfer is submitted to the Show Secretary in writing by the owner or handler at least one (1) hour prior to breed judging. A dog that has a Temporary Competition Number (TCN) is not eligible to be transferred from one (1) of the regular classes to Specials Only.

Please Note – the drive-in doors (overhead garage doors, or oversized sliding barn doors) can not be opened at any time through out the show weekend. There will be 1 Designated garage door that can be opened at the end of each day (after Best in Show), and at lunch on Sunday. Anyone who is found to be removing tape or signs from the doors, or propping man doors open, will be removed from the show, with no refunds given.

Extracts From CKC Dog Show Rules

Chapter 8 Entries and End of Show Section

8.2.5 An error in an age specified class, date of birth or sex may be amended on the entry form up to one hour before the start of the show.

Section 8.3.1 Entries: Every dog entered in a Championship show must be one of the following:

- a) registered with the CKC,
- b) have an Event Registration Number,
- c) be eligible for registration with the CKC, or
- d) if it belongs to a listed breed, it must have a Miscellaneous Certification Number (MCN).

Section 8.4.1 Listed Dogs: If a dog is not registered as in 8.3.1 (a) or (b) but is eligible for registration with the CKC, it may be entered at a show as a listed dog provided:

- b) that if born in Canada, it is eligible for individual registration;
- c) that if not born in Canada, is eligible for registration in the records of the CKC.
- d) that if it is a foreign born and owned dog, an Event Registration Number or CKC registration number is obtain from the CKC within 30 days of the first show entered.

Section 8.4.2 Entry of a listed dog at a show must be accompanied by a listing fee as set by the Board in addition to the regular entry fee.

Section 8.5.1 Acceptance of Entries: If indicated in the premium list, an electronically transmitted entry may be accepted provided the entry is accompanied by a credit card charge authorization.

Section 8.5.3 No entry shall be accepted from or on behalf of any person who is officially known to be expelled, deprived of privileges, debarred or suspended by the CKC or any other registering body for pure bred dogs.

Section 8.5.4 After entries close, no further entries may be accepted, cancelled or substituted other than as otherwise stated in this section or as provided for in case of a postal strike.

Section 8.6.1 Refusal of Entries: The authorities of any show may:

- a) decline to accept entries for just cause, and/or
- b) refuse to receive or may remove any dog from the show building on account of disease or viciousness.
- c) in the case of non-acceptance, refund the fee with the reason for non-acceptance.

Section 8.8.2 Fees: Tendering of a dishonoured cheque or declined credit card in payment of an entry fee shall be considered non-payment of said fee and is an offense punishable by disciplinary action and cancellation of awards.

Section 8.9.1 Moving a Dog to Specials: A dog which is individually registered in the records of the CKC or that has a Miscellaneous Certification Number (MCN) and has completed the requirements for a Championship in accordance with these rules but at the time of the closing of entries for a show has not received confirmation of the title, may be transferred from one of the regular classes to Specials Only providing the transfer is submitted to the Show Secretary in writing by the owner or handler at least one hour prior to the opening of the show.

Section 8.9.2 If it is established that a dog transferred to Specials Only has not completed the Championship requirements, all awards will be canceled and all ribbons and prizes won shall be forfeited. The owner may also be subject to disciplinary action.

Section 8.9.3 When one or more All-Breed and/or Specialty Shows are held on the same day, in the same venue, the moving of class dogs to Specials must be made prior to the scheduled opening of the first show.

Chapter 4 Judges Section 4.1.3 A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out.

Section 4.1.5 No person may approach a judge either directly or otherwise, orally or in writing, to favor his entry. Disciplinary action will be taken against any person who violates this rule or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the act.

Chapter 14 Disqualifying or Excusing Dogs

Section 14.1.2 (a) At his discretion, a judge shall have the authority to excuse or disqualify a dog which menaces, threatens, attempts to bite or bites the judge, another person, or another dog in the ring. When a dog is twice excused on this account, it shall have the status of a disqualified dog.

(b) At his discretion, a judge shall have the authority to permanently disqualify a dog which bites the judge or another person in the ring. Dogs disqualified under this provision will not be eligible for reinstatement. The decision to permanently disqualify a dog must be clearly indicated on the Judge's Disqualification Form.

Section 14.1.4 Once a dog has been disqualified for any reason at a conformation show, it may not be entered or shown at another show until

the dog has been reinstated by the CKC. All awards earned by a dog shown in violation of this section will be cancelled by the CKC and the owner of the dog is subject to disciplinary action. A dog disqualified under section 14.1.2 (b) is not eligible for reinstatement.

Section 14.1.5 Any dog that is disqualified under section 14.1.2(a) shall automatically be disqualified from entering in any CKC event in any other discipline until such time as the dog is officially reinstated, if the dog is eligible for reinstatement.

Championship Points and Cancellations

Section 15.1.1 A dog awarded Winners at a conformation show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded Winners shall be as provided hereunder.

Section 15.1.2 The schedule to be employed in the determination of the number of points awarded Winners shall be as follows:

Dogs competing*	1	2	3-5	6-9	10-12	13 & more
Points allocated	0	1	2	3	4	5

**Includes the dog awarded Winners.*

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall NOT be included in the calculation for championship points.

Section 15.1.3 If a Dog awarded Winners was also awarded Best of Breed then at the show all dogs competing in the breed, including Specials Only, shall be included the total.

Section 15.1.4 If a Dog awarded Winners is also awarded Best of Opposite Sex to Best of Breed, then all dogs of the same sex including those competing for Specials Only shall be included in the total.

Section 15.1.5 If a Dog awarded Winners is also awarded Best of Winners, then all dogs defeated directly or indirectly in the breed shall be included in the total.

Section 15.1.6 If a dog is awarded Winners only, then all the dogs of the same sex in the class competition shall be included in the total.

Section 15.1.7 The number of championship points to be credited to a dog awarded Winners shall be determined by the highest award earned and calculated as per this section.

Clarification: Example of directly or indirectly defeating: If the Winners Bitch is awarded Best of Opposite Sex but not Best of Winners, the Best of Winners Male shall be deemed to have indirectly defeated the Specials Bitches, and is thus entitled to add them to the number of dogs and bitches defeated.

Section 15.1.8 In addition to championship points allocated at the breed level, a dog awarded Winners which also places in the regular Group competition shall be credited with the following additional points provided that the dog was defeated at the Group level.

Section 15.1.9 A dog may not be credited with more than 5 championship points in a single show:

Section 15.1.10 A breed or class shall not be allowed more than 2 sets of championship points per sex on any day in the same venue.

Section 15.1.11 A dog awarded Winners which also places Best in Show at an all-breed conformation show shall be credited with 5 championship points inclusive of any points earned at the breed and group level.

Section 15.1.12 In order for a dog to be recognized as a Champion and its owner provided with a Championship certificate, the dog must:

- (a) earn at least 10 championship points under at least 3 judges; and,
- (b) be individually registered in the records of the CKC or have an Event Registration Number.
- (c) have earned at least one 2 point win either at the breed or group level.

15.2 Grand Champion (GCh)

15.2.1 The title of Grand Champion may only be earned after the completion of the CKC conformation championship.

15.2.2 Points for this title are only accumulated after the completion of the conformation championship and do not include the points earned in attaining the conformation championship.

15.2.3 To be awarded a Grand Champion title, a dog must attain a minimum of 20 points, which must include a minimum of two (2) wins of at least two (2) points each. Points may be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward.

(a) Grand Champion Point System

Points towards the Grand Champion title, are attained at breed level and are awarded to Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch. Points are calculated based on the number of animals competing at the breed level for the Best of Breed winner and the number of similar-sex dogs competing for the other three (Best of Opposite, Select Dog, Select Bitch). The following schedule shall be employed in the determination of points awarded at breed level for all levels of GCh:

(b) the following schedule shall be employed in determination of points awarded at Group Level for all GCh:

c) In order to obtain a Grand Champion title, a dog must obtain at least two (2) points after 12 months of age.

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points.

(d) Only the highest points earned at a single show are carried forward.

15.2.4 Grand Champion Bronze (GChB) The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.

Win	Points
Best in Show	5
Best of Breed at a National Specialty Show	5
Reserve Best in Show	4
Best of Breed at a Specialty Show (other than National)	3

(a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship.

(b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

(c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

15.2.5 Grand Champion Silver (GChS) The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Bronze is attained, and do not include the points earned in attaining the Grand Championship Bronze

(b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

15.2.6 Grand Champion Gold: (GChG) The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Silver is attained, and do not include the points earned in attaining the Grand Championship Silver.

(b) To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

15.3 Grand Champion Excellent (GChEx)

15.3.1 The title of Grand Champion Excellent may be granted only after the completion of the CKC Grand Championship Silver Title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website.

15.3.2 To earn the title a dog must have earned the following during their career as a Special:

(a) one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed)

(b) three (3) Group 1st, or three (3) breed specialty best of breed wins.

(c) a CKC performance title from any CKC Event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.

15.3.3 Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance title may be attained at any time in the dog's career.

NOTE: 1. Exhibitors are required to complete the Grand Champion Excellent Record Sheet form located on the CKC website and forward to CKC upon completion of requirements above.

2. Grandfathering of the previous version of the Grand Champion Excellent title will be honoured up until July 1, 2022.

Please Note – the drive-in doors (overhead garage doors, or oversized sliding barn doors) can not be opened at any time through out the show weekend. There will be 1 Designated garage door that can be opened at the end of each day (after Best in Show), and at lunch on Sunday. Anyone who is found to be removing tape or signs from the doors, or propping man doors open, will be removed from the show, with no refunds given.
