DRIVING DIRECTIONS

Yellowhead Hwy East just past Range Road 224. Turn into the Esso/Tempo gas station turnoff. Go through their parking lot to the road behind. Turn west (toward Edmonton), and immediately south onto Range Road 223. Approximately ½ mile (BEFORE RAILROAD TRACKS) on right side. Field is behind the house.

AGILITY CLASS DESCRIPTIONS

Standard Classes

These classes are open to all dogs, 18 months of age or older, as described within the current AAC rules.

Special Classes

These classes are open to all dogs but are intended for dogs that are of a size or stature that limits their jumping ability.

Veterans Classes

These classes are for dogs seven years of age or older that are currently competing in any Standard Agility Class and for dogs five years of age or older who have competed in the Specials Agility Class for a minimum of 1 calendar year.

Junior Classes

These classes are for handlers up to and including 17 years of age on the date of the trial.

PRIZES

Ribbons for 1st, 2nd, 3rd and 4th place and qualifying ribbons in each height category. A "leave the ribbon" draw will be available as an alternative to taking ribbons. There are also special Rosettes for those achieving significant milestones in their AAC journey.

TRIAL EQUIPMENT

Equipment available for the trial will include A-Frame, Dogwalk, Teeter, 24" Weave Poles, Broad Jump, Ascending Spread Jump, Double Bar Jump, Tire (Self Healing), Winged Single Jumps, Flexible Tunnels, Table (Contacts are rubberized).

FOOD SERVICES

There will be a NO FOOD on site. But there are also a number of culinary options in Sherwood Park, a few short minutes away.

We will do a food run midway through the day.

NOTICE TO EXHIBITORS

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of the rules and regulations of the AAC, including but not limited to the following:

This event is held under AAC Rules and Regulations and is open to all dogs being at least 18 months of age, pure breed or mixed breed, except bitches in season, aggressive dogs, or dogs suffering from any deformity or illness which may affect the dog's physical or mental performance.

Obstacles shall be chosen from those described in the current edition of the rules and regulations of the AAC and shall conform to AAC specification.

No leads, collars, food, toys or any other aids or devices shall be permitted on the course at any time.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and / or children. Any exhibitor whose dogs and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may be asked to leave the show grounds and NO REFUND of fees shall be given.

All dogs must be penned, crated or on leash when not in the ring. All dogs must be under control when exiting the ring. Any dog engaging in aggressive or out of control behavior upon exit of the ring may be disqualified and / or required to leave the show grounds and NO REFUND of fees shall be given.

Exhibitors MUST keep crate and exercise areas clean. Please clean up after yourselves and your dogs. Anyone who does not clean up after themselves or their dogs may be required to leave the show grounds and no refund will be given.

There will be no refunds after the closing date, except for bitches in season or injured dogs, and only providing the trial secretary is informed prior to the trial date and a certificate from a veterinarian is provided.

AGILITY ASSOCIATION OF CANADA ("AAC") PARTICIPATION WAIVER AND RELEASE

Entry not valid unless Agreement is signed, dated and submitted with the correct fee.

In consideration of the acceptance of this entry by AAC and Dynamo Dogsports and the opportunity to have the Dog participate, compete in and/or be judged at this Trial, I, the undersigned, agree as follows:

1. I certify that I am the actual owner of the Dog, or that I am the duly authorized agent of the actual owner of the Dog and that the Dog is not a hazard to persons, property or other dogs.

2. I agree that AAC or the Organizing Club for the Event may refuse my entry for any reason that it deems to be sufficient.

3. I understand and acknowledge that participation in the Event carries certain risks, including, but not limited to injuries (including serious injuries and death) to myself, the Dog, another dog under my control or persons attending as my guests, damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to sue AAC, Dynamo Dogsports or any of the directors, executives, committees, representatives, employees, volunteers or agents of either AAC or Dynamo Dogsports ("the Personnel"), for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind.

4. I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event. I agree to indemnify and save harmless AAC, the Organizing Club and the Personnel from and against any and all claims that may be made against them or costs, fees, expenses or liability (including, without limitation, lawyers' fees on a solicitor and own client basis) incurred by AAC, Dynamo Dogsports or the Personnel that may arise due to:

- (a) any act or omission of myself, my Related Parties or any party for whom I am liable at law; or
- (b) aggressive behaviour by the Dog or any other dog under my control.

5. I have read, and do understand the rules of competition and the additional rules (if any) appearing in the trial schedule for the Trial, as well as the policies of AAC pertaining to discipline (collectively, the "Rules"). I agree to abide by the Rules and to conduct myself and the Dog in accordance with the Rules. I understand that myself and/or the Dog may be subject to disciplinary procedures or sanctions for breach of the Rules and agree to respect and be bound by any disciplinary decision made by AAC.

6. I understand that AAC and/or the Organizing Club may, in the course of administering the Event or conducting its activities generally, collect, use or disclose my personal information and that any personal information collected, used or disclosed by AAC and/or the Organizing Club will be treated in accordance with AAC policy and applicable privacy and personal information laws. I hereby consent to the collection, use and disclosure by AAC and/or the Organizing Club of my personal information.
