#### **ENTRY FEES**

Tracking dog (TD) \$85. Tracking Dog Excellent (TDX) \$95.

**ENTRY & ALTERNATES:** All entries to be sent to the Test Secretary. Entries will be accepted by **MAIL ONLY**, with **only ONE entry per envelope**. **Please indicate TD or TDX on the outside of the envelope**. All entries will be accepted until the official closing date.

A **WORKER DRAW** will be conducted on each class in accordance with 6.6.2 of the regulations ,if sufficient entries are received. The draw for these places in the test will be held immediately prior to the main draw and any entries of workers that were unsuccessful in obtaining a place in the worker draw will be added to the general pool of entrants for the **MAIN ENTRY DRAW** outlined in 6.6.1., all remaining entries will be assigned a position on an "Alternate List" in the order they are drawn. Entrants will be notified by email or telephone that their entry has been received and accepted for the test or their position as an alternate. If acknowledgement is not received by the exhibitor within a reasonable time, please contact the test secretary. Placement in the test or onto an alternate list will be determined by a random draw. Only one entry per event for each dog entered will be accepted by the tracking test secretary.

**THE RANDOM DRAW IS PUBLIC AND WILL TAKE PLACE SUNDAY AT 1:00 PM SEPTEMBER 29, 2019 at the A&W on Smith Drive in Armstrong, BC**

**MEETING PLACE & DRAW for tracking order:** All participants will rendezvous at the **A&W on Smith Drive in Armstrong, BC** for the drawing of tracks. Coming from the north or south, turn off Highway 97B at the traffic light. Go 1 block and turn left at the stop sign. The A&W is plainly visible from the highway. **Draw will take place at 8:00 am Sunday October 20, 2019**. Any primary entrant who is not present at this time will forfeit their position to the first alternate present. The competitors will then convoy to the location of the test and the first track will be run as soon as it is sufficiently aged.

**PAYMENT:** Please make all cheques or money orders to: North Okanagan Tracking Club. A listing fee as established by the Canadian Kennel Club must accompany the entry of a dog for which a Canadian Kennel Club individual registration number, ERN or PEN number is not shown on the entry form. (Rule 4.1) All fees are to be paid in Canadian funds. American entrants may pay fees by money order in Canadian funds or by personal cheque in U.S. funds for the full amount of the fees.

**REFUNDS:** When an entered dog is withdrawn after the closing date, refunds will only be permitted when the vacancy is accepted by an 'Alternate'. Entry fees will be returned within 10 days of the test to Alternates who did not participate in the test. Out of consideration for other entrants, if you are unable to participate in the test, please notify the test secretary as soon as possible.

**BITCHES IN SEASON:** Bitches in season may compete, but will run last (Rule 6.7.1) Please inform the secretary before the draw if this affects you.

**LIABILITY AND SAFETY:** In attending this test and signing the entry form, all competitors and invited guests acknowledge that they do so at their own risk and that of their dog. They also agree not to hold liable the CKC, North Okanagan Tracking club or its test officials, the judge or the land owners for any loss, damage or injury, however arising, to themselves, their dog or their chattels. All reasonable care will be taken for the safety of dogs, handlers and spectators. Use caution alongside roads and be aware of farm equipment.

**AWARDS AND NO-HOST LUNCHEON:** Location to be announced on the day of trial.

**(Rule 14.7) INDIGNITIES:** "It shall be the duty of the test-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test

Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.”

**NON-MEMBER PARTICIPATION FEE - Effective Jan. 1, 2011**

A participation fee will be charged to a resident of Canada who is a non-member of CKC. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. This applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

**ACCOMMODATIONS**
