

# Welcome to the NYOC Trials. We are so glad you are joining us.

In order to keep everyone as safe as possible and follow the directives of local and provincial health authorities, the following COVID strategies will be in place:

- Based on the announcement made by the Ontario government on September 3, our event is required to follow provincial regulations requiring participants present proof of 2 COVID vaccinations completed on or before September 11th. Please ensure you have access to the necessary documents when you arrive. You can show us either a paper copy of your vaccine receipt or the receipt on your phone. Without this documentation, we cannot allow you to compete or enter the building for any reason.
- Waivers will also be signed when you arrive
- Face masks must be worn in the building including in the ring.
- There will be no indoor crating. Please crate from your vehicle
- To facilitate social distancing, we ask that you do not bring friends, children, spouses or others unless you need them to provide mobility assistance at the trial.
- All briefings will be done outside the building.
- Only the current exhibitor and "on deck" dog may be in the facility at any given time.
- Walk-through group size will be limited to 5 exhibitors per walk-through and competitors will be required to wear a mask.
- Exhibitors will remove and retrieve their own leashes. A chair or other object will be placed in the ring for the leash.
- The restroom will be the only facility available to competitors.
- Paper towels, soap, and hand sanitizer will be available throughout the facility.
- We encourage you to leave the facility promptly when you are done for the day.
- No lunch will be served. However, there are numerous food outlets not far away.
- CKC COVID19 Obedience and Rally Rules Guidelines will be followed

- No dogs are permitted on the grassy area next to the blue building (near the trial site entrance).
