2. Exhibitors will be asked to SHOW N GO to maintain the COVID limits.
3. There will be NO spectators allowed on the grounds.
4. Access to show grounds will be allowed on Saturday, October 2, 2021 at 8:00 am. Please DO NOT line up prior to that. Please follow signs.
5. Masks are MANDATORY in the trial area, the bathrooms and when you can't socially distance outside of your bubble.
6. Hand sanitizer stations will be available in the trial area and bathrooms. Please bring your own to use when you are at your vehicle.
7. Social distancing MUST be followed while on the show site and in the trial area. Avoid congregating.
8. Bring your own food and drinks.
9. Obey ENTER and EXIT gates in the trial area.
10. Ribbons and rosettes will be set out on a table. If you DO NOT want your ribbon or rosette please leave it on the table and DO NOT touch it.
11. Participants are expected to follow these event guidelines.
12. Failure to comply may result in excusal from the remainder of this event.
13. Schedules are based on 2 minutes per dog for Instinct, 9 minutes per dog for Novice and Open, and 11 minutes per dog for Excellent.
14. Please allow for absentees and variances in the rate of judging.

BRING YOUR OWN MASKS

REMINDER: That anyone discussing hides before the end of the trial will be excused and asked to leave as per CKC rules. Please show consideration for other competitors.

TEST SITE: No indoor kenneling. These tests will be run rain or shine. All dogs must be under control, on a leash except during the trial where off leash searches are permitted. Flexi leads will not be allowed on the test site. Remember that this is a public park used by families. Clean up after yourself and your dog.

WASHROOM facilities only available during class changes.

NO CONCESSION ON SITE: Convenience store close by or bring your own food, treats and water for you and your dog(s)
